When performing measurements at a distance other than that specified, the results shall be extrapolated to the specified distance using an extrapolation factor of 20 dB/decade (inverse of linear distance for field-strength measurements, inverse of linear distance-squared for power-density measurements).

Note 2: Test distance for frequencies at below 30 MHz, measurements may be performed at a distance closer than the EUT limit distance; however, an attempt should be made to avoid making measurements in the near field. When performing measurements at a distance other than that specified, the results shall be extrapolated to the specified distance using an extrapolation factor of 20 dB/decade (inverse of linear distance for field-strength measurements, inverse of linear distance-squared for power-density measurements).

#### 2.1.2 Test Procedures

#### **Test Method**

- Measurements may be performed at a distance other than the limit distance provided they are not performed in the near field and the emissions to be measured can be detected by the measurement equipment. Measurements shall not be performed at a distance greater than 30 m for frequencies above 30 MHz, unless it can be further demonstrated that measurements at a distance of 30 m or less are impractical. When performing measurements at a distance other than that specified, the results shall be extrapolated to the specified distance using an extrapolation factor of 20 dB/decade (inverse of linear distance for field-strength measurements, inverse of linear distance-squared for power-density measurements).
- The average emission levels shall be measured in [duty cycle ≥ 98 or duty factor].
- For the transmitter unwanted emissions shall be measured using following options below:
  - Refer as KDB 789033, clause G)2) for unwanted emissions into non-restricted bands.
  - Refer as KDB 789033, clause G)1) for unwanted emissions into restricted bands.
    - Refer as KDB 789033, G)6) Method VB (ANSI C63.10, clause 4.1.4.2.3), Reduced VBW.
    - Refer as KDB 789033, clause G)5) (ANSI C63.10, clause 4.1.4.2.2), measurement procedure peak limit.
- For radiated measurement.
  - Refer as ANSI C63.10, clause 6.4 for radiated emissions below 30 MHz and test distance is 3m.
  - Refer as ANSI C63.10, clause 6.5 for radiated emissions 30 MHz to 1 GHz and test distance is 3m.
  - Refer as ANSI C63.10, clause 6.6 for radiated emissions above 1GHz.
- The any unwanted emissions level shall not exceed the fundamental emission level.
- All amplitude of spurious emissions that are attenuated by more than 20 dB below the permissible value has no need to be reported.




