







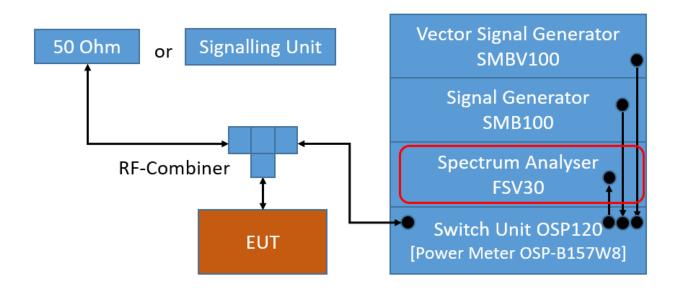












TS8997; Output Power










Radio Technology = Bluetooth LE 1 Mbps, Operating Frequency = low (S01_aa01)


