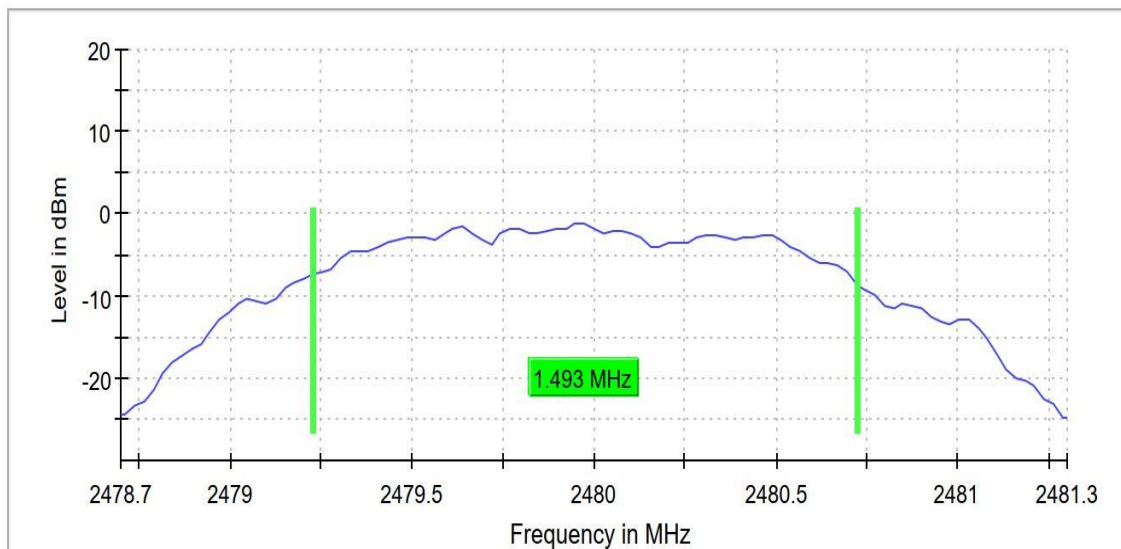

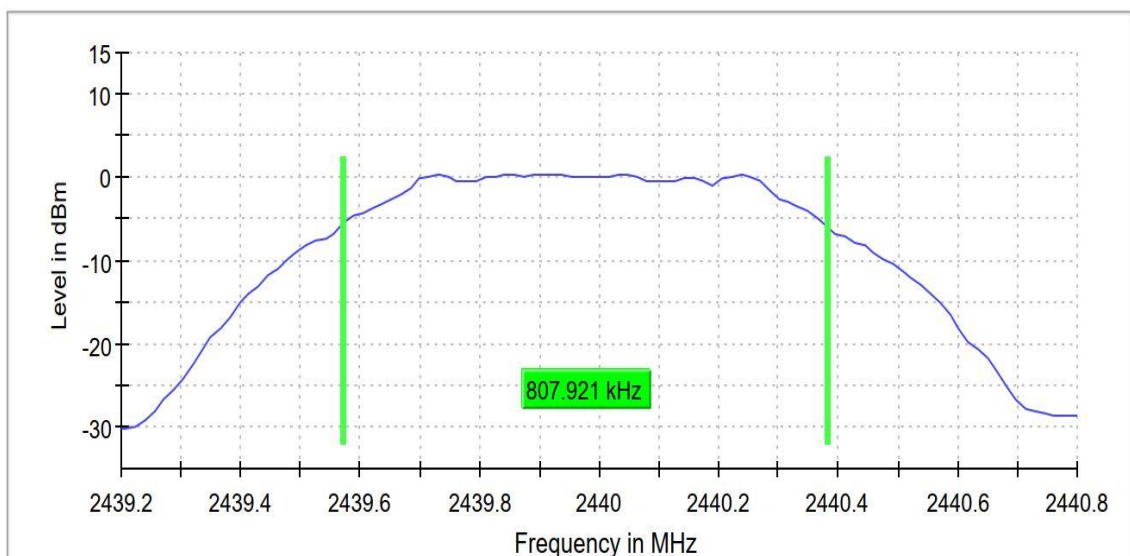

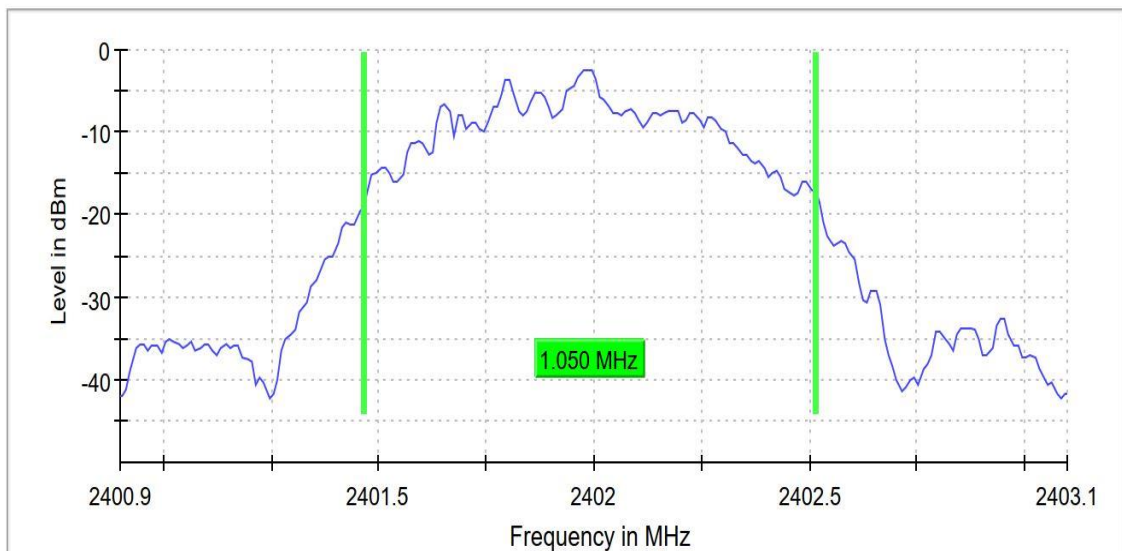

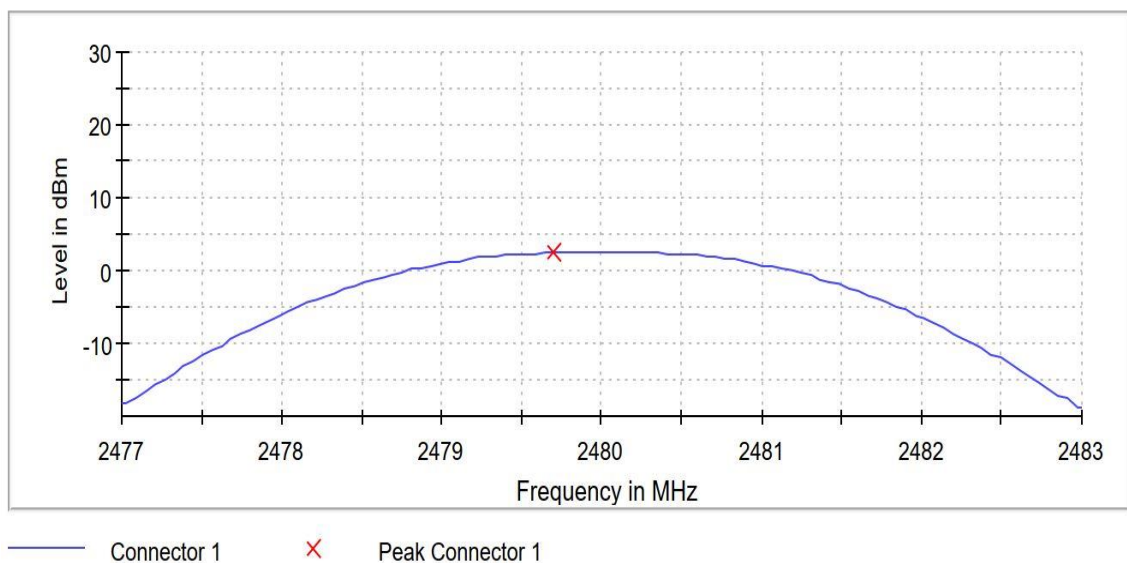

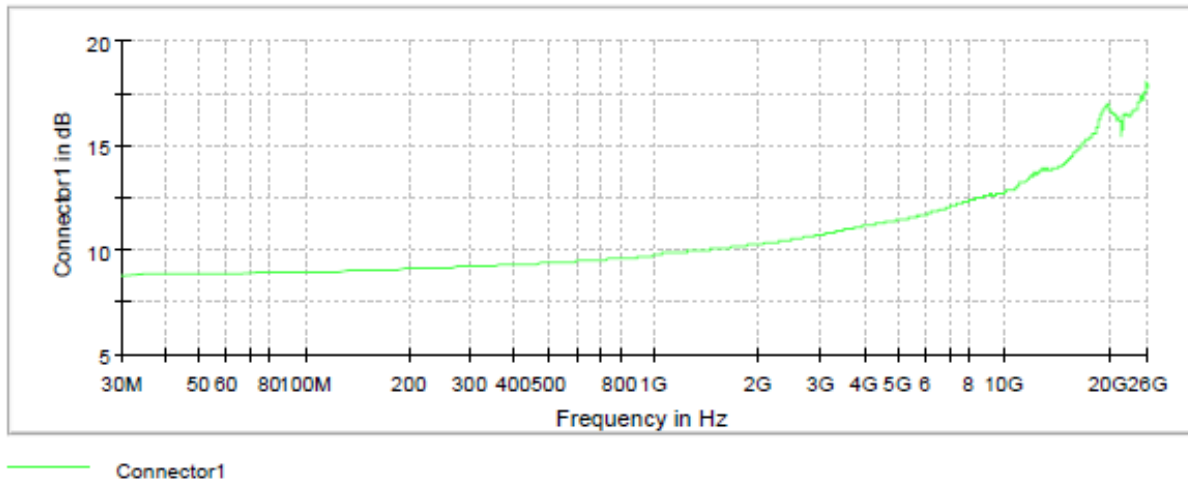

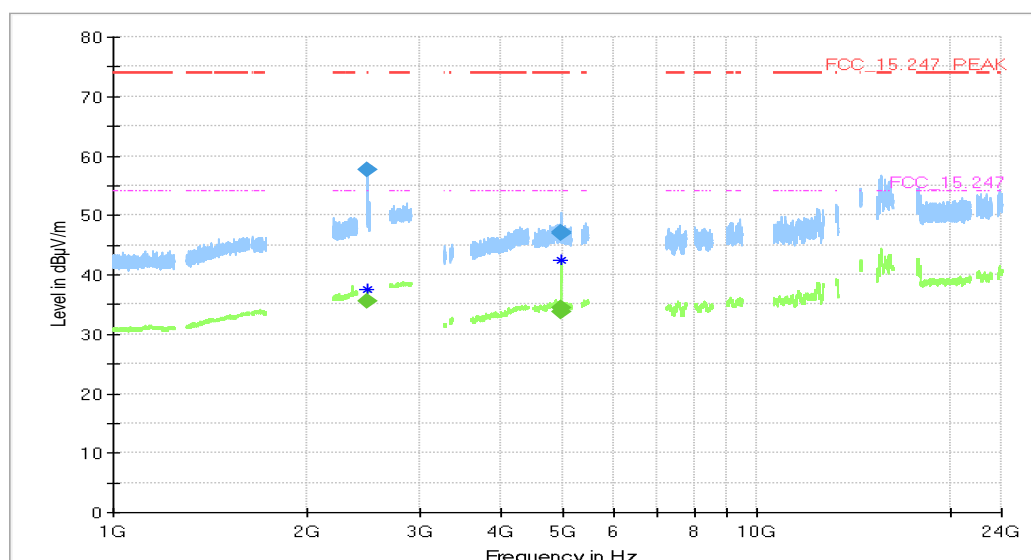

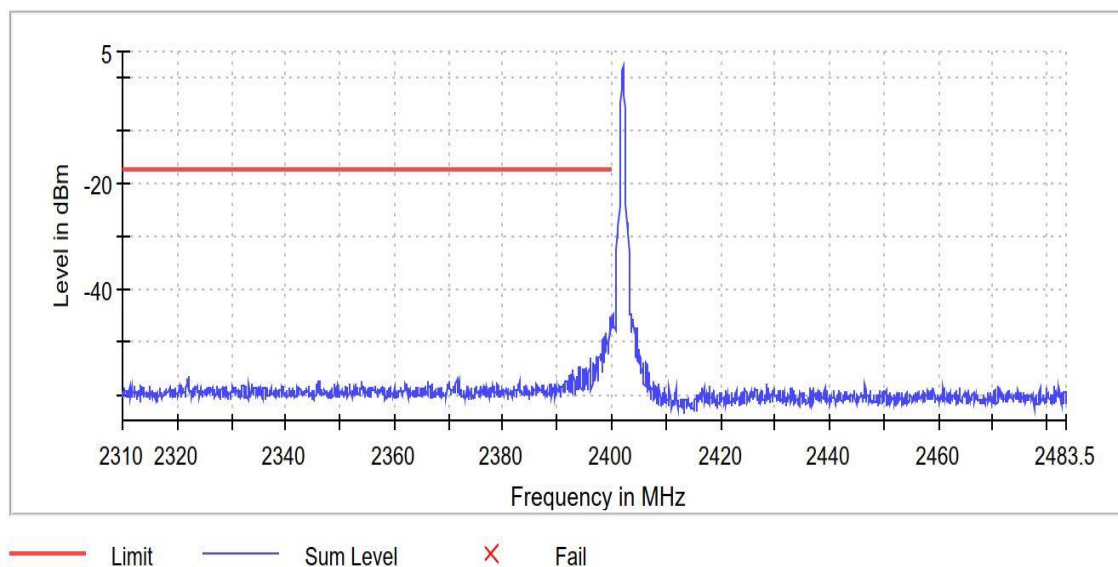

### 5.8.1 TEST DESCRIPTION

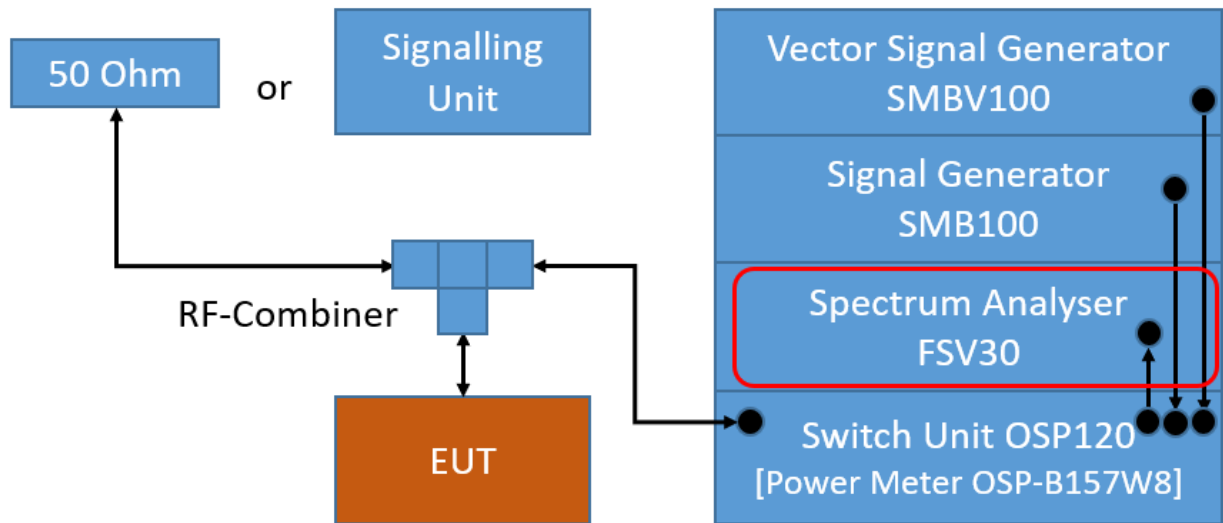

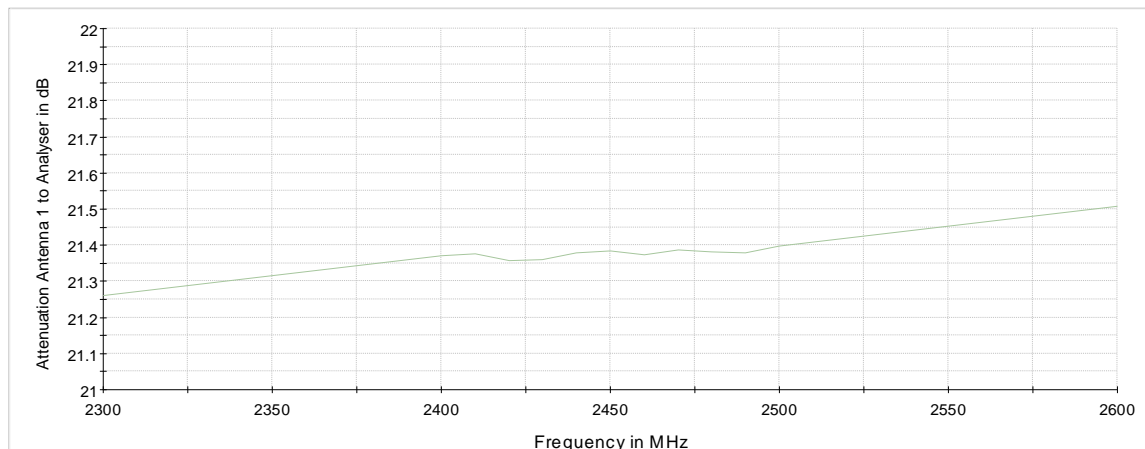

## 5.8.2 TEST REQUIREMENTS / LIMITS

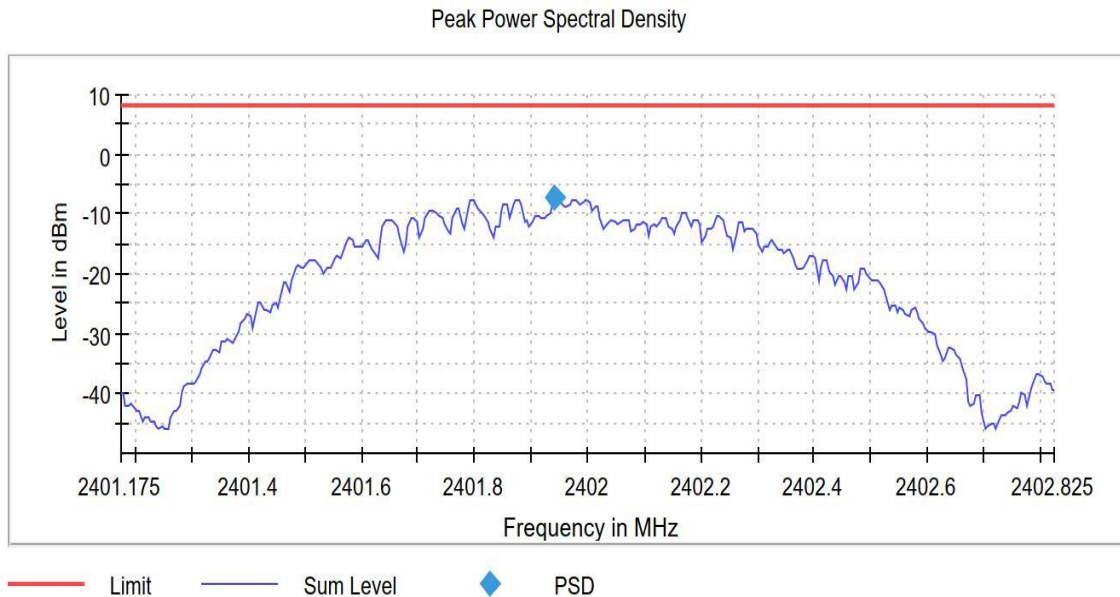

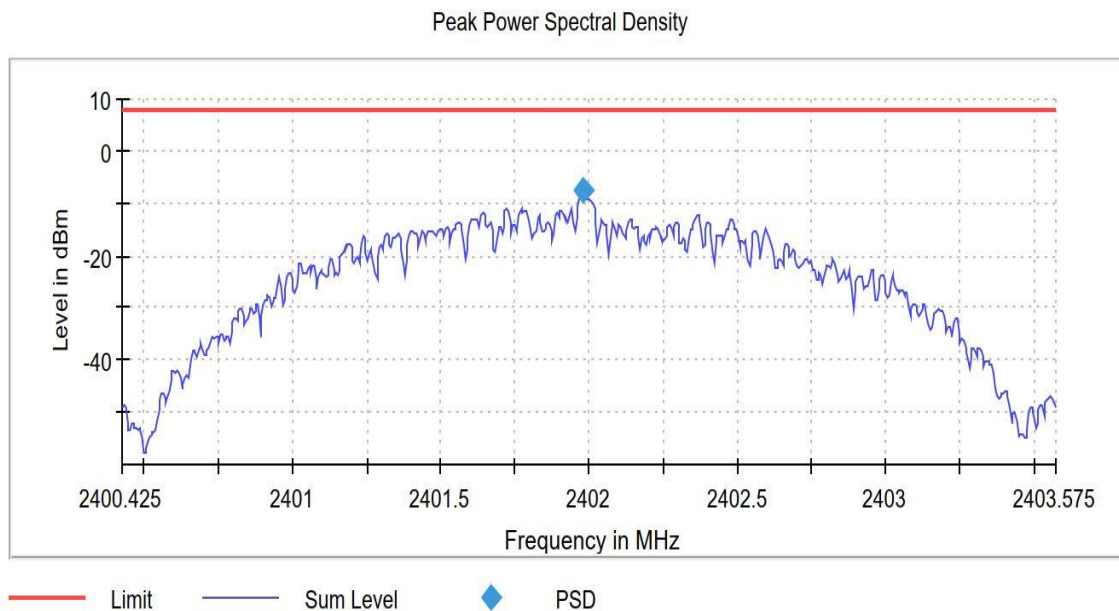

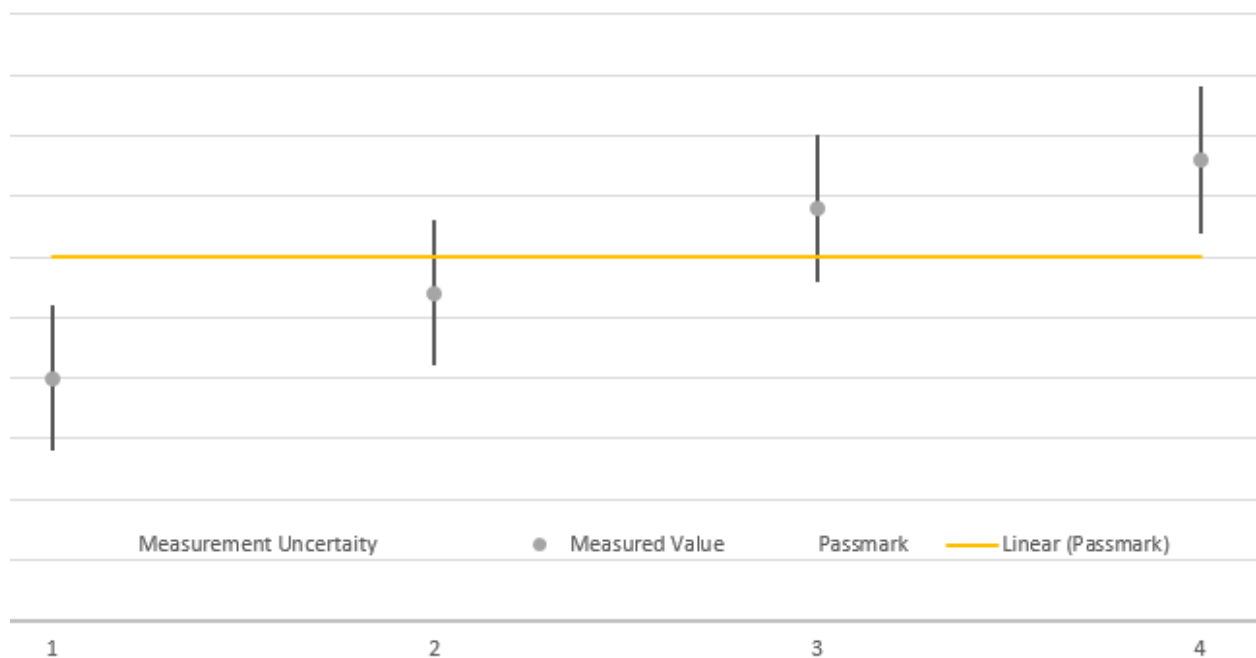
