Introduction

The Interpreter is a battery-operated module designed for automated water meter reading. The Interpreter is capable of recording water consumption data from residential and commercial water meters. It has a 2-way radio that is compatible with electric meters, routers, and mesh extenders for relaying sensor data to the utility. It also has a low power mode for short distance communications to the Tech Studio field tools.

Functional Description

The Interpreter is a wireless battery endpoint for the application of automatic water meter reading. The primary function of the module is to record magnetic field reversals that are converted to measurement of water consumption volume, and then deliver the data to the utility for processing. The block diagram below demonstrates this operation.




Figure 1. Operation Block Diagram

The module is designed to record rotations of a multipole magnet on the internal shaft of a water meter. The count from the movement of the magnet is converted to passed volume that is displayed and passed serially to the radio.

The radio has two operating modes, frequency hopping and single channel. The frequency hopping mode is the normal operating mode for network communication. The single channel mode is a low power mode, and is primarily used for field diagnostic purposes.

When installed, the module automatically utilizes the FHSS mode to operate as part of a mesh network. The module will remain in this mode unless a service event is initiated from the field tool. In this case the radio changes to the single channel mode for the duration of the service session. The module returns to the FHSS mode when the service session is closed. The user does not have the ability to change modes other than by the use of the field tool.
