## 5 SAR Evaluation

## 5.1 RF Exposure Compliance Requirement

### 5.1.1 Standard Requirement

According to KDB447498D01 General RF Exposure Guidance v06

4.3.1. Standalone SAR test exclusion considerations

Unless specifically required by the published RF exposure KDB procedures, standalone 1-g head or body and 10-g extremity SAR evaluation for general population exposure conditions, by measurement or numerical simulation, is not required when the corresponding SAR Exclusion Threshold condition, listed below, is satisfied.

#### **5.1.2 Limits**

The 1-g and 10-g SAR test exclusion thresholds for 100 MHz to 6 GHz at test separation distances ≤ 50 mm are determined by:

[(max. power of channel, including tune-up tolerance, mW)/(min. test separation distance, mm)]  $\cdot$  [ $\sqrt{f(GHz)}$ ]  $\leq$  3.0 for 1-g SAR and  $\leq$  7.5 for 10-g extremity SAR, where

f(GHz) is the RF channel transmit frequency in GHz

Power and distance are rounded to the nearest mW and mm before calculation<sup>17</sup>

The result is rounded to one decimal place for comparison

The test exclusions are applicable only when the minimum test separation distance is ≤ 50 mm and for transmission frequencies between 100 MHz and 6 GHz. When the minimum test separation distance is < 5 mm, a distance of 5 mm is applied to determine SAR test exclusion

### 5.1.3 EUT RF Exposure

The Max Conducted Peak Output Power-4.23 dBm on the lowest channer. GHz -4.23 dBm logarithmic terms convert to numeric result is nearly 0.38 mW

According to the formula. calculate the test exclusion thresholds:

[(max. power of channel, including tune-up tolerance, mW)/

(min. test separation distance, mm)] · [√f(GHz)]

General RF Exposure =  $(0.38 \text{ mW} / 5 \text{ mm}) \text{ x } \sqrt{2.402 \text{ GHz}} = 0.12$  (1)
