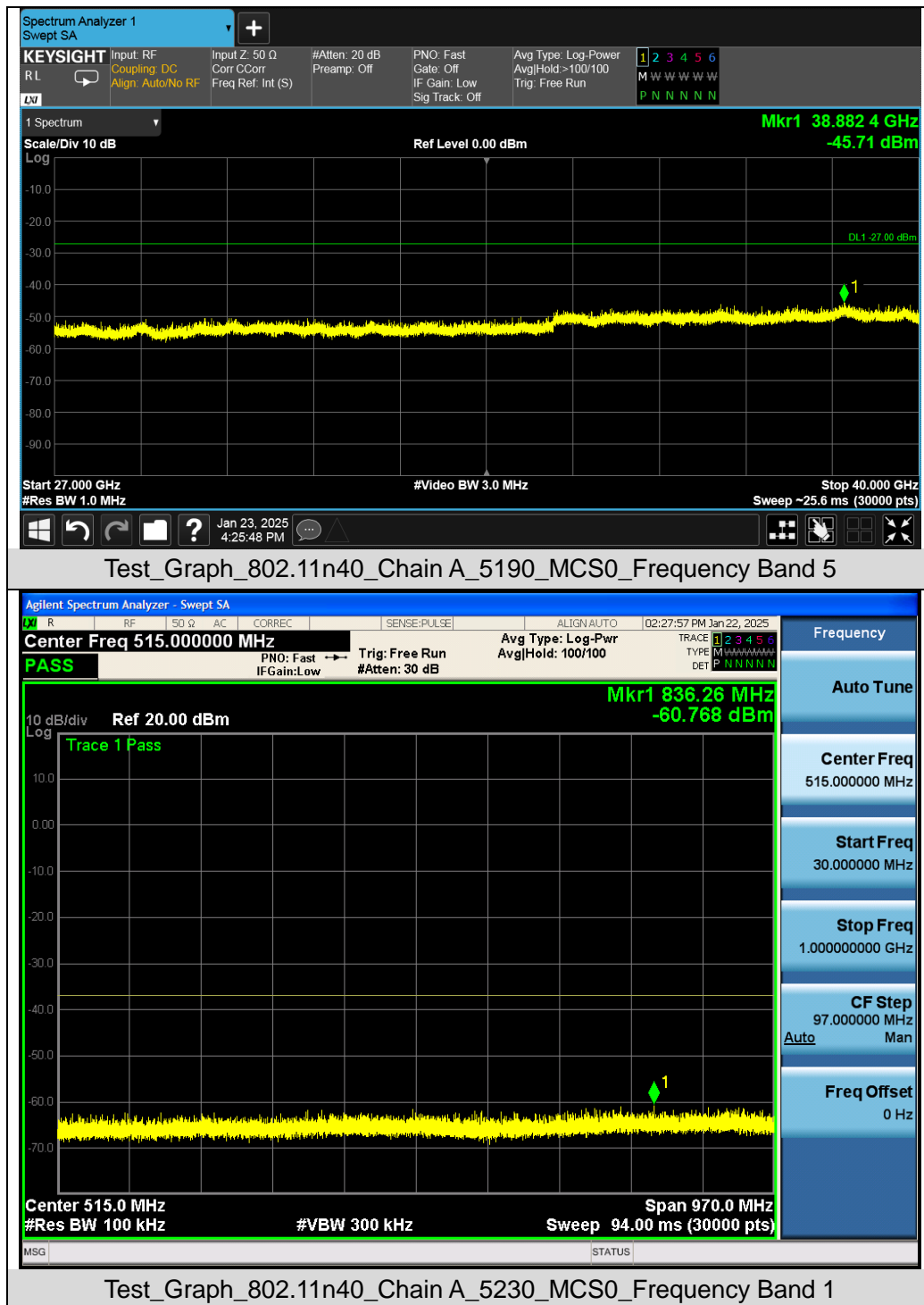


Test_Graph_802.11n40_Chain A_5190_MCS0_Frequency Band 3
