Objective

The tests were performed in order to determine the compliance of the EUT with FCC Part 15-Subpart D, section 15.207, 15.315, 15.317, 15.319 and 15.323 rules. The EMI measurements were performed according to the measurement procedure described in ANSI C63.17 – 2013 and RSS-213 Issue 3, 2GHz License-Exempt Personal Communications Service Devices (PCS) OF THE Canadian Department of Industry rules and RSS-GEN ISSUE 5, FEBRUARY 2021 AMENDMENT 2of the Innovation, Science and Economic Development Canada rules.

Test Methodology

All measurements contained in this report were conducted with ANSI C63.17 - 2013, American National Standard Methods of Measurement of the Electromagnetic and Operational Compatibility of Unlicensed Personal Communications Services (UPCS) Devices.

All emissions measurement was performed at Shenzhen Accurate Technology Co., Ltd. The radiated testing was performed at an antenna-to-EUT distance of 3 meters.





- below 20 MHz and the source-based, time-averaged maximum e.i.r.p. of the device is equal to or less than 1 W (adjusted for tune-up tolerance);
- at or above 20 MHz and below 48 MHz and the source-based, time-averaged maximum e.i.r.p. of the device is equal to or less than $4.49/f^{0.5}$ W (adjusted for tune-up tolerance), where f is in MHz;

Calculated Data:

The maximum tune-up conducted output power is 20.3 dBm, antenna gain is 0dBi. So the maximum e.i.r.p. of the device is 20.3dBm + 0dBi = 20.3dBm = 0.107W<2.30 W

The worst case is f = 1921.536 MHz: The limit is $1.31 \times 10^{-2} f^{0.6834}$ W=2.30W

Applicable Standard

According to FCC § 15.203, an intentional radiator shall be designed to ensure that no antenna other than that furnished by the responsible party shall be used with the device. The use of a permanently attached antenna or of an antenna that uses a unique coupling to the intentional radiator shall be considered sufficient to comply with the provisions of this Section. The manufacturer may design the unit so that a broken antenna can be replaced by the user, but the use of a standard antenna jack or electrical connector is prohibited.



The setup of EUT is according with per ANSI C63.10-2013 measurement procedure. The specification used was with the FCC 15.315, FCC 15.207 and RSS-Gen limits.

The external I/O cables were draped along the test table and formed a bundle 30 to 40 cm long in the middle.

The spacing between the peripherals was 10 cm.

EMI Test Receiver Setup

The EMI test receiver was set to investigate the spectrum from 150 kHz to 30 MHz.

During the conducted emission test, the EMI test receiver was set with the following configurations:

Test Procedure

During the conducted emission test, adapter was connected to the outlet of the LISN.

Maximizing procedure was performed on the six (6) highest emissions of the EUT.

All final data was recorded in the Quasi-peak and average detection mode.

Factor & Margin Calculation

The Factor is calculated by adding the Outlet Cable Loss, LISN Insertion Loss and Cable Loss. The basic equation is as follows:

Factor = Outlet Cable Loss + LISN Insertion Loss

The "Over Limit" column of the following data tables indicates the degree of compliance with the applicable limit. For example, a over limit of -7 dB means the emission is 7 dB below the limit. The equation for margin calculation is as follows:



6) Least Interfered Channel (LIC)

If access to spectrum is not available as determined by the above, and a minimum of 20 duplex system access channels are defined for the system, the time and spectrum windows with the lowest power level may be accessed.

A device utilizing the provisions of this paragraph (5) must have monitored all access channels defined for its system within the last 10 seconds and must verify, within the 20 milliseconds (40 milliseconds for devices designed to use a 20 millisecond frame period) immediately preceding actual channel access, that the detected power of the selected time and spectrum windows is no higher than the previously detected value.

The power measurement resolution bandwidth for this comparison must be accurate to within 6 dB. 12) Alternative monitoring interval

An initiating device that is prevented from monitoring during its intended transmit window due to monitoring system blocking from the transmissions of a co-located (within one meter) transmitter of the same system, may monitor the portions of the time and spectrum windows in which they intend to receive over a period of at least 10 milliseconds. 13) Fair Access

The provisions of FCC §15.323 (c) & paragraphs 5.2 (10) or (11) shall not be used to extend the range of spectrum occupied over space or time for the purpose of denying fair access to spectrum to other devices.

Each device that implements time division for the purposes of maintaining a duplex connection on a given frequency carrier shall maintain a frame repetition rate with a frequency stability of at least 50 parts per million (ppm). Each device which further divides access in time in order to support multiple communication links on a given frequency carrier shall maintain a frame repetition rate with a frequency stability of at least 10 ppm. The jitter (time-related, abrupt, spurious variations in the duration of the frame interval) introduced at the two ends of such a communication link shall not exceed 25 microseconds for any two consecutive transmissions. Transmissions shall be continuous in every time and spectrum window during the frame period defined for the device.
