#### 3.1 Radio Frequency Exposure Compliance

The maximum average power of the transmitter is -7.62 dBm (87.61dBuV/m)  $\approx$  0.17 mW < 1 mW.

**Summary:** Hence the EUT is excluded from SAR evaluation according to FCC KDB 447498 D04 Interim General RF Exposure Guidance v01.

**For IC:**

The maximum output power of the transmitter is -6.76 dBm (88.47dBuV/m)  $\approx$  0.21 mW, which is below the SAR exclusion threshold level 3 mW  $\approx$  4.77 dBm.

Note: The maximum output power refers to test report CN24QOH5 001.

**Summary:** The EUT is exempted from routine evaluation limits (SAR Evaluation) according to clause 6.3 of RSS-102 Issue 6.
