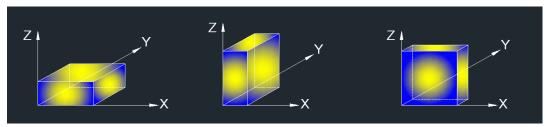

TEST PROCEDURE
