
# NB IoT Band5 15kHz BPSK 1 0 CH20401




#### NB IoT Band5 15kHz BPSK 1 0 CH20525




# NB IoT Band5 15kHz BPSK 1 0 CH20649






NB IoT Band5 15kHz QPSK 12 0 CH20525








#### NB IoT Band12 15kHz BPSK 1 0 CH23095




#### NB IoT Band12 15kHz BPSK 1 0 CH23179






#### NB IoT Band13 15kHz BPSK 1 0 CH23230






### NB IoT Band26 15kHz BPSK 1 0 CH26915




