#### 2.6 Transmit Power Control (TPC)

U-NII devices operating in the 5.25-5.35 GHz band and the 5.47-5.725 GHz band shall employ a TPC mechanism. The U-NII device is required to have the capability to operate at least 6 dB below the mean EIRP value of 30 dBm. A TPC mechanism is not required for systems with an E.I.R.P. of less than 500 mW.

Maximum EIRP of this device is 22.075 mW which less than 500mW, therefore it's not require TPC function.








#### Channel Move Time Plot






