It includes Bluetooth EDR and LE radio which complies with Bluetooth v2.1+EDR, v3.0, v4.0+BLEand V4.2.The Module is a highly integrated MAC/BBP and 2.4/5GHz PA/LNA single chip which supports a 433.3Mbps PHY rate. The Module is designed to support standard-based features in the areas of security, quality of service, and international regulations, giving end users the greatestperformance anytime and in any circumstance. This documentation describes the engineering requirements specification.
