- (5) Measure the frequency difference of two frequencies that were attenuated 20 dB from the reference level. Record the frequency difference as the emission bandwidth.





- b. The EUT was placed on the top of a rotating table 0.1 meters (above 1GHz is 1.5 m) above the ground at a 3 meter anechoic chamber test site. The table was rotated 360 degrees to determine the position of the highest radiation.

- e. If the Peak Mode measured value compliance with and lower than Quasi Peak Mode Limit, the EUT shall be deemed to meet QP Limits and then no additional QP Mode measurement performed.




(A) Radiated Emission Test-Up Frequency Below 30MHz
