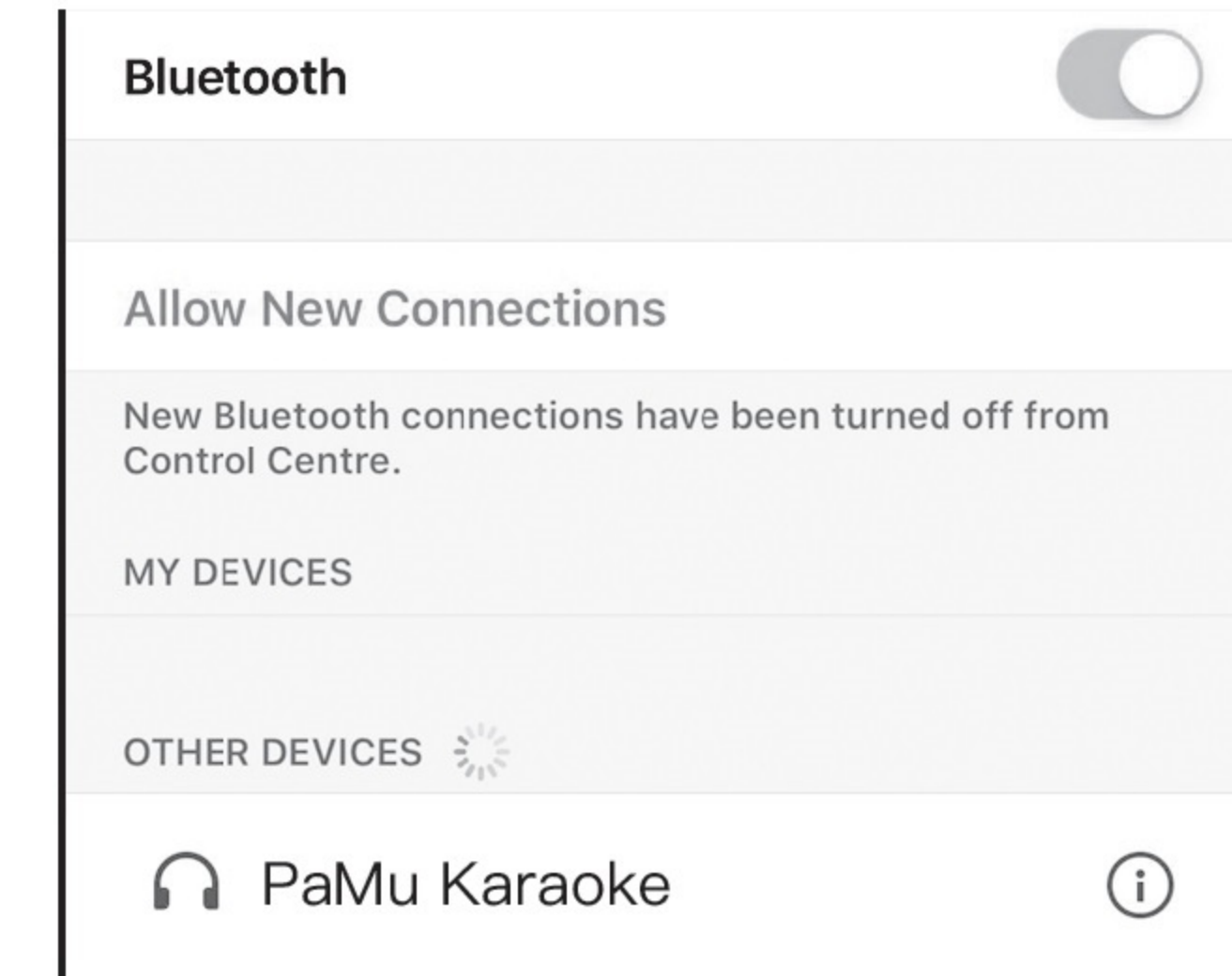

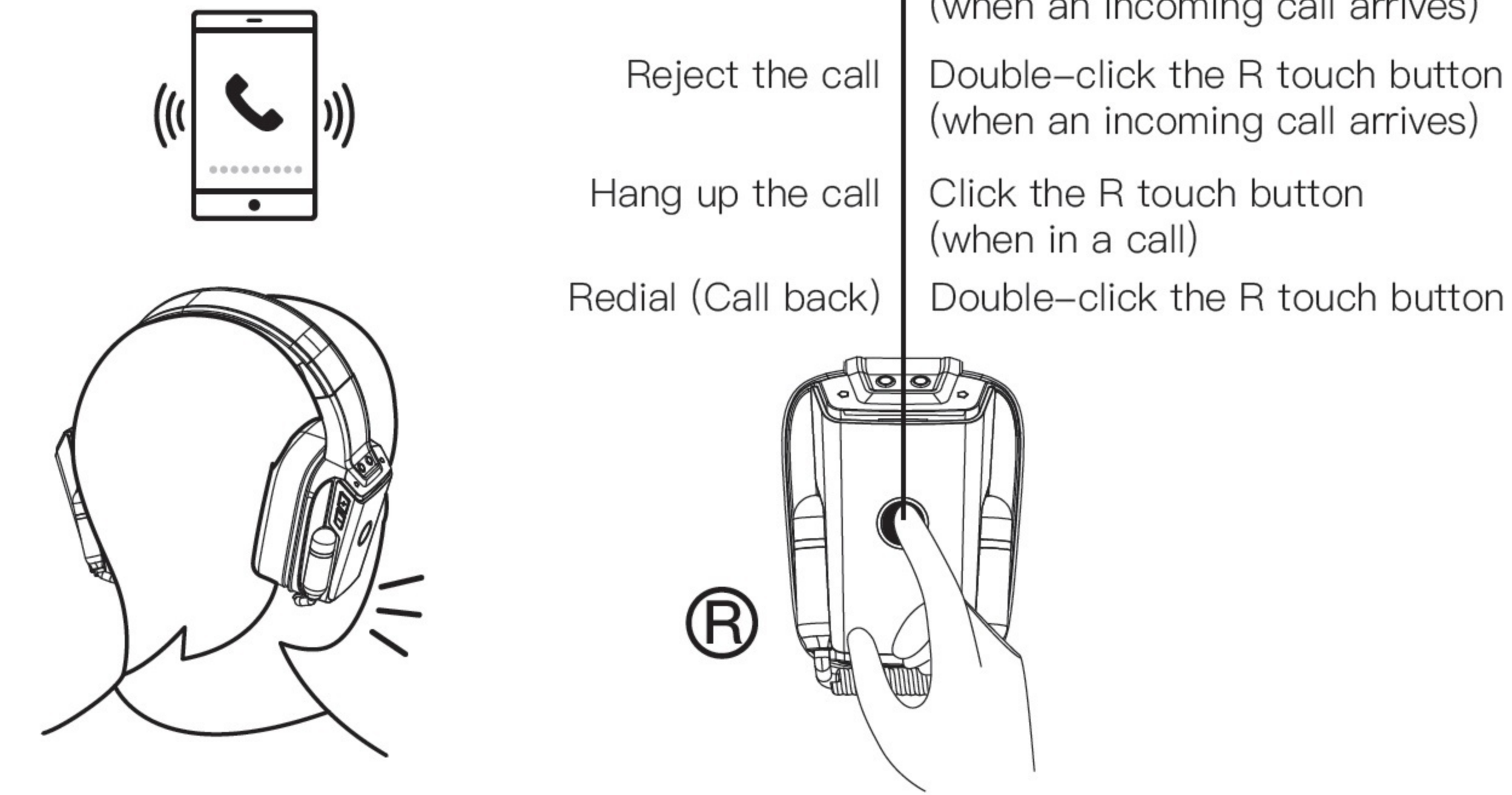

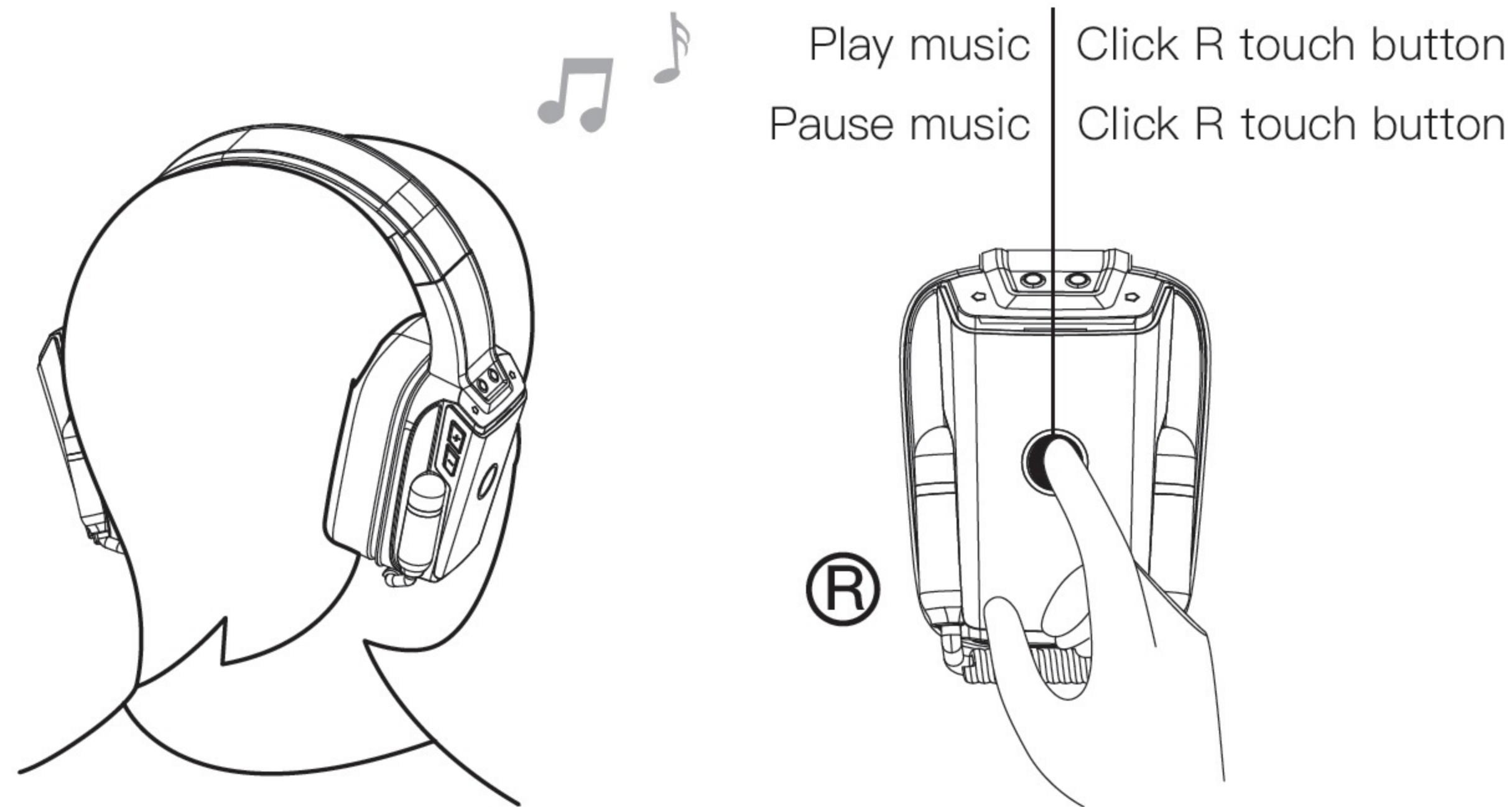


Turn on your phone's Bluetooth, search for "PaMu Karaoke" in the available devices list, and click on it to complete the pairing .

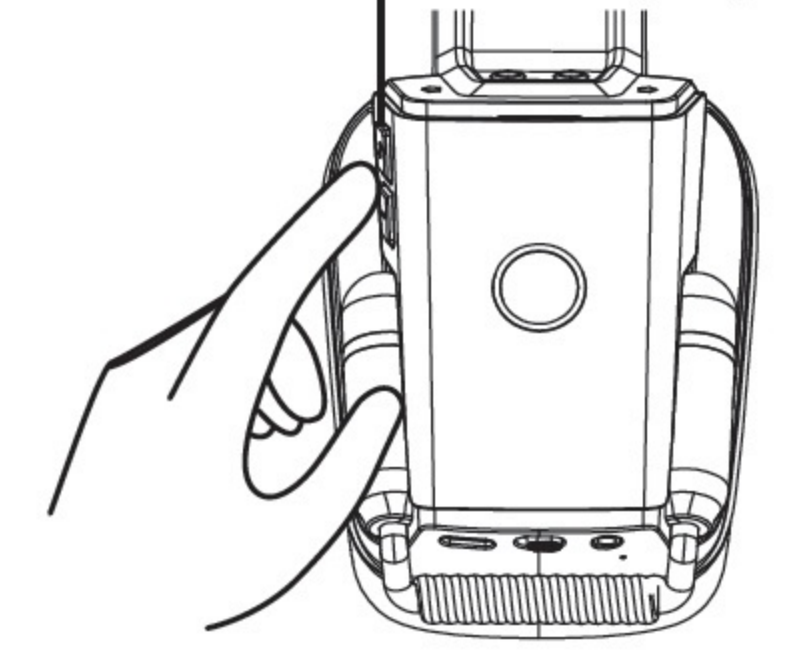


Music function.

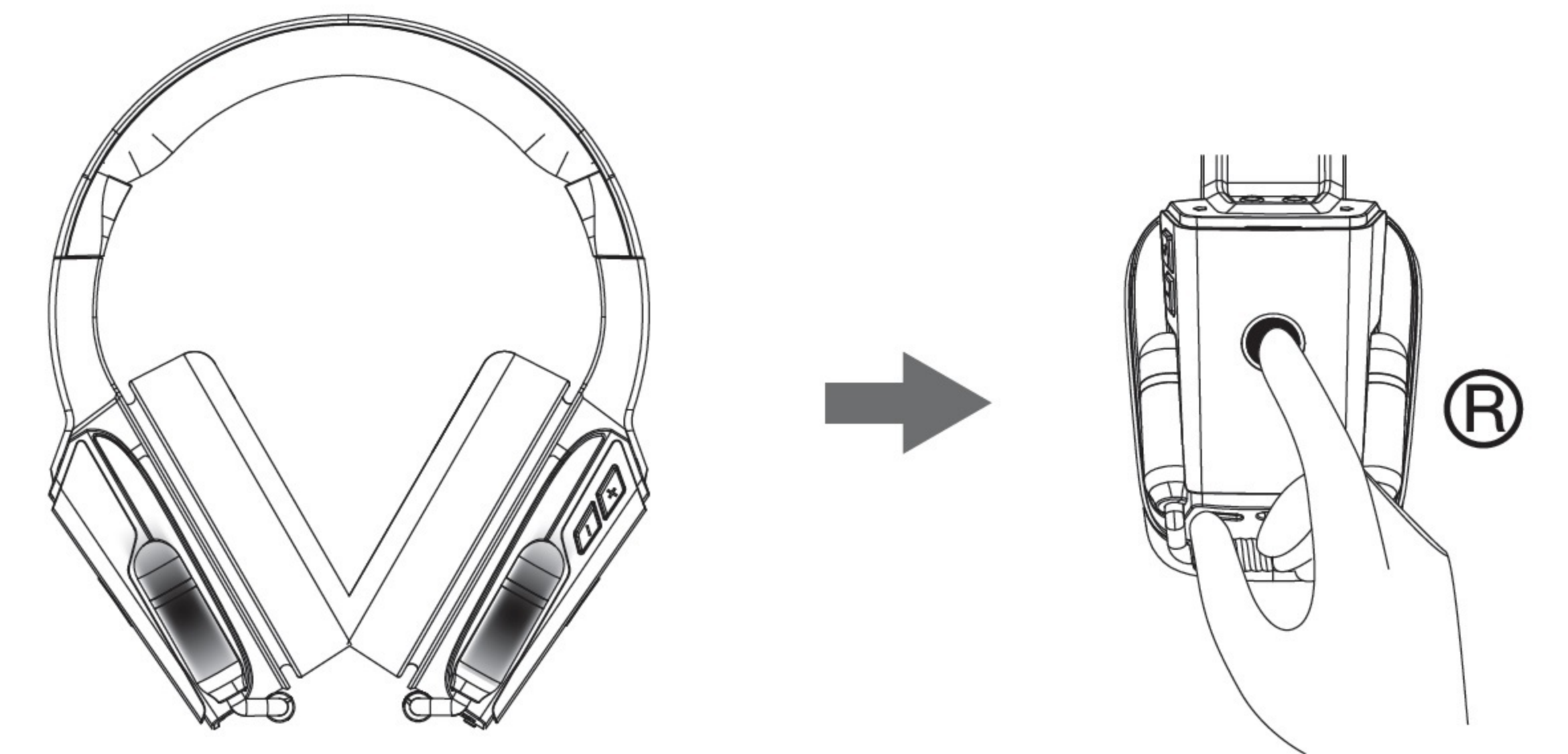


Volume and Previous/Next track functions

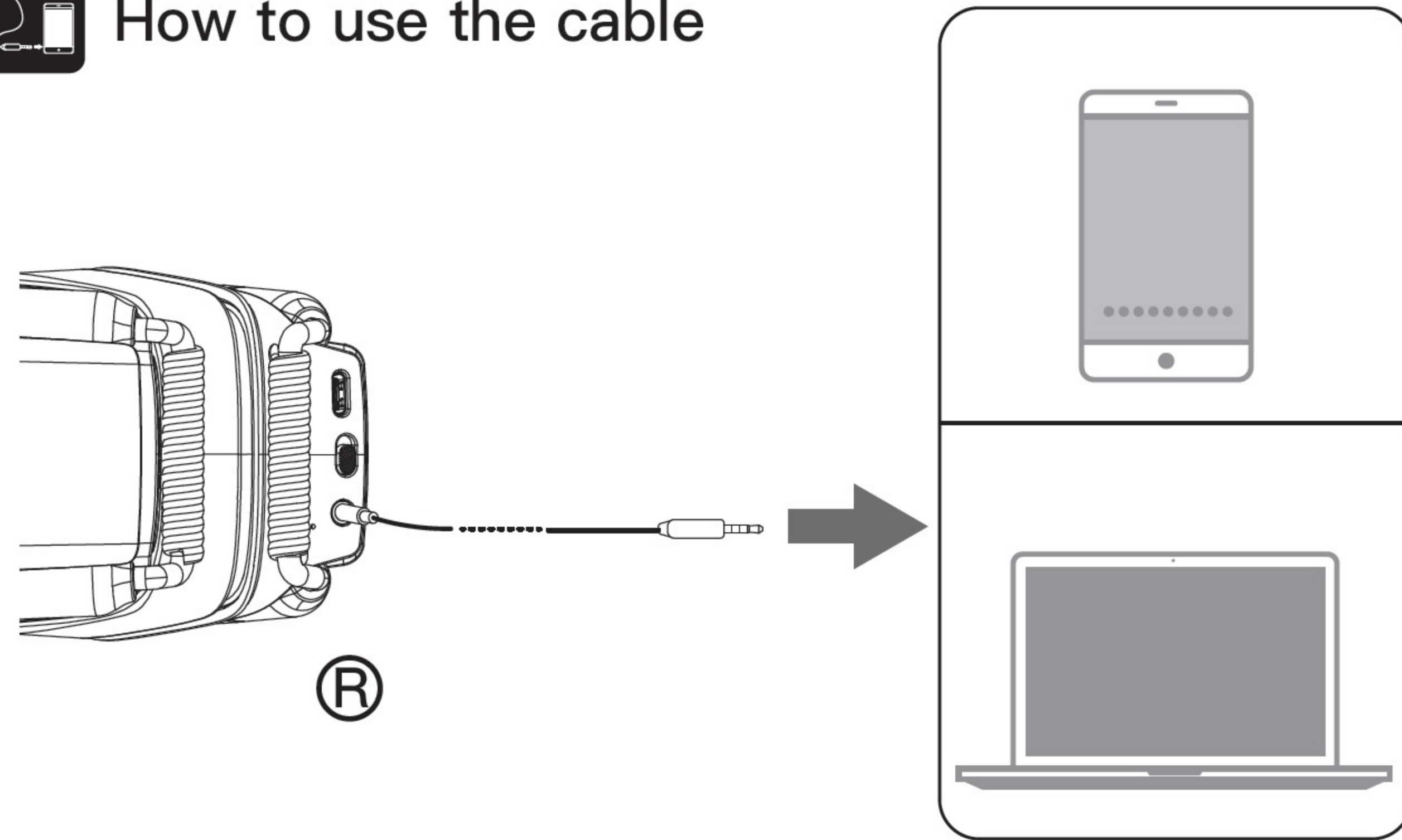

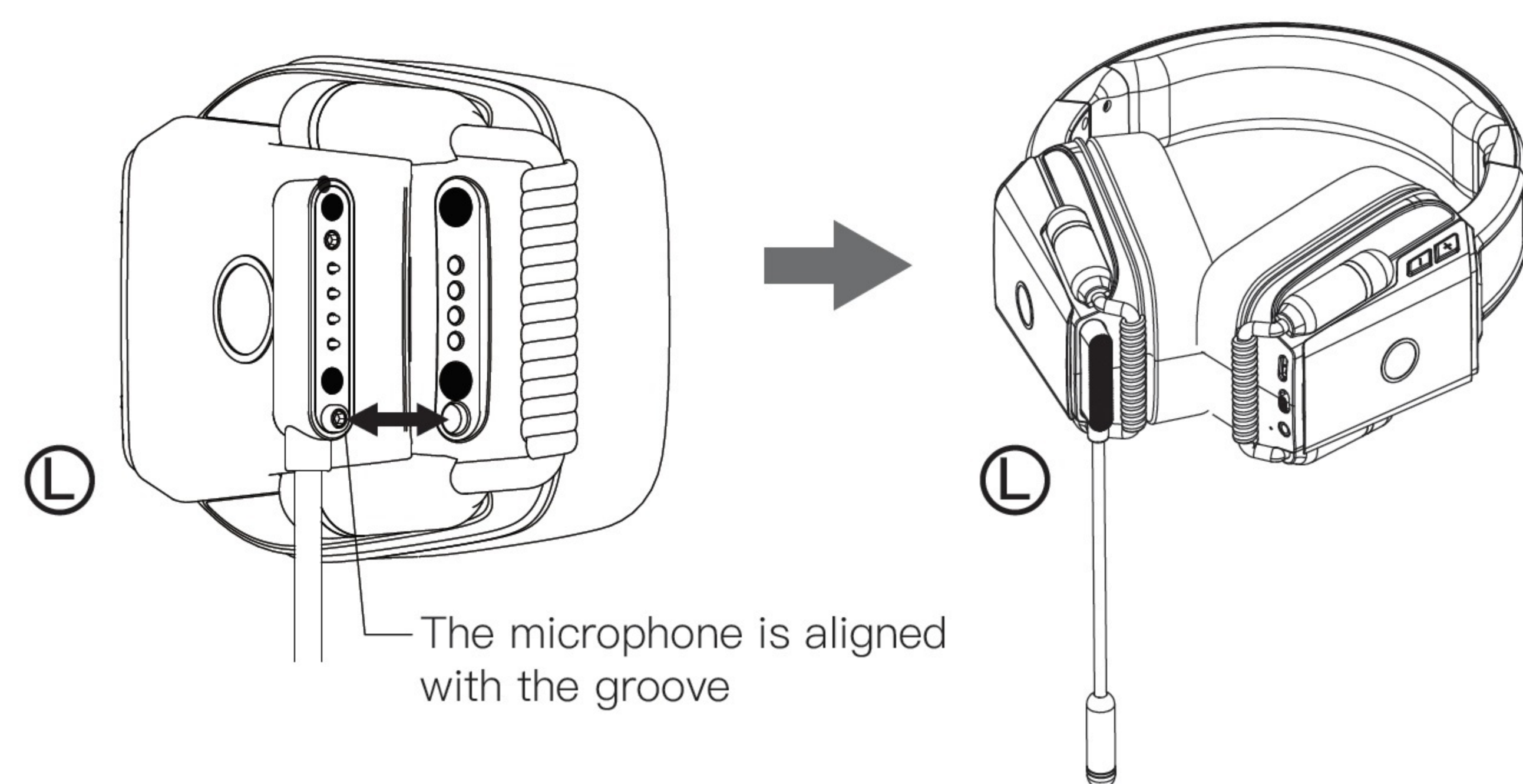


Press and hold the R touch button for 3 seconds (turn off the rocket light)

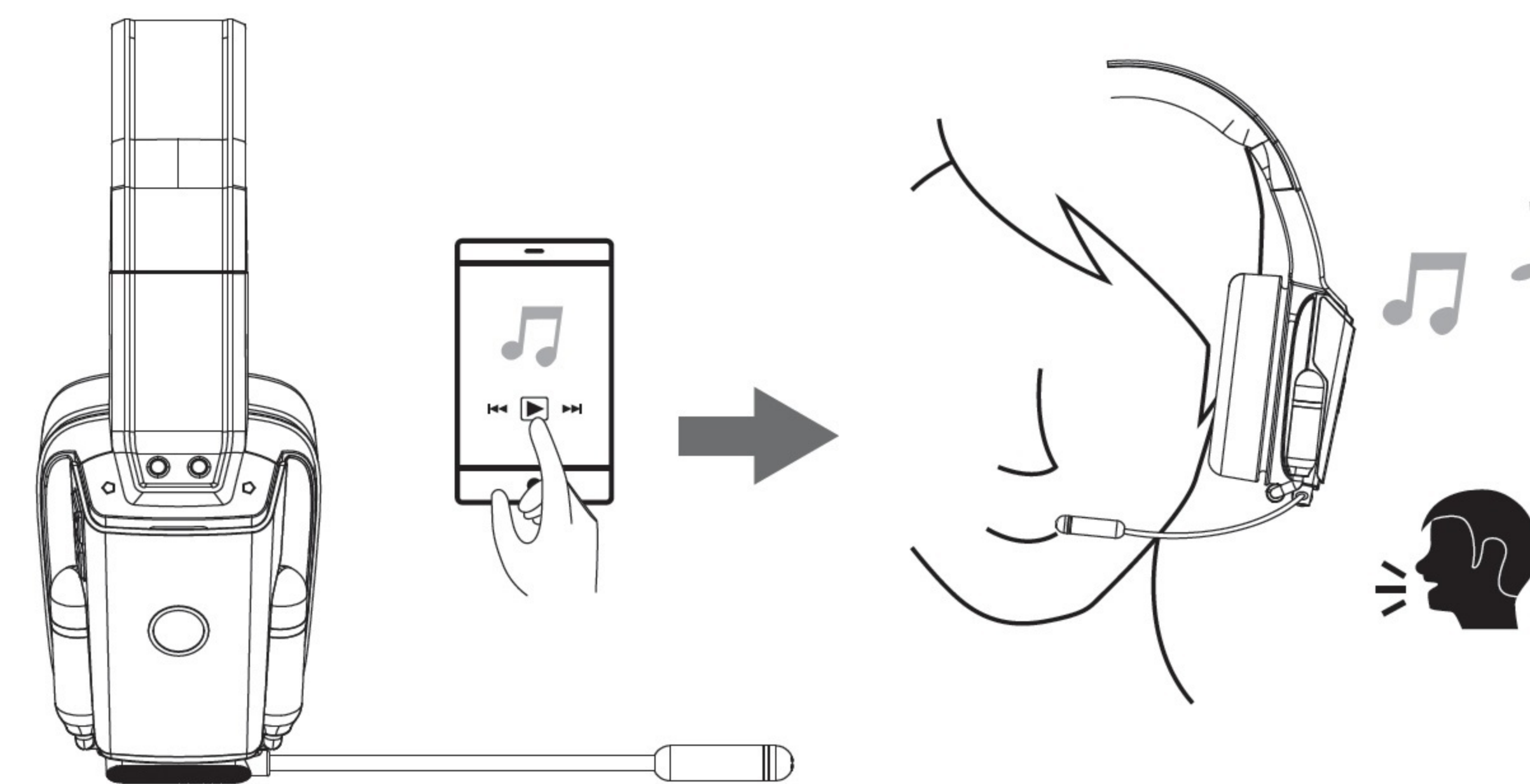

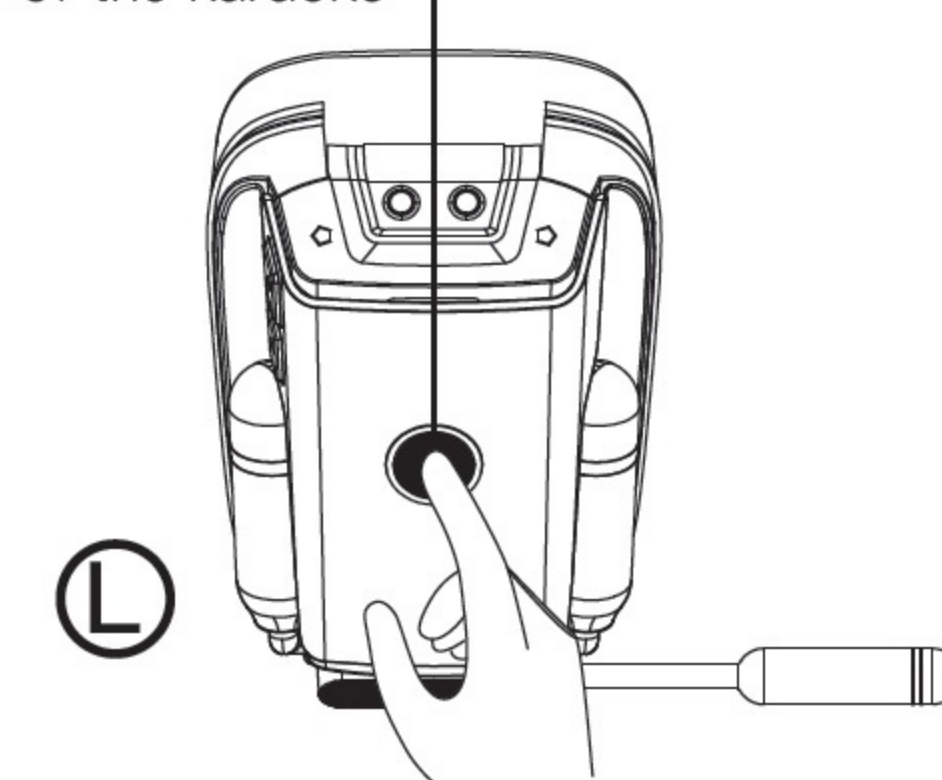
