Hopping Channel Number_DH5_2402



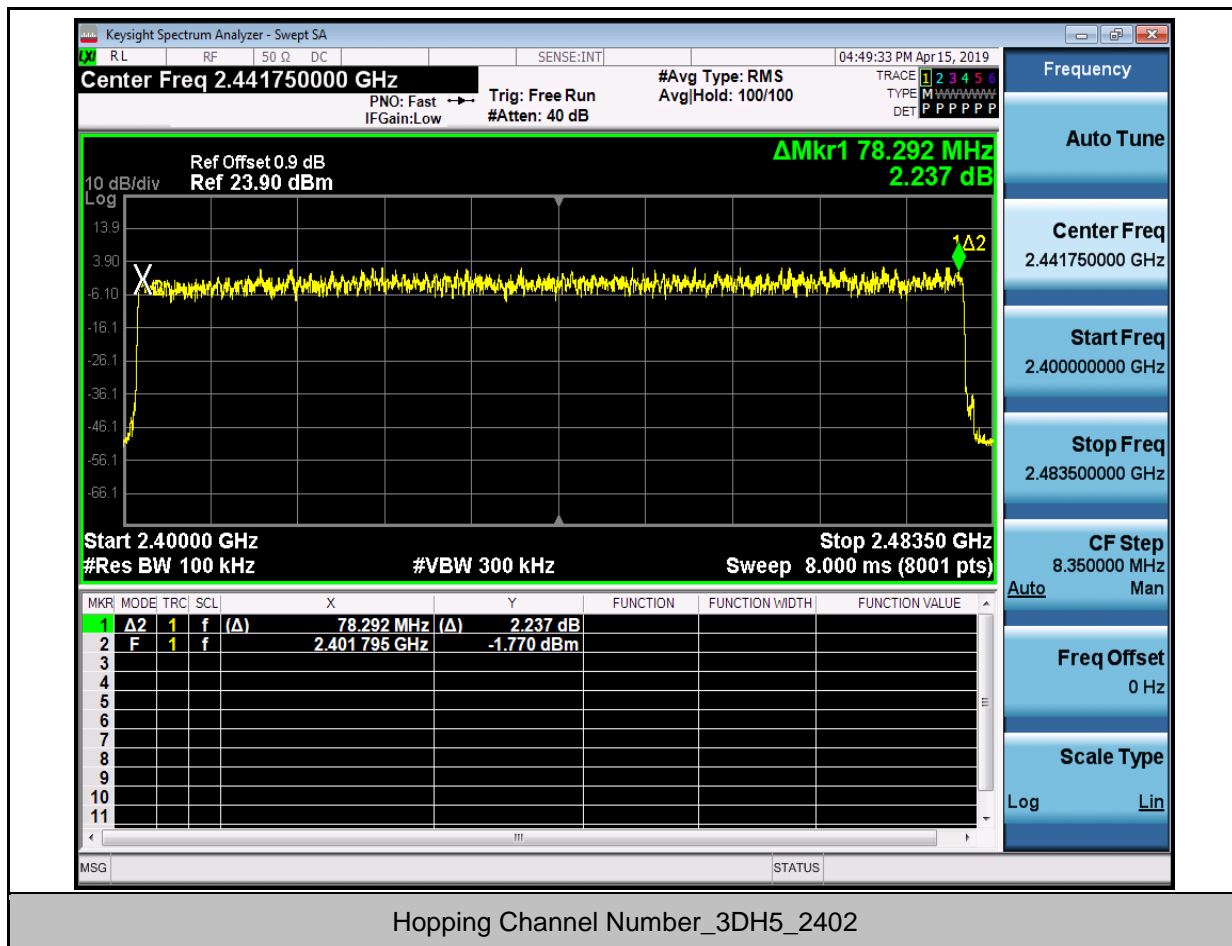
