The maximum antenna gain between the two antennas is 4.0 dBi

The max time-averaged EIRP per 2.0 above is $1.31 \times 10-2 \times 2405^{0.6834}$ (W) = 2.679W = 2679 mW.

The power density at 20cm corresponding to 2679 mW EIRP is N/(4 x π x d²) or 2679/(4* π *20²) = 0.533 mW/CM²
