GENERAL INFORMATION

Product Description for Equipment under Test (EUT)

The *Telecell Mobile (H.K) Ltd.*'s product, model number: *F242 (FCC ID: 2ADX3F242)* or the "EUT" in this report was a *Mobile phone*, which was measured approximately: 103.0 mm (L) * 52.0 mm (W) * 15 mm (H), rated with input voltage: DC 3.7V rechargeable Li-ion battery or DC 5.0V from adapter. The highest operating frequency is 2480MHz.

Objective

This test report is prepared on behalf of *Telecell Mobile (H.K) Ltd.* in accordance with Part 2-Subpart J, Part 15-Subparts A, B of the Federal Communication Commissions rules.

The objective of the manufacturer is to determine the compliance of the EUT with FCC Part 15 B.

Test Methodology

All measurements contained in this report were conducted with ANSI C63.4-2014, American National Standard of Procedures for Compliance Testing of Intentional Devices.

All emissions measurement was performed at Bay Area Compliance Laboratories Corp. (Kunshan). The radiated testing was performed at an antenna-to-EUT distance of 3 meters.

Measurement uncertainty with radiated emission is 5.91 dB for 30MHz-1GHz and 4.92dB for above 1GHz, 1.95dB for conducted measurement.

Test Facility

The test site used by Bay Area Compliance Laboratories Corp. (Kunshan) to collect test data is located on the Chenghu Lake Road, Kunshan Development Zone No.248, Kunshan, Jiangsu, China

Test site at Bay Area Compliance Laboratories Corp. (Kunshan) has been fully described in reports submitted to the Federal Communication Commission (FCC). The details of these reports have been found to be in compliance with the requirements of Section 2.948 of the FCC Rules on November 06, 2014. The facility also complies with the radiated and AC line conducted test site criteria set forth in ANSI C63.4.





Maximizing procedure was performed on the six (6) highest emissions of the EUT.

All data was recorded in the Quasi-peak and average detection mode.

Corrected Factor & Margin Calculation

The Corrected factor is calculated by adding LISN/ISN VDF (Voltage Division Factor), Cable Loss and Transient Limiter Attenuation. The basic equation is as follows:

Correction Factor = LISN VDF + Cable Loss + Transient Limiter Attenuation




AC 120V/60 Hz, Line





The radiated emission tests were performed in the 3 meters chamber test site, using the setup accordance with the ANSI C63.4-2014. The specification used was the FCC Part 15.109 Class B limits.

The external I/O cables were draped along the test table and formed a bundle 30 to 40 cm long in the middle.

The spacing between the peripherals was 10 cm.

EMI Test Receiver Setup

The system was investigated from 30 MHz to 12.4 GHz.

During the radiated emission test, the EMI test receiver was set with the following configurations:

Test Procedure

Maximizing procedure was performed on the highest emissions to ensure that the EUT complied with all installation combinations.

All data was recorded in the Quasi-peak detector mode from 30 MHz to 1 GHz and PK and average detector modes for frequencies above 1 GHz.

Corrected Amplitude & Margin Calculation

The Corrected Amplitude is calculated by adding the Antenna Factor and Cable Loss, and subtracting the Amplifier Gain from the Meter Reading. The basic equation is as follows:

Corrected Amplitude = Meter Reading + Antenna Factor + Cable Loss - Amplifier Gain

The "Margin" column of the following data tables indicates the degree of compliance with the applicable limit. For example, a margin of 7 dB means the emission is 7 dB below the limit. The equation for margin calculation is as follows:

Margin = Limit – Corrected Amplitude
