Where: S=power density

P=power input to antenna

G=power gain of the antenna in the direction of interest relative to an isotropic radiator

R=distance to the center of radiation of the antenna

From the peak EUT RF output power, the minimum mobile separation distance, d=0.2m, as well as the gain of the antenna is 2.5 dBi, the RF power density can be obtained.

# 2. RF EXPOSURE

# 2.1. Exemption Limits for Routine Evaluation – RF Exposure Evaluation

RF exposure evaluation is required if the separation distance between the user and/or bystander and the device's radiating element is greater than 20 cm, except when the device operates as follows:

at or above 300 MHz and below 6 GHz and the source-based, time-averaged maximum e.i.r.p. of the device is equal to or less than  $1.31 \times 10-2 \text{ } f0.6834 \text{ W}$  (adjusted for tune-up tolerance), where f is in MHz
