4.3 DESCRIPTION OF TEST MODES

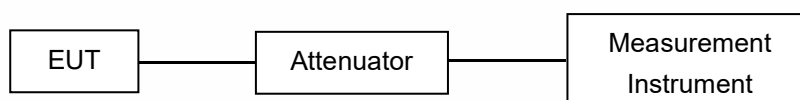

7 SETUP OF EQUIPMENT UNDER TEST

7.1 RADIO FREQUENCY TEST SETUP

The WLAN component's antenna ports(s) of the EUT are connected to the measurement instrument per an appropriate attenuator. The EUT is controlled by PC/software to emit the specified signals for the purpose of measurements.



7.2 RADIO FREQUENCY TEST SETUP

The test site semi-anechoic chamber has met the requirement of NSA tolerance 4 dB according to the standards: ANSI C63.10. The test distance is 3m. The setup is according to the requirements in Section 13.1.4.1 of ANSI C63.10-2013 and CAN/CSA-CEI/IEC CISPR 22.

Below 30MHz:

The EUT is placed on a turntable 0.8 meters above the ground in the chamber, 3 meter away from the antenna (loop antenna). The Antenna should be positioned with its plane vertical at the specified distance from the EUT and rotated about its vertical axis for maximum response at each azimuth about the EUT. The center of the loop shall be 1 m above the ground. For certain applications, the loop antenna plane may also need to be positioned horizontally at the specified distance from the EUT.

Above 30MHz:

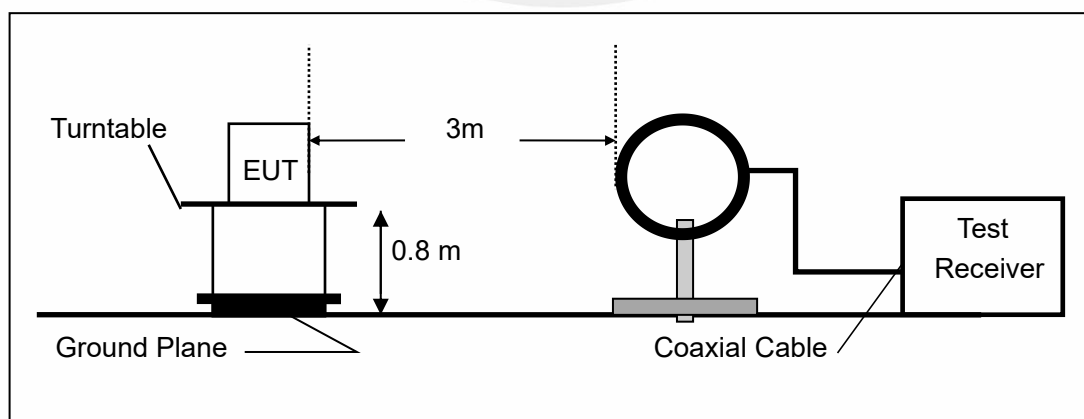
The EUT is placed on a turntable 0.8 meters above the ground in the chamber, 3 meter away from the antenna. The maximal emission value is acquired by adjusting the antenna height, polarisation and turntable azimuth. Normally, the height range of antenna is 1 m to 4 m, the azimuth range of turntable is 0° to 360°, and the receive antenna has two polarizations Vertical (V) and Horizontal (H).

Above 1GHz:

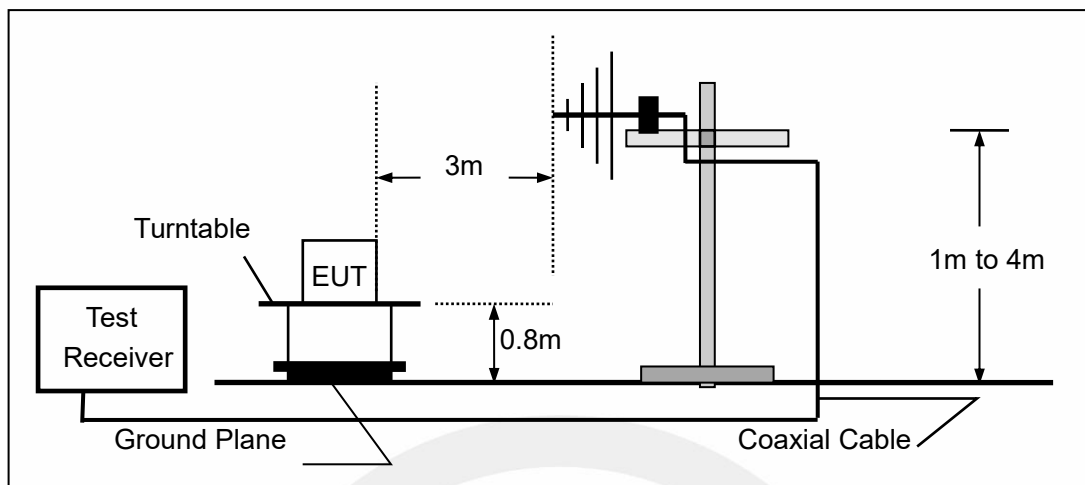

The EUT is placed on a turntable 1.5 meters above the ground in the chamber, 3 meter away from the antenna. The maximal emission value is acquired by adjusting the antenna height, polarisation and turntable azimuth. Normally, the height range of antenna is 1 m to 4 m, the azimuth range of turntable is 0° to 360°, and the receive antenna has two polarizations Vertical (V) and Horizontal (H).

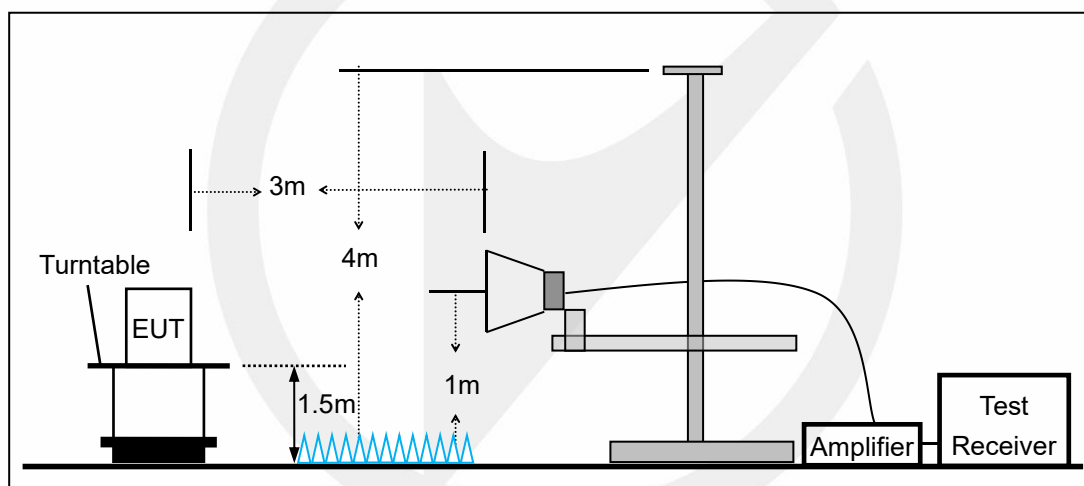
(a) Radiated Emission Test Set-Up, Frequency Below 30MHz

(c) Radiated Emission Test Set-Up, Frequency above 1000MHz

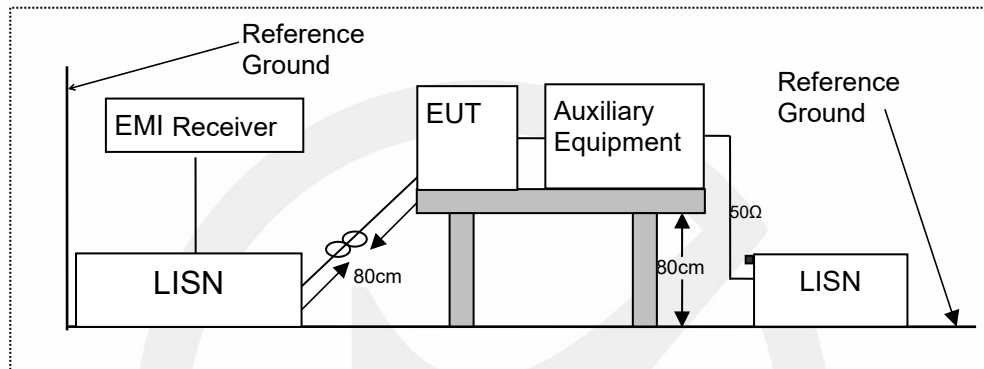


7.3 CONDUCTED EMISSION TEST SETUP

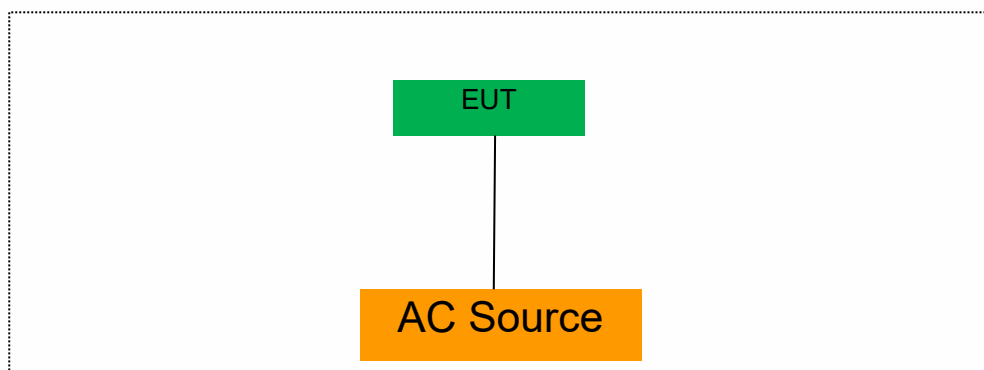
The mains cable of the EUT (maybe per AC/DC Adapter) must be connected to LISN. The LISN shall be placed 0.8 m from the boundary of EUT and bonded to a ground reference plane for LISN mounted on top of the ground reference plane. This distance is between the closest points of the LISN and the EUT. All other units of the EUT and associated equipment shall be at least 0.8m from the LISN.

Ground connections, where required for safety purposes, shall be connected to the reference ground point of the LISN and, where not otherwise provided or specified by the manufacturer, shall be of same length as the mains cable and run parallel to the mains connection at a separation distance of not more than 0.1 m.

According to the requirements in Section 13.1.4.1 of ANSI C63.10-2013 Conducted emissions from the EUT measured in the frequency range between 0.15 MHz and 30 MHz using CISPR Quasi-Peak and average detector mode.

8 TEST REQUIREMENTS

8.1 BANDWIDTH MEASUREMENT

8.1.1 Applicable Standard

According to FCC Part 15.407(a)(1) for UNII Band I

8.1.2 Conformance Limit

(1) For the band 5.15-5.25 GHz.

(iv) For mobile and portable client devices in the 5.15-5.25 GHz band, the maximum conducted output power over the frequency band of operation shall not exceed 250 mW provided the maximum antenna gain does not exceed 6 dBi. In addition, the maximum power spectral density shall not exceed 11 dBm in any 1 megahertz band. If transmitting antennas of directional gain greater than 6 dBi are used, both the maximum conducted output power and the maximum power spectral density shall be reduced by the amount in dB that the directional gain of the antenna exceeds 6 dBi.

(2) For the 5.25-5.35 GHz and 5.47-5.725 GHz bands, the maximum conducted output power over the frequency bands of operation shall not exceed the lesser of 250 mW or 11 dBm + 10 log B, where B is the 26 dB emission bandwidth in megahertz. In addition, the maximum power spectral density shall not exceed 11 dBm in any 1 megahertz band. If transmitting antennas of directional gain greater than 6 dBi are used, both the maximum conducted output power and the maximum power spectral density shall be reduced by the amount in dB that the directional gain of the antenna exceeds 6 dBi.

(3) For the band 5.725-5.85 GHz, the maximum conducted output power over the frequency band of operation shall not exceed 1 W. In addition, the maximum power spectral density shall not exceed 30 dBm in any 500-kHz band. If transmitting antennas of directional gain greater than 6 dBi are used, both the maximum conducted output power and the maximum power spectral density shall be reduced by the amount in dB that the directional gain of the antenna exceeds 6 dBi. However, fixed point-to-point U-NII devices operating in this band may employ transmitting antennas with directional gain greater than 6 dBi without any corresponding reduction in transmitter conducted power. Fixed, point-to-point operations exclude the use of point-to-multipoint systems, omnidirectional applications, and multiple collocated transmitters transmitting the same information. The operator of the U-NII device, or if the equipment is professionally installed, the installer, is responsible for ensuring that systems employing high gain directional antennas are used exclusively for fixed, point-to-point operations.

(e) Within the 5.725-5.85 GHz band, the minimum 6 dB bandwidth of U-NII devices shall be at least 500 kHz.

8.1.3 Test Configuration

Test according to clause 6.1 radio frequency test setup

8.1.4 Test Procedure

According to 789033 D02 v02r01 section C&D, the following is the measurement procedure.

1. Emission Bandwidth (EBW)

- Set RBW = approximately 1% of the emission bandwidth.
- Set the VBW > RBW.
- Detector = Peak.
- Trace mode = max hold.
- Measure the maximum width of the emission that is 26 dB down from the maximum of the emission.

Compare this with the RBW setting of the analyzer. Readjust RBW and repeat measurement as needed until the RBW/EBW ratio is approximately 1%.

2. Minimum Emission Bandwidth for the band 5.725-5.85 GHz

Section 15.407(e) specifies the minimum 6 dB emission bandwidth of at least 500 KHz for the band 5.715-5.85 GHz. The following procedure shall be used for measuring this bandwidth:

- a) Set RBW = 100 kHz.
- b) Set the video bandwidth (VBW) $\geq 3 \times$ RBW.
- c) Detector = Peak.
- d) Trace mode = max hold.
- e) Sweep = auto couple.
- f) Allow the trace to stabilize.
- g) Measure the maximum width of the emission that is constrained by the frequencies associated with the two outermost amplitude points (upper and lower frequencies) that are attenuated by 6 dB relative to the maximum level measured in the fundamental emission.

Note: The automatic bandwidth measurement capability of a spectrum analyzer or EMI receiver may be employed if it implements the functionality described above.

D. 99 Percent Occupied Bandwidth

The 99-percent occupied bandwidth is the frequency bandwidth such that, below its lower and above its upper frequency limits, the mean powers are each equal to 0.5 % of the total mean power of the given emission. Measurement of the 99-percent occupied bandwidth is required only as a condition for using the optional band-edge measurement techniques described in section II.G.3.d). Measurements of 99-percent occupied bandwidth may also optionally be used in lieu of the EBW to 789033 D02 v01r02 General UNII Test Procedures New Rules v01 define the minimum frequency range over which the spectrum is integrated when measuring maximum conducted output power as described in section II.E. However, the EBW must be measured to determine bandwidth dependent limits on maximum conducted output power in accordance with 15.407(a).

The following procedure shall be used for measuring (99 %) power bandwidth:

1. Set center frequency to the nominal EUT channel center frequency.
2. Set span = 1.5 times to 5.0 times the OBW.
3. Set RBW = 1 % to 5 % of the OBW
4. Set VBW $\geq 3 \cdot$ RBW
5. Video averaging is not permitted. Where practical, a sample detection and single sweep mode shall be used. Otherwise, peak detection and max hold mode (until the trace stabilizes) shall be used.
6. Use the 99 % power bandwidth function of the instrument (if available).
7. If the instrument does not have a 99 % power bandwidth function, the trace data points are recovered and directly summed in power units. The recovered amplitude data points, beginning at the lowest frequency, are placed in a running sum until 0.5 % of the total is reached; that frequency is recorded as the lower frequency. The process is repeated until 99.5 % of the total is reached; that frequency is recorded as the upper frequency. The 99% occupied bandwidth is the difference between these two frequencies.

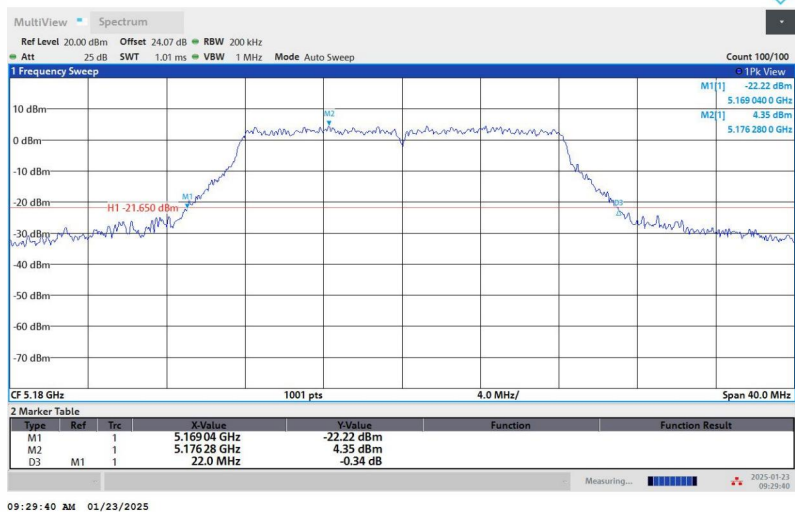

8.2.2 Conformance Limit

■ For the band 5.15-5.25 GHz,

(a) (1) (i) For an outdoor access point operating in the band 5.15-5.25 GHz, the maximum conducted output power over the frequency band of operation shall not exceed 1 W provided the maximum antenna gain does not exceed 6 dBi. In addition, the maximum power spectral density shall not exceed 17 dBm in any 1 megahertz band. If transmitting antennas of directional gain greater than 6 dBi are used, both the maximum conducted output power and the maximum power spectral density shall be reduced by the amount in dB that the directional gain of the antenna exceeds 6 dBi. The maximum e.i.r.p. at any elevation angle above 30 degrees as measured from the horizon must not exceed 125 mW (21 dBm).

(a) (1) (ii) For an indoor access point operating in the band 5.15-5.25 GHz, the maximum conducted output power over the frequency band of operation shall not exceed 1 W provided the maximum antenna gain does not exceed 6 dBi. In addition, the maximum power spectral density shall not exceed 17 dBm in any 1 megahertz band. If transmitting antennas of directional gain greater than 6 dBi are used, both the maximum conducted output power and the maximum power spectral density shall be reduced by the amount in dB that the directional gain of the antenna exceeds 6 dBi.

(a) (1) (iii) For fixed point-to-point access points operating in the band 5.15-5.25 GHz, the maximum conducted output power over the frequency band of operation shall not exceed 1 W. In addition, the maximum power spectral density shall not exceed 17 dBm in any 1 megahertz band. Fixed point-to-point U-NII devices may employ antennas with directional gain up to 23 dBi without any corresponding reduction in the maximum conducted output power or maximum power spectral density. For fixed point-to-point transmitters that employ a directional antenna gain greater than 23 dBi, a 1 dB reduction in maximum conducted output power and maximum power spectral density is required for each 1 dB of antenna gain in excess of 23 dBi. Fixed, point-to-point operations exclude the use of point-to-multipoint systems, omnidirectional applications, and multiple collocated transmitters transmitting the same information. ■ For the 5.25-5.35 GHz and 5.47-5.725 GHz bands

(a) (2) The maximum conducted output power over the frequency bands of operation shall not exceed the lesser of 250 mW or $11 \text{ dBm} + 10 \log B$, where B is the 26 dB emission bandwidth in megahertz. In addition, the maximum power spectral density shall not exceed 11 dBm in any 1 megahertz band. ■ For the band 5.725-5.85 GHz

If transmitting antennas of directional gain greater than 6 dBi are used, both the maximum conducted output power and the maximum power spectral density shall be reduced by the amount in dB that the directional gain of the antenna exceeds 6 dBi. However, fixed point-to-point U-NII devices operating in this band may employ transmitting antennas with directional gain greater than 6 dBi without any corresponding reduction in transmitter conducted power. Fixed, point-to-point operations exclude the use of point-to-multipoint systems, omnidirectional applications, and multiple collocated transmitters transmitting the same information. The operator of the U-NII device, or if the equipment is professionally installed, the installer, is responsible for ensuring that systems employing high gain directional antennas are used exclusively for fixed, point-to-point operations

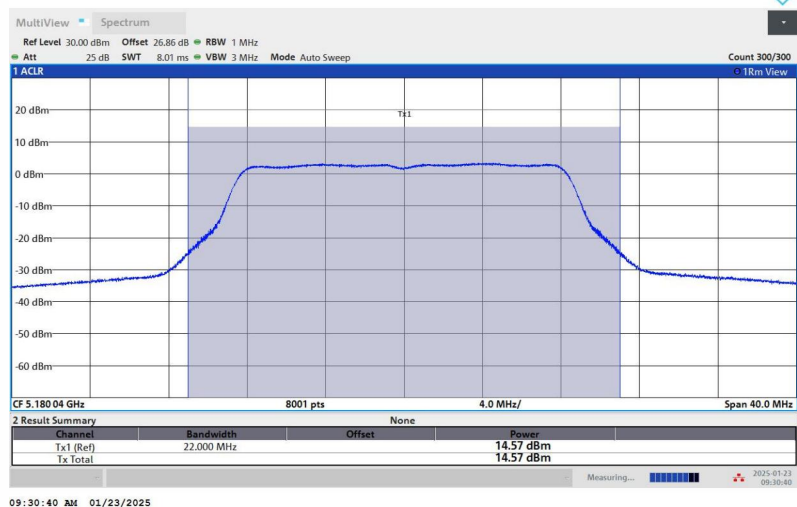
The maximum average conducted output power can be measured using Method PM-G (Measurement using a gated RF average power meter):
Measurements may be performed using a wideband gated RF power meter provided that the gate parameters are adjusted such that the power is measured only when the EUT is transmitting at its maximum power control level. Since the measurement is made only during the ON time of the transmitter, no duty cycle correction factor is required.

- The Transmitter output (antenna port) was connected to the power meter.
- Turn on the EUT and power meter and then record the power value.
- Repeat above procedures on all channels needed to be tested.

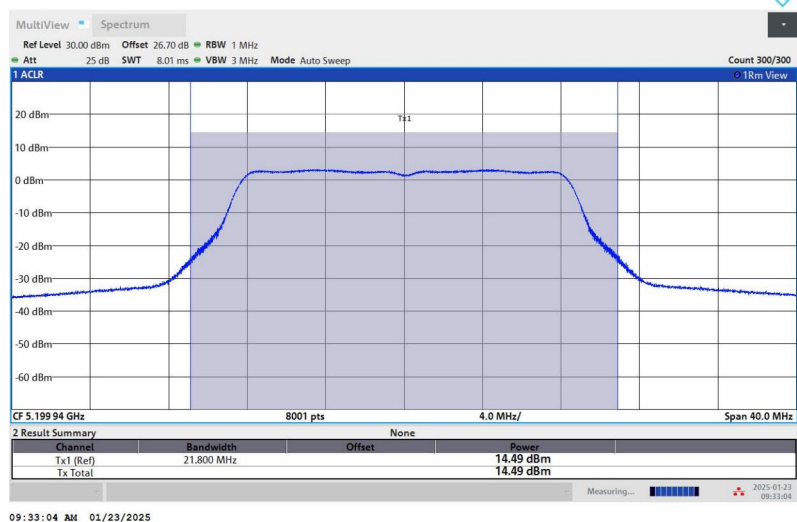

(a) (3) for the band 5.725-5.85 GHz, the maximum conducted output power over the frequency band of operation shall not exceed 1 W. In addition, the maximum power spectral density shall not exceed 30

dBm in any 500-kHz band. If transmitting antennas of directional gain greater than 6 dBi are used, both the maximum conducted output power and the maximum power spectral density shall be reduced by the amount in dB that the directional gain of the antenna exceeds 6 dBi. However, fixed point-to-point U-NII devices operating in this band may employ transmitting antennas with directional gain greater than 6 dBi without any corresponding reduction in transmitter conducted power. Fixed, point-to-point operations exclude the use of point-to-multipoint systems, omnidirectional applications, and multiple collocated transmitters transmitting the same information. The operator of the U-NII device, or if the equipment is professionally installed, the installer, is responsible for ensuring that systems employing high gain directional antennas are used exclusively for fixed, point-to-point operations

8.3.4 Test Procedure

Methods refer to FCC KDB 789033

For devices operating in the bands 5.15-5.25 GHz, 5.25-5.35 GHz, and 5.47-5.725 GHz, the above procedures make use of 1 MHz RBW to satisfy directly the 1 MHz reference bandwidth specified in § 15.407(a)(5). For devices operating in the band 5.725-5.85 GHz, the rules specify a measurement bandwidth of 500 kHz. Many spectrum analyzers do not have 500 kHz RBW, thus a narrower RBW may need to be used. The rules permit the use of a RBWs less than 1 MHz, or 500 kHz, “provided that the measured power is integrated over the full reference bandwidth” to show the total power over the specified measurement bandwidth (i.e., 1 MHz, or 500 kHz). If measurements are performed using a reduced resolution bandwidth (< 1 MHz, or < 500 kHz) and integrated over 1 MHz, or 500 KHz bandwidth, the following adjustments to the procedures apply:

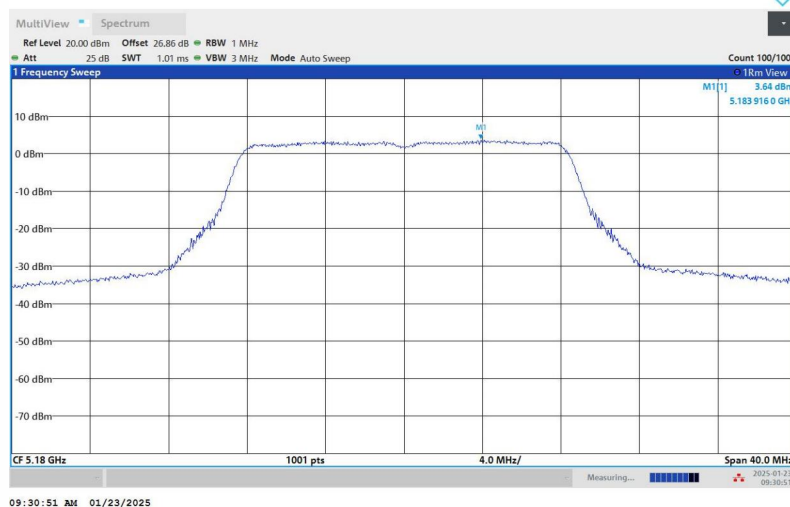
- a) Set $RBW \geq 1/T$, where T is defined in section II.B.I.a).
- b) Set $VBW \geq 3 RBW$.
- c) If measurement bandwidth of Maximum PSD is specified in 500 kHz, add $10\log(500\text{kHz}/RBW)$ to the measured result, whereas $RBW (< 500 \text{ KHz})$ is the reduced resolution bandwidth of the spectrum analyzer set during measurement.
- d) If measurement bandwidth of Maximum PSD is specified in 1 MHz, add $10\log(1\text{MHz}/RBW)$ to the measured result, whereas $RBW (< 1 \text{ MHz})$ is the reduced resolution bandwidth of spectrum analyzer set during measurement.
- e) Care must be taken to ensure that the measurements are performed during a period of continuous transmission or are corrected upward for duty cycle.

Note: As a practical matter, it is recommended to use reduced RBW of 100 KHz for the sections 5.c) and 5.d) above, since $RBW=100 \text{ KHz}$ is available on nearly all spectrum analyzers.

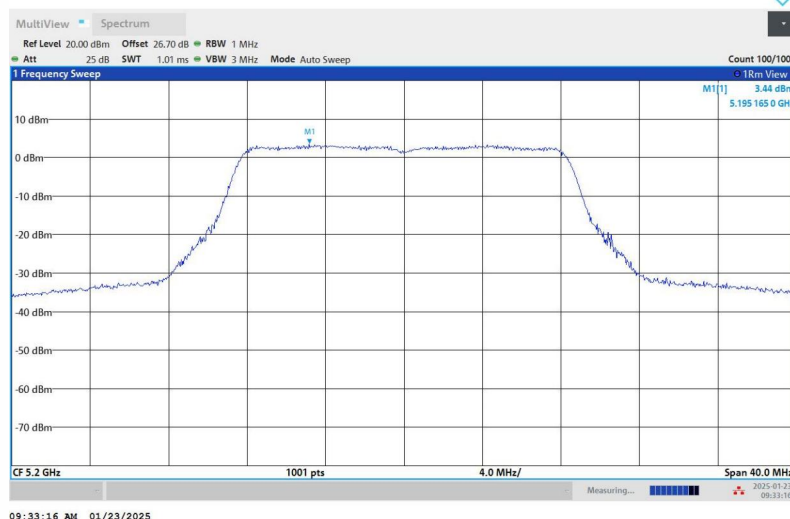

8.4 UNDESIRABLE RADIATED SPURIOUS EMISSION

8.4.1 Applicable Standard

According to FCC Part 15.407 (b)
According to 789033 D02 Section II(G)

8.4.2 Conformance Limit

For transmitters operating in the 5.15-5.25 GHz band: All emissions outside of the 5.15-5.35 GHz band shall not exceed an e.i.r.p. of -27 dBm/MHz.

For transmitters operating in the 5.25-5.35 GHz band: All emissions outside of the 5.15-5.35 GHz band shall not exceed an e.i.r.p. of -27 dBm/MHz.

For transmitters operating in the 5.47-5.725 GHz band: All emissions outside of the 5.47-5.725 GHz band shall not exceed an e.i.r.p. of -27 dBm/MHz.

For transmitters operating in the 5.725-5.85 GHz band: All emissions shall be limited to a level of -27 dBm/MHz at 75 MHz or more above or below the band edge increasing linearly to 10 dBm/MHz at 25 MHz above or below the band edge, and from 25 MHz above or below the band edge increasing linearly to a level of 15.6 dBm/MHz at 5 MHz above or below the band edge, and from 5 MHz above or below the band edge increasing linearly to a level of 27 dBm/MHz at the band edge.

The emission measurements shall be performed using a minimum resolution bandwidth of 1 MHz. A lower resolution bandwidth may be employed near the band edge, when necessary, provided the measured energy is integrated to show the total power over 1 MHz.

Unwanted emissions below 1 GHz must comply with the general field strength limits set forth in §15.209. The emissions from an intentional radiator shall not exceed the field strength levels specified in the following table 15.209(a):

8.4.4 Test Procedure

■ Unwanted Emissions Measurements below 1000 MHz

Compliance shall be demonstrated using CISPR quasi-peak detection; however, peak detection is permitted as an alternative to quasi-peak detection.

The EUT was placed on a turn table which is 0.8m above ground plane.

And also, each emission was to be maximized by changing the polarization of receiving antenna both horizontal and vertical.

Repeat above procedures until all frequency measured was complete.

We use software control the EUT, Let EUT hopping on and transmit with highest power, All the modes have been tested and the worst result was reported.

Use the following spectrum analyzer settings:

Set RBW=120kHz for $f < 1$ GHz(30MHz to 1GHz), 200Hz for $f < 150$ KHz(9KHz to 150KHz), 9KHz for < 30 MHz

(150KHz to 30KHz).

Set the VBW > RBW.

Detector = Peak.

Trace mode = max hold.

Follow the guidelines in ANSI C63.10-2013 with respect to maximizing the emission by rotating the EUT, measuring the emission while the EUT is situated in three orthogonal planes (if appropriate), adjusting the measurement antenna height and polarization, etc. A pre-amp and a high pass filter are required for this test, in order to provide the measuring system with sufficient sensitivity. Allow the trace to stabilize. The peak reading of the emission, after being corrected by the antenna factor, cable loss, pre-amp gain, etc., is the peak field strength, which must comply with the limit specified in Section 15.35(b). Submit this data.

Repeat above procedures until all frequency measured was complete.

■ Unwanted Maximum peak Emissions Measurements above 1000 MHz

Maximum emission levels are measured by setting the analyzer as follows:

RBW = 1 MHz.

VBW \geq 3 MHz.

Detector = Peak.

Sweep time = auto.

Trace mode = max hold.

Allow sweeps to continue until the trace stabilizes. Note that if the transmission is not continuous, the time required for the trace to stabilize will increase by a factor of approximately $1/x$, where x is the duty cycle. For example, at 50 percent duty cycle, the measurement time will increase by a factor of two relative to measurement time for continuous transmission.

■ Unwanted Average Emissions Measurements above 1000 MHz

Method VB (Averaging using reduced video bandwidth): Alternative method.

RBW = 1 MHz.

Video bandwidth. • If the EUT is configured to transmit with duty cycle \geq 98 percent, set $VBW \leq RBW/100$ (i.e., 10 kHz) but not less than 10 Hz.

• If the EUT duty cycle is < 98 percent, set $VBW \geq 1/T$, where T is defined in section II.B.1.a).

Video bandwidth mode or display mode • The instrument shall be set to ensure that video filtering is applied in the power domain. Typically, this requires setting the detector mode to RMS and setting the Average-VBW Type to Power (RMS).

• As an alternative, the analyzer may be set to linear detector mode. Ensure that video filtering is applied in linear voltage domain (rather than in a log or dB domain). Some analyzers require linear display mode in order to accomplish this. Others have a setting for Average-VBW Type, which can be set to "Voltage" regardless of the display mode.

Detector = Peak.

Sweep time = auto.

Trace mode = max hold.

Allow max hold to run for at least 50 traces if the transmitted signal is continuous or has at least 98 percent duty cycle. For lower duty cycles, increase the minimum number of traces by a factor of $1/x$, where x is the duty cycle. For example, use at least 200 traces if the duty cycle is 25 percent. (If a specific emission is demonstrated to be continuous—i.e., 100 percent duty cycle—rather than turning on and off with the transmit cycle, at least 50 traces shall be averaged.)

■ Band edge measurements.

Unwanted band-edge emissions may be measured using either of the special band-edge measurement techniques (the marker-delta or integration methods) described below. Note that the marker-delta method is primarily a radiated measurement technique that requires the 99% occupied bandwidth edge to be within 2 MHz of the authorized band edge, whereas the integration method can be used in either a radiated or conducted measurement without any special requirement with regards to the displacement of the unwanted emission(s) relative to the authorized bandwidth.

Marker-Delta Method.

The marker-delta method, as described in ANSI C63.10, can be used to perform measurements of the radiated unwanted emissions level of emissions provided that the 99% occupied bandwidth of the fundamental is within 2 MHz of the authorized band-edge.

Further, this requirement does not apply to intentional radiators that must be professionally installed, such as perimeter protection systems and some field disturbance sensors, or to other intentional radiators which, in accordance with §15.31(d), must be measured at the installation site. However, the installer shall be responsible for ensuring that the proper antenna is employed so that the limits in this part are not exceeded.

For intentional device, according to FCC 47 CFR Section 15.203, an intentional radiator shall be designed to ensure that no antenna other than that furnished by the responsible party shall be used with the device. And according to FCC 47 CFR Section 15.407 (a), if transmitting antennas of directional gain greater than 6dBi are used, the power shall be reduced by the amount in dB that the directional gain of the antenna exceeds 6dBi.
