The offset level is set in the spectrum analyzer to compensate the RF cable loss and attenuation factor between EUT conducted port and spectrum analyzer. With the offset compensation, the spectrum analyzer reading level is exactly EUT RF output level.

- 2. Enable AP service from EPC management
- 3. Check EUD Tx Frequency and power
- 4. Disable AP service from EPC management






