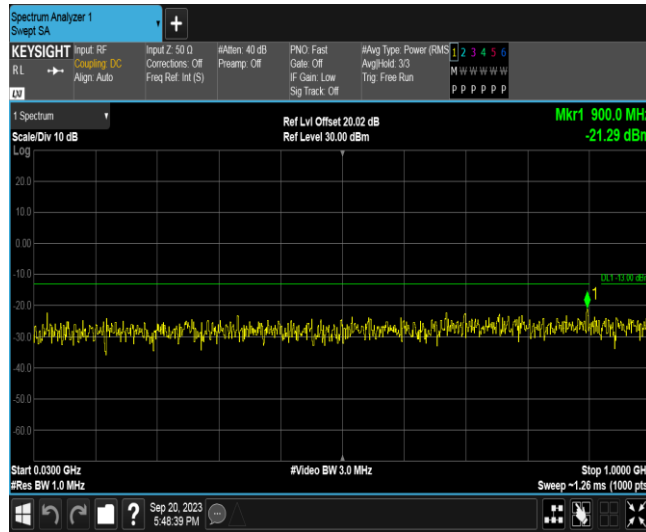


Band2-1.4MHz-QPSK-18607-1RB#0-Range2:1000~20000MHz

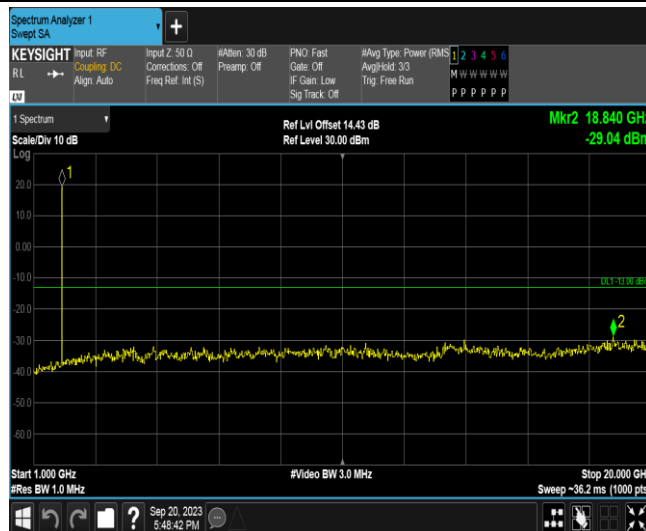

Band2-10MHz-16QAM-18650-1RB#0-Range2:1000~20000MHz

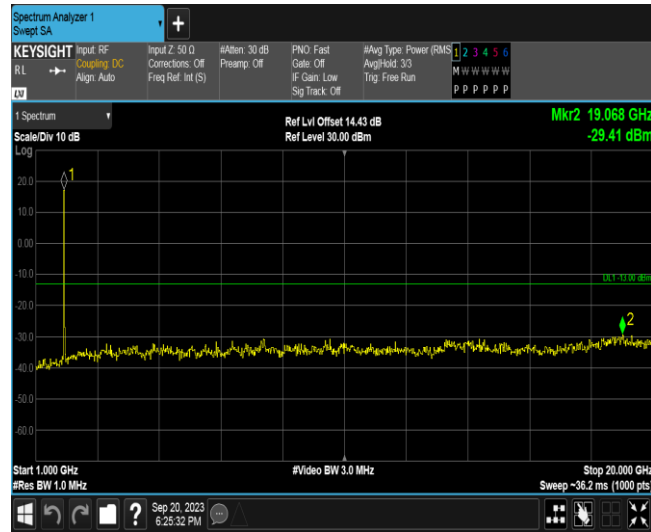

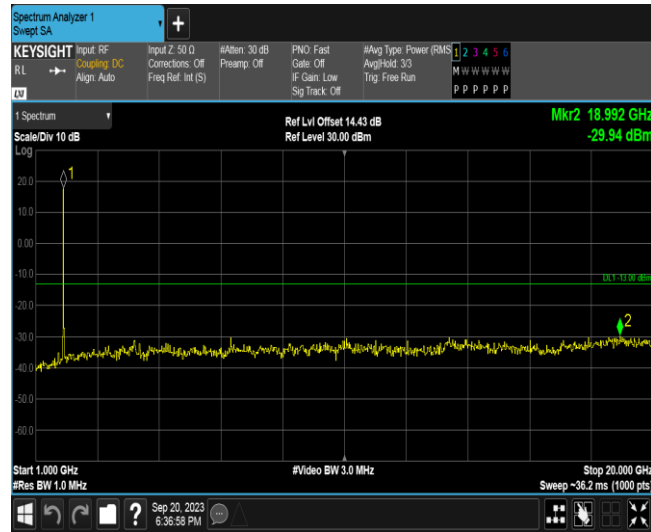


Band2-15MHz-16QAM-18675-1RB#0-Range1:30~1000MHz

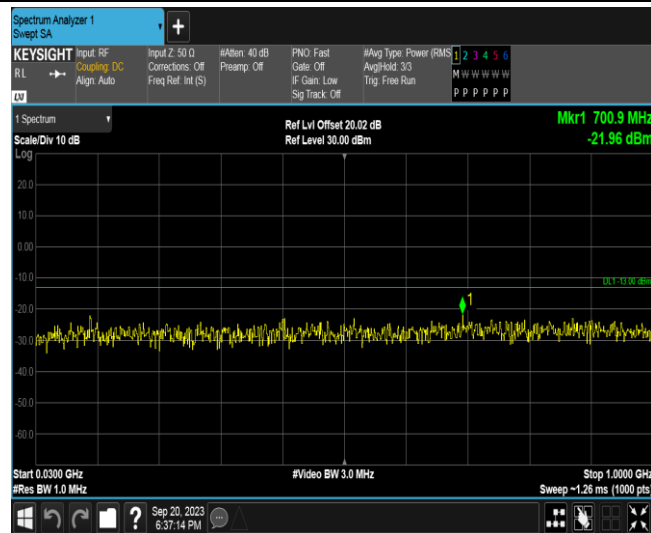

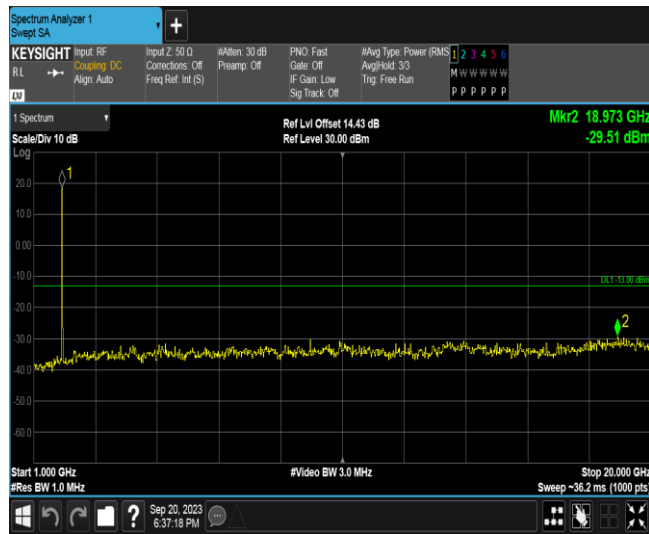

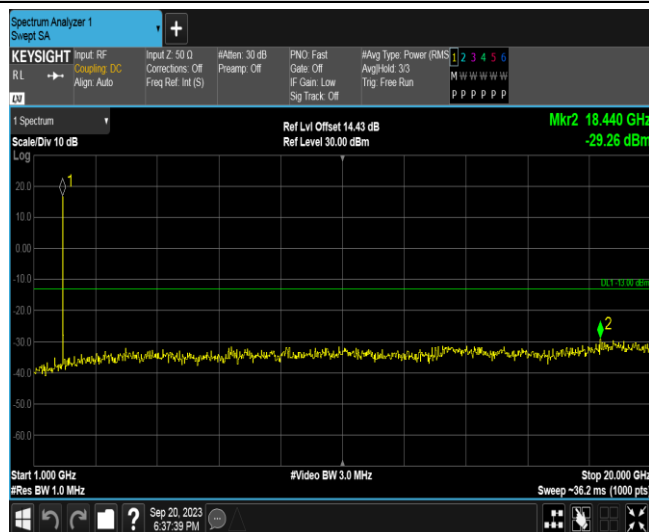

Band2-15MHz-16QAM-19125-1RB#0-Range1:30~1000MHz

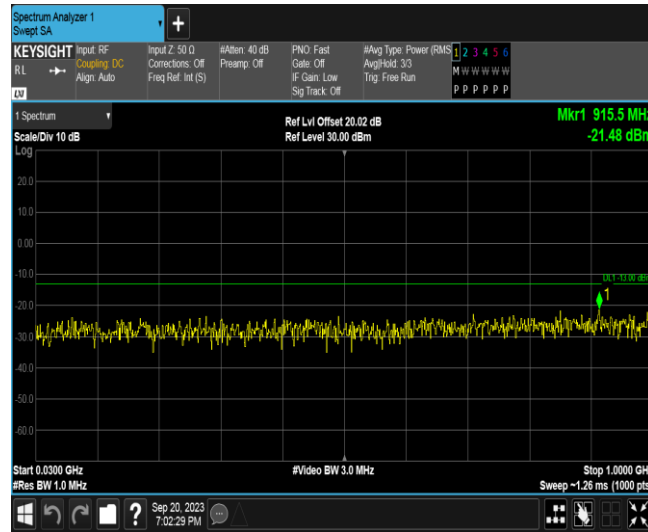


Band2-15MHz-16QAM-19125-1RB#0-Range2:1000~20000MHz

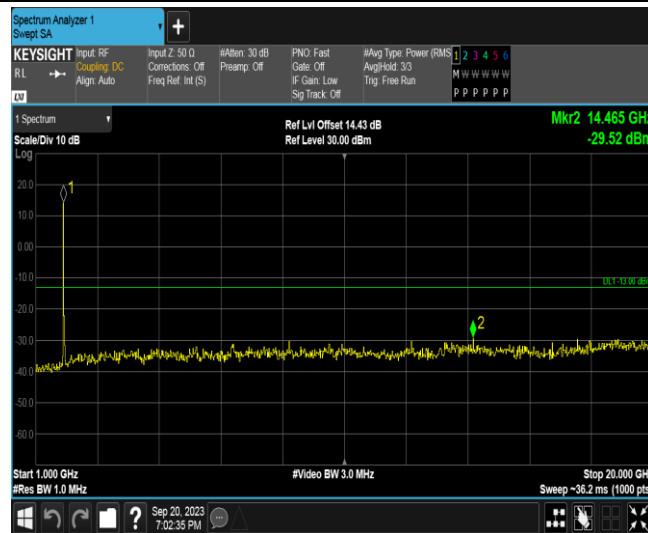

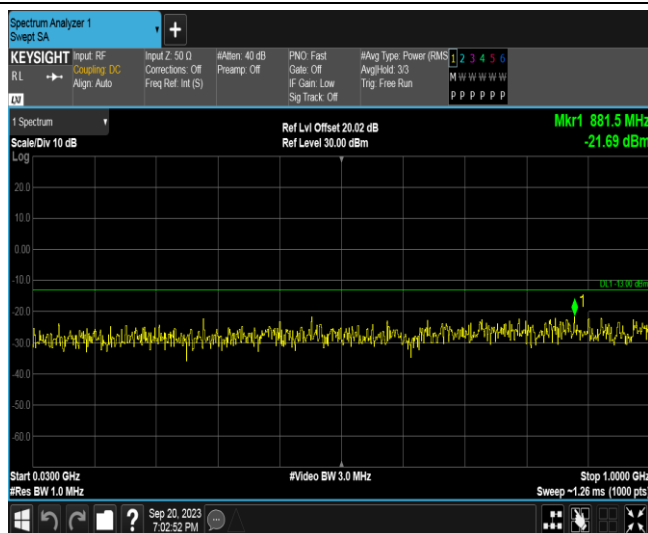

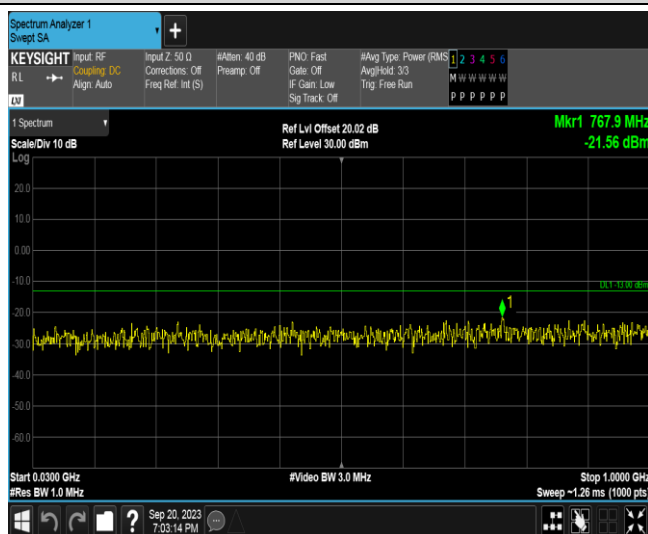

Band2-20MHz-QPSK-18900-1RB#0-Range2:1000~20000MHz

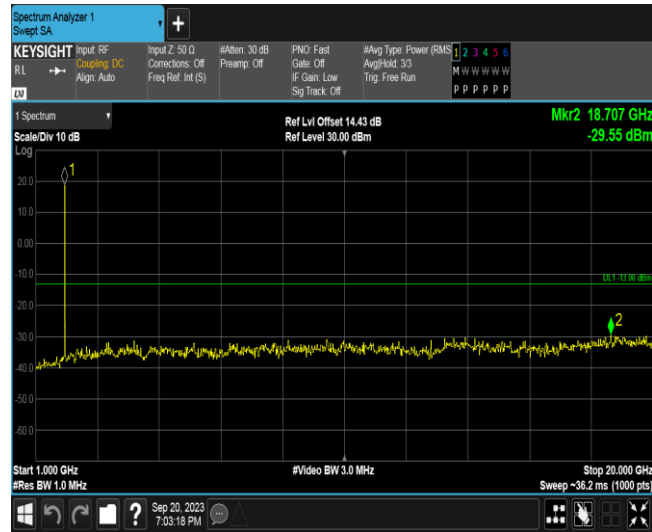


Band2-20MHz-QPSK-19100-1RB#0-Range1:30~1000MHz

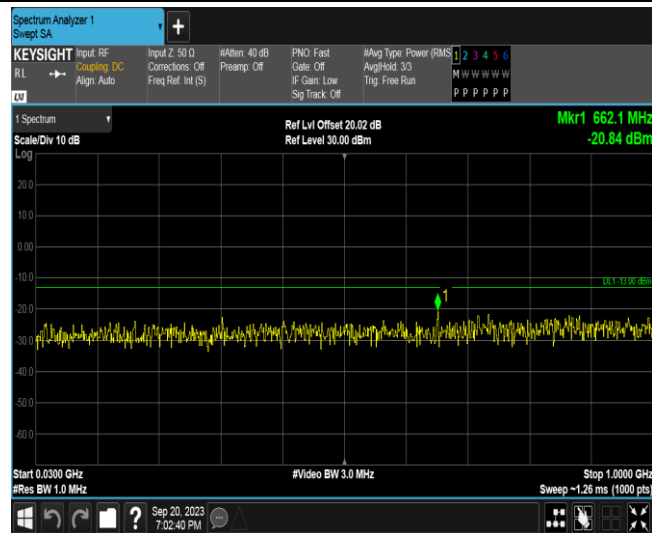
