



4 TEST CONDITIONS AND RESULTS

4.1 AC Power Conducted Emission

TEST CONFIGURATION



TEST PROCEDURE

- 1 The equipment was set up as per the test configuration to simulate typical actual usage per the user's manual. The EUT is a tabletop system, a wooden table with a height of 0.8 meters is used and is placed on the ground plane as per ANSI C63.10-2013.
- 2 Support equipment, if needed, was placed as per ANSI C63.10-2013
- 3 All I/O cables were positioned to simulate typical actual usage as per ANSI C63.10-2013
- 4 The EUT received DC 12V power from adapter, the adapter received AC120V/60Hz and AC 240V/60Hz power through a Line Impedance Stabilization Network (LISN) which supplied power source and was grounded to the ground plane.
- 5 All support equipments received AC power from a second LISN, if any.
- 6 The EUT test program was started. Emissions were measured on each current carrying line of the EUT using a spectrum Analyzer / Receiver connected to the LISN powering the EUT. The LISN has two monitoring points: Line 1 (Hot Side) and Line 2 (Neutral Side). Two scans were taken: one with Line 1 connected to Analyzer / Receiver and Line 2 connected to a 50 ohm load; the second scan had Line 1 connected to a 50 ohm load and Line 2 connected to the Analyzer / Receiver.
- 7 Analyzer / Receiver scanned from 150 KHz to 30MHz for emissions in each of the test modes.
- 8 During the above scans, the emissions were maximized by cable manipulation.






(A) Radiated Emission Test Set-Up, Frequency Below 30MHz

**Test Procedure**

- Below 1GHz measurement the EUT is placed on a turntable which is 0.8m above ground plane, and above 1GHz measurement EUT was placed on a low permittivity and low loss tangent turn table which is 1.5m above ground plane.
- Maximum procedure was performed by raising the receiving antenna from 1m to 4m and rotating the turn table from 0° to 360° to acquire the highest emissions from EUT
- And also, each emission was to be maximized by changing the polarization of receiving antenna both horizontal and vertical.
- Repeat above procedures until all frequency measurements have been completed.
- There were no emissions found below 30MHz within 20dB of the limit.

TEST RESULTS

The emissions from 30MHz to 5GHz are measured peak and average level, below 1 GHz measured QP level, detailed test data please see below. Besides, we tested 3 directions and recorded the worst data.

Note: We tested all Modes and recorded the worst case as follow.






(The plot of Duty Cycle See the follow page)

(Time per burst: 1.000ms*11pcs)





4.3 20dB Bandwidth

Limit

According to 47 CFR 15.231(c) The bandwidth of the emission shall be no wider than 0.25% of the centre frequency for devices operating above 70MHz and below 900MHz. Bandwidth is determined at the points 20dB down from the modulated carrier.

Test Configuration



Test Procedure

The 20dB bandwidth and 99% bandwidth is measured with a spectrum analyzer connected via a receive antenna placed near the EUT while the EUT is operating in transmission mode.


The 20dB bandwidth is defined as the total spectrum the power of which is higher than peak power minus 20dB.

The occupied bandwidth (OBW), that is the frequency bandwidth such that, below its lower and above its upper frequency limits, the mean powers radiated are each equal to 0.5 percent of the total mean power radiated by a given emission.

4.5 Antenna Requirement
