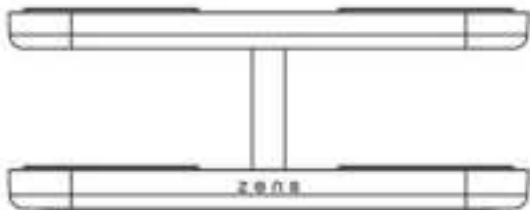

Compatibility

The four Qi2 charging pads work with all devices supporting Qi2, Qi, or MagSafe. The Quattro Charger Pro 4 works with most lightweight cases (< 3 mm). Cases with metal inside (e.g. magnets, bankcards, etc.) or a metal lining need to be removed before charging.

Use of the product

1. The 65W power adapter comes with four separate adapter plugs for type A (US), type C (EU), type G (UK) & Type I (ANZ). Adjust the power adapter by adding the applicable pin to the original power adapter before connecting it to a power outlet.
2. Connect the adapter DC connector to the product first, and then connect it to the AC power supply.
3. Put the Qi 2-supporting device into the charging area for charging

Important safety notices

- Keep the product away from water.
- Do not place or store the product near water or any other liquid.
- After cleaning, make sure the product is completely dry before you connect it to an electrical socket

Warning notifications

- Check if the voltage indicated on the power adaptor or power plug corresponds to the local voltage before you connect the adapter to a power outlet.
- Never use the charger, power adapter or power plug if any of them is damaged in any way.
- Only use the official power adapter and power plug (supplied together with the charger). When an unofficial power adapter is used or an incorrect voltage is used for the charger, the light will blink rapidly and no charging will occur.
- Do not place any metallic labels or any objects onto the charger.
- Do not use the charger outdoors or near heated surfaces.
- If you have a pacemaker or other implanted device, consult your doctor or the manufacturer of the implanted device before using the charger.
- Do not use with an extension cord or overload electrical outlets.
- Supervision is needed when used by or near children, disabled persons or those with mental disabilities.

Return policy / Zens warranty

In the unlikely event of failure during the warranty period Zens will arrange for your product to be serviced.

Warranty terms

The warranty begins on the date of purchase and expires after 24 months. If any defect due to faulty materials and/or workmanship occurs within the warranty period, Zens will arrange for service. Where a repair is not possible or is deemed uneconomical Zens may agree to replace the product. Replacement will be offered at Zens discretion, and the warranty will continue from the date of original purchase. The Zens warranty applies provided the product has been handled properly for its intended use and in accordance with the operating instructions.

The warranty does not cover for the loss consequent in nature, including but not limited to loss of data or loss of business. The Zens warranty does not apply if:

- The original proof of purchase (invoice) is missing.
- The purchase documents have been altered in any way or made illegible.
- The model- and/or serial number on the product has been altered, removed or made illegible.
- Repairs or product modifications and alterations have been carried out by unauthorized service organizations or persons.
