GENERAL INFORMATION

Product Description for Equipment under Test (EUT)

The *Guangde Ledup Enterprise Inc.*'s product, model number: 42R5-1501B1 (FCC ID: 2AEBHR51501B1) (or the "EUT") in this report was a *Remote Control*, which was measured approximately: 13.6 cm (L) x 5.0 cm (W) x2.5 cm (H), rated input voltage: DC 9V from battery.

Note: This product is a Remote Control, model 42R5-1501B2, 50R5-1501D2, 47R5-1501D2P, 35R5-1501B1P and 50R5-1501B1P are identical schematics with the model 42R5-1501B1. The only difference between them is their model number. Model 50R5-1501B1P was selected for fully testing, which was explained in the attached product similarity declaration letter.

*All measurement and test data in this report was gathered from production sample serial number: 1502020 (Assigned by BACL, Shenzhen). The EUT supplied by the applicant was received on 2015-02-05.

Objective

This test report is prepared on behalf of *Guangde Ledup Enterprise Inc.* All the test measurements were performed according to the measurement procedure described in ANSI C63.4-2009.

The tests were performed in order to determine compliance with FCC Part 15, Subpart C, section 15.203, 15.205, 15.209, 15.35(c) and 15.231 rules.

Test Methodology

All measurements contained in this report were conducted with ANSI C63.4 - 2009, American National Standard for Methods of Measurement of Radio-Noise Emissions from Low-Voltage Electrical and Electronic Equipment in the range of 9 kHz to 40 GHz. All radiated and conducted emissions measurement was performed at Bay Area Compliance Laboratories Corp. (Shenzhen). The radiated testing was performed at an antenna-to-EUT distance of 3 meters.

Measurement uncertainty with radiated emission is 5.91 dB for 30MHz-1GHz.and 4.92 dB for above 1GHz, 1.95dB for conducted measurement.

Test Facility

The Test site used by Bay Area Compliance Laboratories Corp. (Shenzhen) to collect test data is located on the 6/F, the 3rd Phase of WanLi Industrial Building, ShiHua Road, FuTian Free Trade Zone Shenzhen, Guangdong, China.

Test site at Bay Area Compliance Laboratories Corp. (Shenzhen) has been fully described in reports submitted to the Federal Communication Commission (FCC). The details of these reports have been found to be in compliance with the requirements of Section 2.948 of the FCC Rules on December 06, 2010. The facility also complies with the radiated and AC line conducted test site criteria set forth in ANSI C63.4-2009.



Measurement Uncertainty


All measurements involve certain levels of uncertainties, especially in field of EMC. The factors contributing to uncertainties are spectrum analyzer, cable loss, antenna factor calibration, antenna directivity, antenna factor variation with height, antenna phase center variation, antenna factor frequency interpolation, measurement distance variation, site imperfections, mismatch (average), and system repeatability.

Based on CISPR 16-4-2:2011, the expended combined standard uncertainty of radiation emissions at Bay Area Compliance Laboratories Corp. (Shenzhen) is 5.91 dB for 30MHz-1GHz.and 4.92 dB for above 1GHz, and it will not be taken into consideration for the test data recorded in the report.



Corrected Amplitude & Margin Calculation

The Corrected Amplitude is calculated by adding the Antenna Loss and Cable Loss, and subtracting the Amplifier Gain from the Meter Reading. The basic equation is as follows:

Corrected Amplitude = Meter Reading + Antenna Loss + Cable Loss - Amplifier Gain

The "Margin" column of the following data tables indicates the degree of compliance with the applicable limit. For example, a margin of 5.8 dB means the emission is 5.8 dB below the limit. The equation for margin calculation is as follows:

Margin = Limit –Corrected Amplitude

Test Results Summary

According to the data in the following table, the EUT complied with the FCC §15.205, §15.209, §15.231, the worst margin reading as below:

11.72 dB at 433.92 MHz in the Horizontal polarization

Refer to CISPR16-4-2:2011 and CISPR 16-4-1:2009, the measured level complies with the limit if

$$L_{\rm m} + U_{(L{\rm m})} \leq L_{\rm lim} + U_{\rm cispr}$$

In BACL, $U_{(Lm)}$ is less than + U_{cispr} , if L_m is less than L_{lim} , it implies that the EUT complies with the limit.






Duty Cycle 2





Per 15.231(c), The bandwidth of the emission shall be no wider than 0.25% of the center frequency for devices operating above 70 MHz and below 900 MHz. Bandwidth is determined at the points 20 dB down from the modulated carrier.



- 2. Set center frequency of spectrum analyzer=operating frequency.
- 3. Set the spectrum analyzer as RBW=100kHz, VBW=100kHz, Span=0Hz.
- 4. Repeat above procedures until all frequency measured was complete.




