FGM840RAAMD-4X-04 and FGM840RAAMD-0L-04 both use RTL8720DF chipset, share the same chipset baseline, same software and hardware design, the primary difference lies in the antenna pedestal. FGM840RAAMD-4X-04 use IPEX antenna port, FGM840RAAMD-0L-04 use LCC pad port, Distinguish by changing the position of one resistor. Based on the differences, main test FGM840RAAMD-0L-04(R1.0) version, FGM840RAAMD-4X-04(R1.1) version Check worse mode RSE, only the worst data is presented in the report.
- FGM840R has three antenna, respectively: Y4RYM0MA0AA/Y4RYM0MA0BA/Y4RYM0MA0CA. Y4RYM0MA0AA, Y4RYM0MA0BA, Y4RYM0MA0CA both are FPC + 1.13 + IpeX-1 antenna. Among them, Y4RYM0MA0CA is the mirror version of Y4RYM0MA0AA, and Y4RYM0MA0BA is the version where Y4RYM0MA0AA modifies the line length. Pre-scan was done on the above antennas, measurements were demonstrated by using the antenna with the highest gain as the worst case scenarios.

- The only difference between the two models is that L15C1 comes with a printer and L15D1 does not come with a printer, everything else is exactly the same. Based on the above differences, complete testing will be conducted for L15C1 model, while L15D1 model will only check EMC.

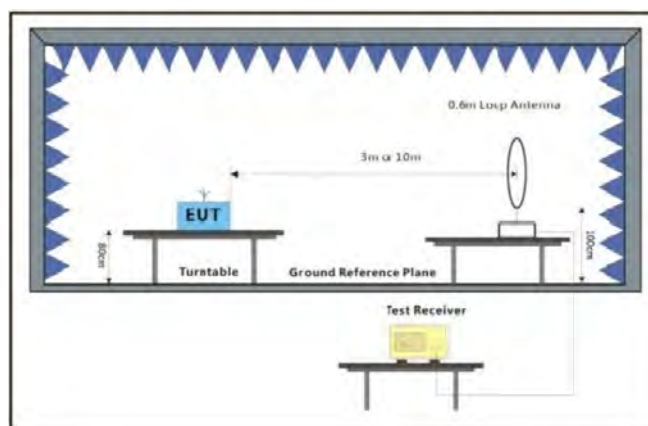


Figure 1. 9kHz to 30MHz

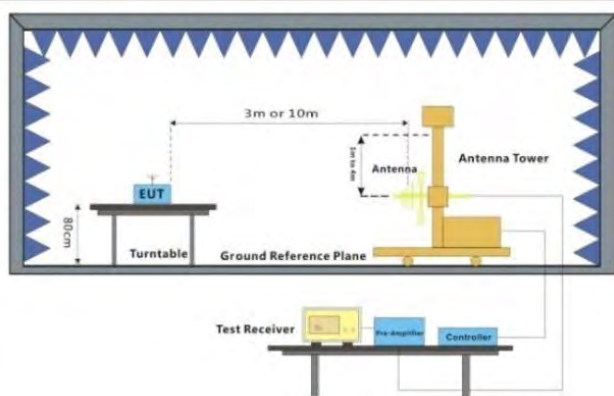


Figure 1. 30MHz to 1GHz

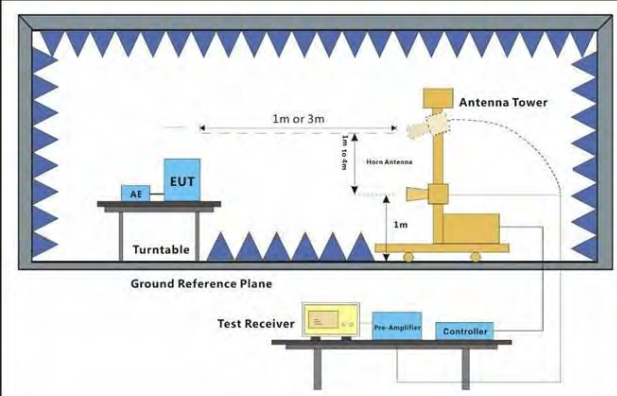


Figure 2. Above 1 GHz
