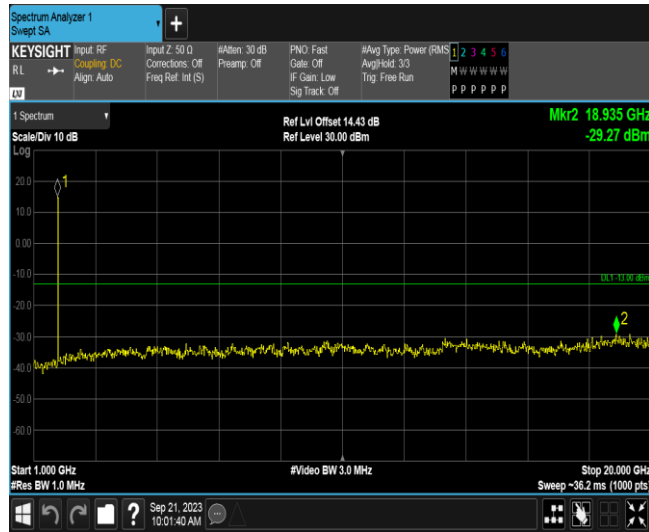

Band4-15MHz-16QAM-20325-1RB#0-Range1:30~1000MHz

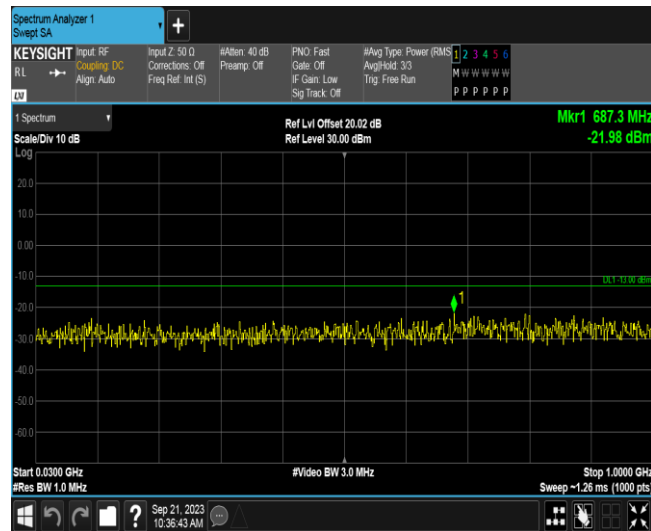


Band4-15MHz-16QAM-20325-1RB#0-Range2:1000~20000MHz

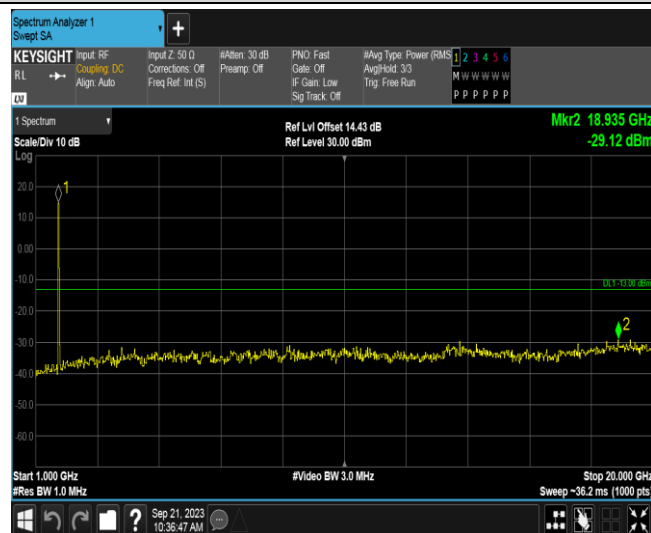
