Operation

- 1.) Select color temperature by adjusting the switch on the bulb
- 2700K Soft White: recommended for relaxing environments, like bedrooms. Recommended as a replacement for incandescent light bulbs.
- ◆ 3000K Bright White: recommended as a direct replacement for halogen bulbs to match color temperature. Recommended for relaxing environments.
- ◆ 3500K True White: appears brighter than 2700K and 3000K. Recommended for any setting.
- ◆ 4000K: recommended as a direct replacement for fluorescent bulbs. Recommended as task lighting.
- ◆ 5000K: Bright light that mimics daylight. Recommended for task environments, like bathrooms, kitchens, garages, etc. 5000K is also recommended for rooms that don't receive much natural light.
- 6500K: The brightest color temperature that appears very lightly blue. Also recommended for task areas.
- 2.) Select motion sensor setting by adjusting the switch
- ◆ Motion On: this setting will enable the motion sensor to turn on anytime it senses motion.
- ◆ Motion On and Dusk to Dawn: this setting will enable the motion sensor to only detect motion and turn on in the dark. This is the recommended setting so the bulb does not turn on when there is motion during the day.
- ♦ Motion and Dusk to Dawn off: this setting will turn off the sensors. If on this setting, the bulb can be used as regular bulb and will not detect motion.
- 3.)Turn power off to fixture
- 4.) Install light bulb
- 5.) Turn power on to light fixture
- 6.) After 30 seconds, light bulb will be controlled by enclosed motion sensor
- Bulb will turn on when motion is detected.
- ◆ Bulb will stay on for 2 minutes after motion is not detected.
- 7.) Power must always be supplied to the fixture for the bulb to work properly

Tips for best performance:

- For best performance, install light bulb facing downwards in fixture that is 9ft. High.
- The lower the height of the bulb, the shorter the detection range.
- The bulb can be installed on its side. Detection range may vary depending on ceiling height and direction bulb is facing.
- Some metal fixtures may impact motion sensor performance
- Compatible with most LED rated dimmers.

Notes:

- Motion sensor detects motion within 10ft range at 120-degree angle when installed facing downwards from 9ft. height
- Recommended applications: driveway, hallway, staircase, porch, closet
- Motion sensor bulb is equipped with a microwave sensor. It may detect motion through walls.
- Please select color temperature and motion sensor setting with power off.
