2. Antenna requirement

Test Requirement:

The antenna is a **PCB Antenna** which permanently attached, and the best case gain of the antenna is **1.9 dBi** . It complies with the standard requirement.



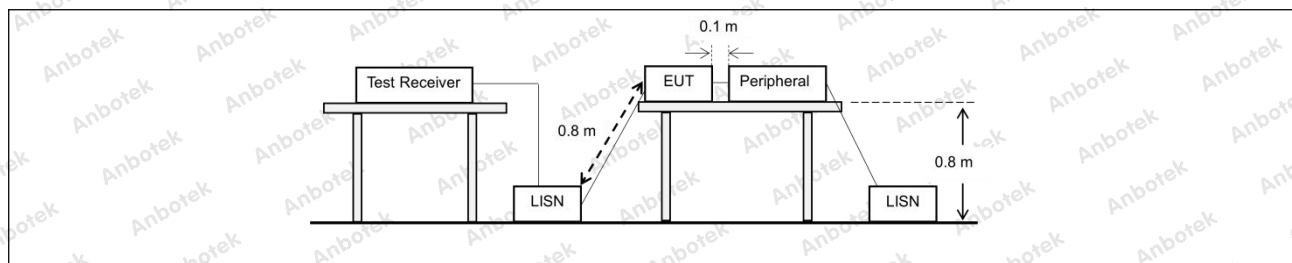

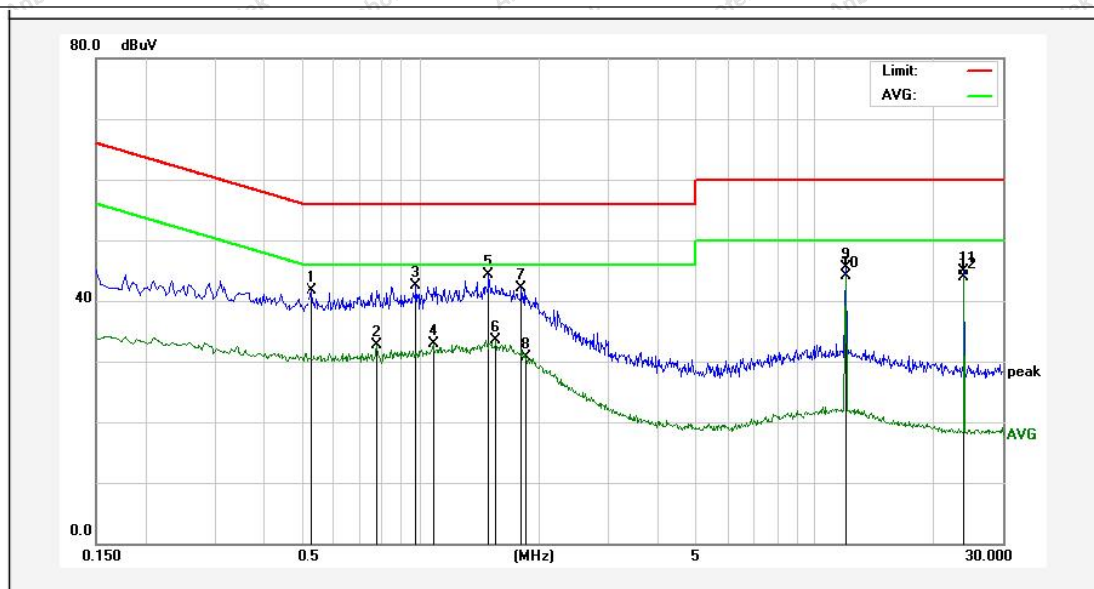

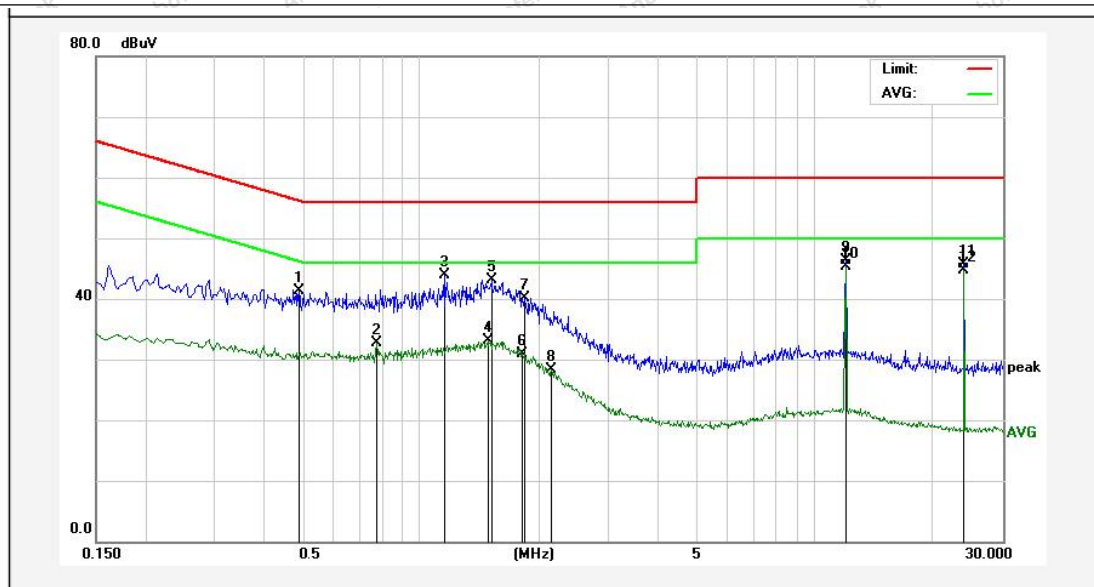

4. Occupied Bandwidth

Test Requirement:	47 CFR 15.215(c)

The following procedure shall be used for measuring 99% power bandwidth: - The instrument center frequency is set to the nominal EUT channel center frequency. To determine the number of hops on a channel in the regulatory observation period repeat the measurement using a longer sweep time. When the device uses a single hopping sequence the period of measurement should be sufficient to capture at least 2 hops. When the device uses a dynamic hopping sequence, or the sequence varies, the period of measurement may need to capture multiple hops to better determine the average time of occupancy.
