E (V/m)=(30*P*G)^{0.5}/d Power Density: Pd(W/m²)=E²/377 E=Electric Field (V/m) P=Peak RF output Power (W) G=EUT Antenna numeric gain (numeric) d= Separation distance between radiator and human body (m) The formula can be changed to Pd= (30*P*G)/(377*d²) From the peak EUT RF output power, the minimum mobile separation distance, d=0.2m, as well as the gain of the used antenna, the RF power density can be obtained.
