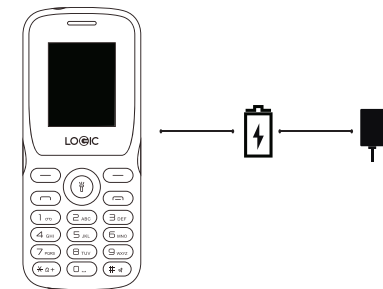

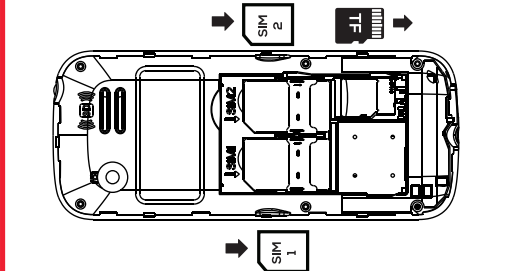

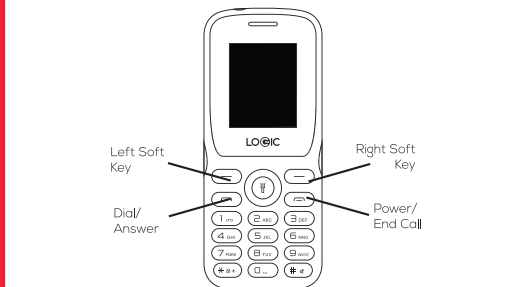

Return the phone upside down, put finger to slide from SD slot to remove Card.

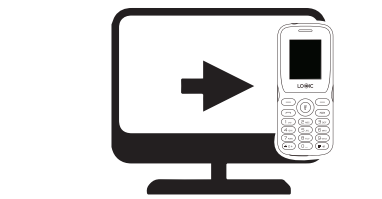

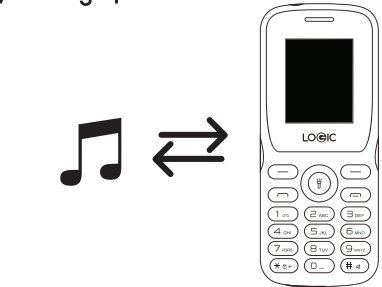

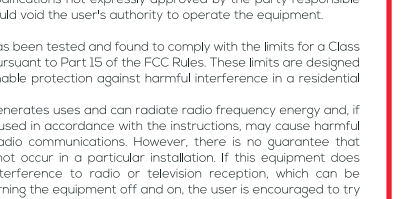

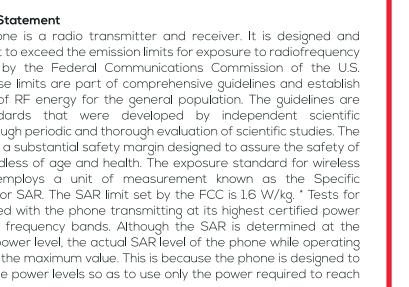
