## **SAR Evaluation**

## **RF Exposure Compliance Requirement**

### 5.1.1 Standard Requirement

According to KDB447498D01 General RF Exposure Guidance v06

4.3.1. Standalone SAR test exclusion considerations

Unless specifically required by the published RF exposure KDB procedures, standalone 1-q head or body and 10-g extremity SAR evaluation for general population exposure conditions, by measurement or numerical simulation, is not required when the corresponding SAR Exclusion Threshold condition, listed below, is satisfied.

#### **5.1.2 Limits**

The 1-g and 10-g SAR test exclusion thresholds for 100 MHz to 6 GHz at test separation distances ≤ 50 mm are determined by:

[(max. power of channel, including tune-up tolerance, mW)/(min. test separation distance, mm)] ·  $[\sqrt{f}(GHz)] \le 3.0$  for 1-g SAR and  $\le 7.5$  for 10-g extremity SAR, where

f(GHz) is the RF channel transmit frequency in GHz

Power and distance are rounded to the nearest mW and mm before calculation<sup>17</sup>

The result is rounded to one decimal place for comparison

The test exclusions are applicable only when the minimum test separation distance is ≤ 50 mm and for transmission frequencies between 100 MHz and 6 GHz. When the minimum test separation distance is < 5 mm, a distance of 5 mm is applied to determine SAR test exclusion

### 5.1.3 EUT RF Exposure

The Max. power (including tune-up tolerance) is 2.92 dBm on the lowest channel 2.402 GHz (\*) 2.92 dBm logarithmic terms convert to numeric result is nearly 1.96 mW

According to the formula. calculate the test exclusion thresholds:

#### 2.4GHz RF:

The Max. power (including tune-up tolerance) is -16.7 dBm on the lowest channel 2.402 GHz (\*) -16.70 dBm logarithmic terms convert to numeric result is nearly 0.02 mW

According to the formula. calculate the test exclusion thresholds:

General RF Exposure =  $\frac{\text{Max.Power of channel, including tune} - \text{up tolerance, mW}}{\text{Max.Power of channel, including tune}}$  $(min.test\ separation\ distance,mm)*\sqrt{f\ (GHz)}$ 

General RF Exposure =  $(0.02 \text{ mW} / 5 \text{ mm}) \times \sqrt{2.402 \text{ GHz}} = 0.01$ 

SAR requirement:

S = 3.0(2)

#### Simultaneous Transmit:

According to the following to determine the simultaneous transmission SAR test exclusion criteria:

[(max. power of channel, including tune-up tolerance, mW) / (min. test separation distance, mm)]·[√f(GHz)/x] W/kg, for test separation distances ≤ 50 mm;

where x = 7.5 for 1-g SAR and x = 18.75 for 10-g SAR

simultaneous transmission SAR test exclusion =  $(1.96 / 5) \times (\sqrt{2.402 / 7.5}) + (0.02 / 5) \times (\sqrt{2.402 / 7.5})$ = 0.082 W/Kg < 1.6 W/Kg
