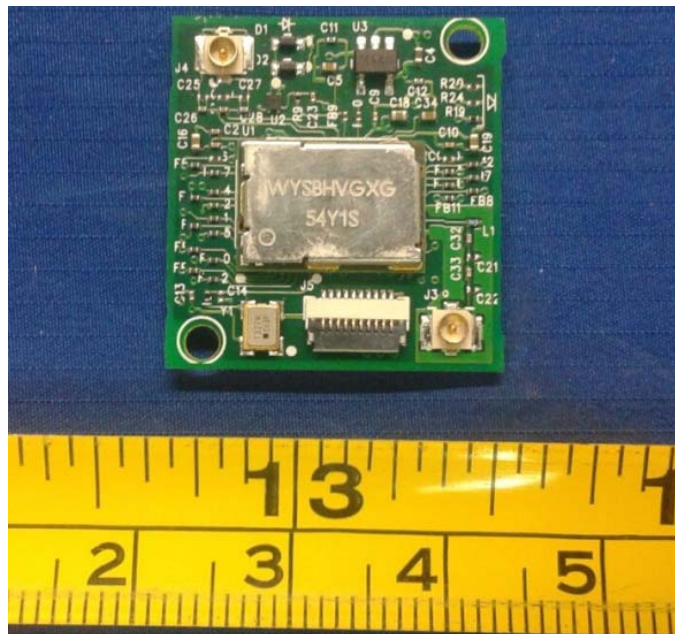

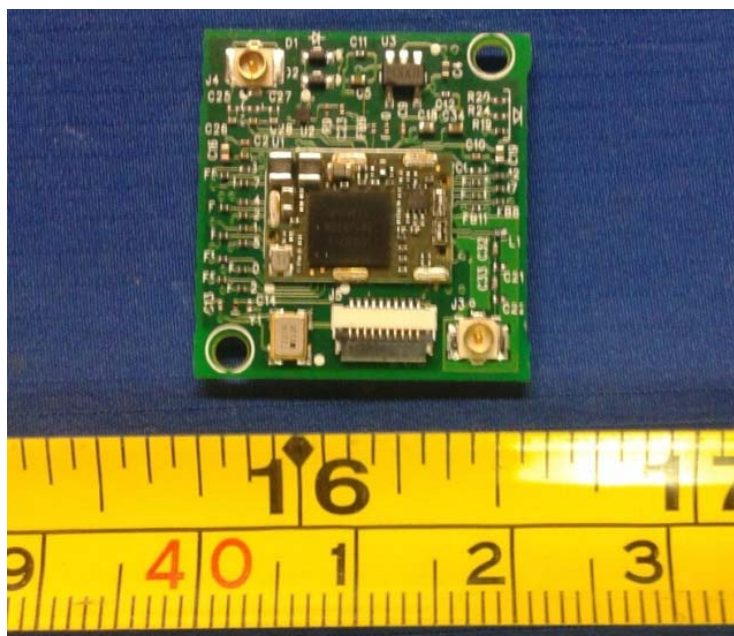

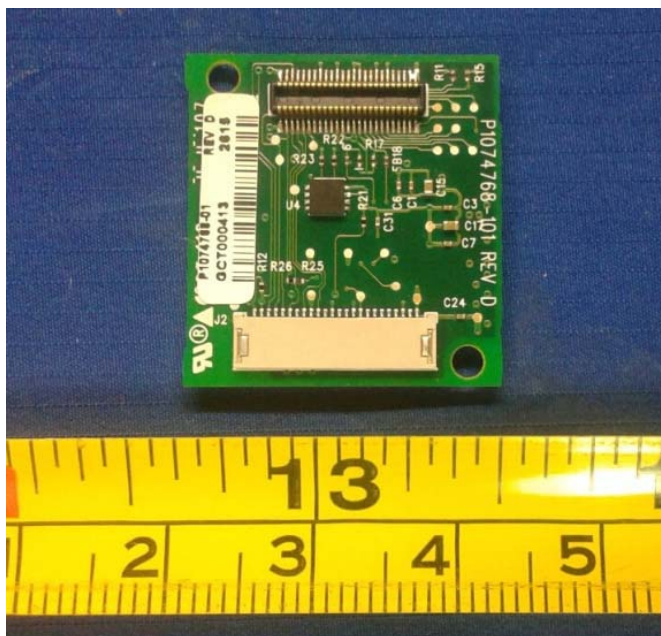

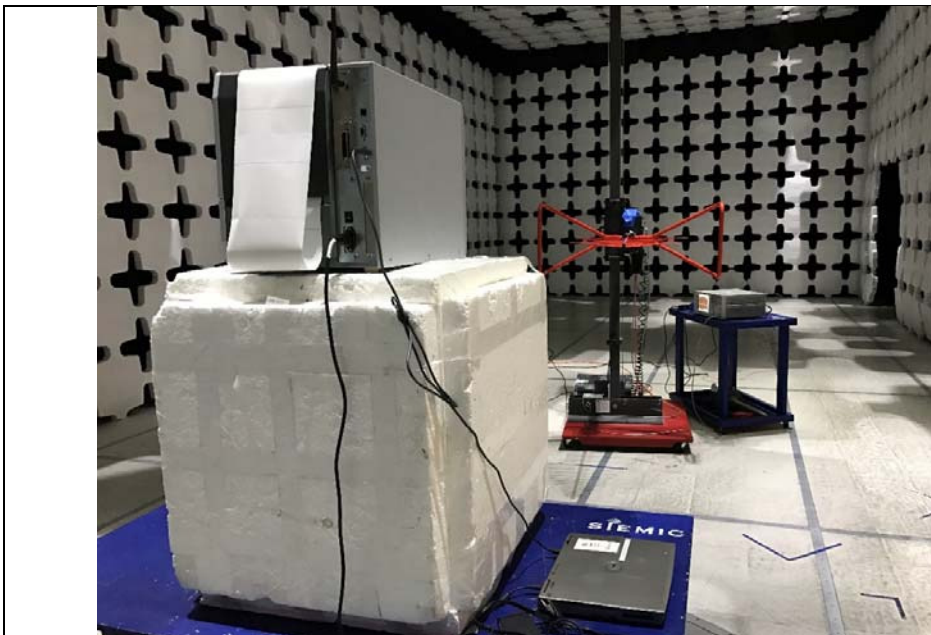


EUT Radio without Shielding Top View

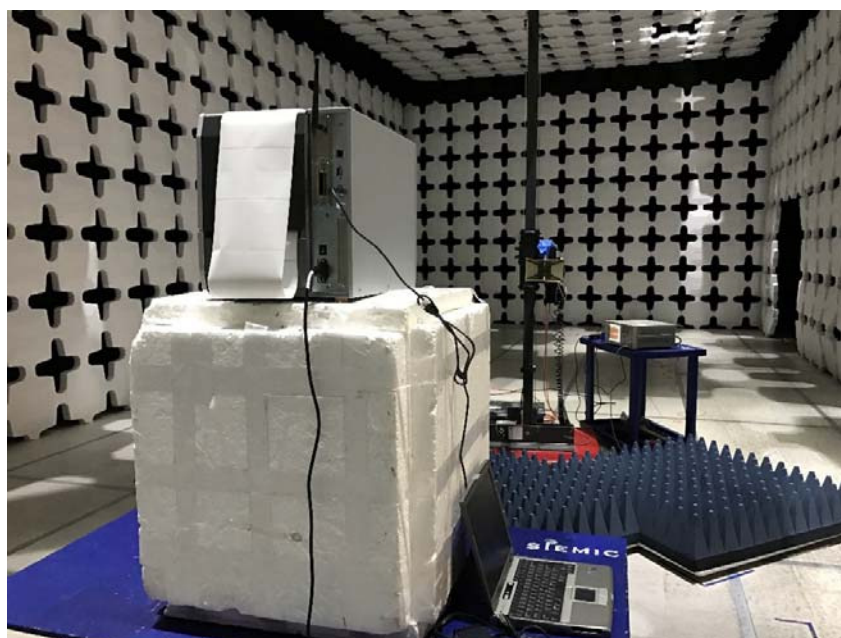
