

USA Designated Local Agent Service Agreement

This Agreement, dated 06/02/2023, is made between Iconsigh Inc. and Shenzhen Lechong Technology Co., Ltd.

The Parties mutually agree as follows:

1. Iconsigh Inc. agrees to act as U.S agent for service of process on behalf of Shenzhen Lechong Technology Co., Ltd for the purposes of acting as the applicant's agent for service of FCC equipment certification. An agent for service of process holds the obligation to accept the service of process and other documents on behalf of the party chiefly responsible, and to swiftly and dutifully deliver them to that party. Service of process includes, but is not limited to, delivery of any correspondence, notices, orders, decisions, and requirements of administrative, legal, or judicial process related to Commission proceedings.
2. Shenzhen Lechong Technology Co., Ltd agrees to pay Iconsigh Inc. the service fees of US\$500.00 per FCC equipment certification application filing (One ID) per year or part thereof, beginning from the date of approval for the equipment authorization grant.
3. This agreement is valid for a period of one (1) year and applies to one FCC equipment certification application filing during that term. Each term shall automatically renew for subsequent periods of the same length as the initial term unless either party gives the other written notice of termination at least thirty (30) days prior to the expiration of the current term. This agreement must remain in effect for no less than one (1) year after the Applicant has terminated all marketing and importing of the associated certified equipment within the United States or the conclusion of any Commission-related administrative or judicial proceeding involving the equipment, whichever is later. Service is deemed to be completed when the document is sent to the U.S physical address, or email address of the U.S-based agent for service of process.
4. Shenzhen Lechong Technology Co., Ltd shall advise Iconsigh Inc. on all relevant FCC equipment certification changes for the single FCC equipment certification above. Applicant has a continuing obligation to ensure that Iconsigh Inc. has accurate contact information for the Applicant and to notify Iconsigh Inc. of any changes to the contact information herein.
5. Iconsigh Inc. agrees to keep Shenzhen Lechong Technology Co., Ltd advised on all applicable FCC requirements concerning the certified equipment's compliance in the United States in order to engage in relevant inquiries, determine compliance, or enforce the Commission's rules where appropriate.
