2.5 Description of Test conditions

(1) E.U.T. test conditions:

For intentional radiators, measurements of the variation of the input power or the adiated signal level of the fundamental frequency component of the emission, as appropriate, shall be performed with the supply voltage varied between 85% and 115% of the nominal rated supply voltage. For battery operated equipment, the equipment tests shall be performed using a new battery.

- (2) Frequency range of radiated measurements: The test range will be up to the tenth harmonic of the highest fundamental frequency.
- (3) Pre-test the EUT in all transmitting mode at the lowest (2403.85 MHz), middle (2441.85 MHz)

and highest (2479.85 MHz) channel with different data packet and conducted to determine the worst-case mode,

only the worst-case results are recorded in this report.


(4) The EUT was programmed to be in continuously transmitting mode and the transmit duty cycle is not less than 98%.


For intentional device, according to FCC 47 CFR Section 15.203, an intentional radiator shall be designed to ensure that no antenna other than that furnished by the responsible party shall be used with the device. And according to FCC 47 CFR Section 15.247, if transmitting antennas of directional gain greater than 6dBi are used, the power shall be reduced by the amount in dB that the directional gain of the antenna exceeds 6dBi.

Refer to statement below for compliance.

The manufacturer may design the unit so that the user can replace a broken antenna, but the use of a standard antenna jack or electrical connector is prohibited. Further, this requirement does not apply to intentional radiators that must be professionally installed.

Antenna Connected Construction

The antenna used in this product is a PCB Antenna, The directional gains of antenna used for transmitting is 0dBi.



Test procedure

- 1. The equipment was set up as per the test configuration to simulate typical actual usage per the user's manual. The EUT is a tabletop system; a wooden table with a height of 0.8 meters is used and is placed on the ground plane as per ANSI C63.10:2013.
- 2. Support equipment, if needed, was placed as per ANSI C63.10:2013
- 3. All I/O cables were positioned to simulate typical actual usage as per ANSI C63.10:2013.
- 4. The adapter received AC120V/60Hz power through a Line Impedance Stabilization Network (LISN) which supplied power source and was grounded to the ground plane.
- 5. All support equipments received AC power from a second LISN, if any.
- 6. The EUT test program was started. Emissions were measured on each current carrying line of the EUT using a spectrum Analyzer / Receiver connected to the LISN powering the EUT. The LISN has two monitoring points: Line 1 (Hot Side) and Line 2 (Neutral Side). Two scans were taken: one with Line 1 connected to Analyzer / Receiver and Line 2 connected to a 50 ohm load; the second scan had Line 1 connected to a 50 ohm load and Line 2 connected to the Analyzer / Receiver.
- 7. Analyzer / Receiver scanned from 150 KHz to 30MHz for emissions in each of the test modes.
- 8. During the above scans, the emissions were maximized by cable manipulation.






9 kHz to 30 MHz emissions:

Test Procedure

Below 1G: The EUT was placed on the top of a rotating table 0.8 meters above the ground at a 3 meter semi-anechoic camber. The table was rotated 360 degrees to determine the position of the highest radiation.
 Above 1G: The EUT was placed on the top of a rotating table 1.5 meters above the ground at a 3 meter semi-anechoic camber. The table was rotated 360 degrees to determine the position of the highest radiation.

Note: For the radiated emission test above 1GHz:Place the measurement antenna away from each area of the EUT determined to be a source of emissions at the specified measurement distance, while keeping the measurement antenna aimed at the source of emissions at each frequency of significant emissions, with polarization oriented for maximum response. The measurement antenna may have to be higher or lower than the EUT, depending on the radiation pattern of the emission and staying aimed at the emission source for receiving the maximum signal. The final measurement antenna elevation shall be that which maximizes the emissions. The measurement antenna elevation shall be restricted to a range of heights of from 1 m to 4 m above the ground or reference ground plane.

The EUT was set 3 meters away from the interference-receiving antenna, which was mounted on the top of a variable-height antenna tower.

The antenna height is varied from one meter to four meters above the ground to determine the maximum value of the field strength. Both horizontal and vertical polarizations of the antenna are set to make the measurement.

For each suspected emission, the EUT was arranged to its worst case and then the antenna was tuned to heights from 1 meter to 4 meters (for the test frequency of below 30MHz, the antenna was tuned to heights 1 meter) and the rotatable table was turned from 0 degrees to 360 degrees to find the maximum reading.

The test-receiver system was set to Peak Detect Function and Specified Bandwidth with Maximum Hold Mode.

If the emission level of the EUT in peak mode was 10dB lower than the limit specified, then testing could be stopped and the peak values of the EUT would be reported. Otherwise the emissions that did not have 10dB margin would be re-tested one by one using peak, quasi-peak or average method as specified and then reported in a data sheet.

Test the EUT in the lowest channel, the middle channel, the Highest channel


The radiation measurements are performed in X, Y, Z axis positioning for Transmitting mode, and found the X axis positioning which it is the worst case.Repeat above procedures until all frequencies measured was complete.

<u>Test Result</u>

Remark:

- 1. Radiated Emission measured at GFSK low/middle/high channel from 9 KHz to 10th harmonic of fundamental and recorded worst case at Low channel
- 2. Radiated emission test from 9KHz to 10th harmonic of fundamental was verified, and no emission found except system noise floor (more than 20dB below the limit) in 9KHz to 30MHz and not recorded in this report.
- 3. For below 1GHz testing recorded worst at Low channel.





3.5 Power Spectral Density

<u>Limit</u>

For digitally modulated systems, the power spectral density conducted from the intentional radiator to the antenna shall not be greater than 8 dBm in any 3 kHz band during any time interval of continuous transmission.

Test Procedure

Use this procedure when the maximum peak conducted output power in the fundamental emission is used to demonstrate compliance. Set the RBW =3 kHz.

Set the VBW =10 KHz. Set the span to 1.5 times the DTS channel bandwidth. Detector = peak. Sweep time = auto couple. Trace mode = max hold. Allow trace to fully stabilize. Use the peak marker function to determine the maximum power level. If measured value exceeds limit, reduce RBW(no less than 3 kHz)and repeat. The resulting peak PSD level must be 8 dBm.



3.6 6dB Bandwidth

<u>Limit</u>

For digital modulation systems, the minimum 6 dB bandwidth shall be at least 500 kHz.

Test procedure

The transmitter output was connected to the spectrum analyzer through an attenuator. The bandwidth of the fundamental frequency was measured by spectrum analyzer with RBW=100 KHz and VBW=300KHz. The 6dB bandwidth is defined as the total spectrum the power of which is higher than peak power minus 6dB.

- 1. Set RBW = 100 kHz.
- 2. Set the video bandwidth (VBW) \geq 3 RBW.
- 3. Detector = Peak.
- 4. Trace mode = max hold.
- 5. Sweep = auto couple.
- 6. Allow the trace to stabilize.

7. Measure the maximum width of the emission that is constrained by the frequencies associated with the two outermost amplitude points (upper and lower frequencies) that are attenuated by 6 dB relative to the maximum level measured in the fundamental emission.






Radiated Emissions: Above 1000MHz
