


X axis, Y axis, Z axis positions:



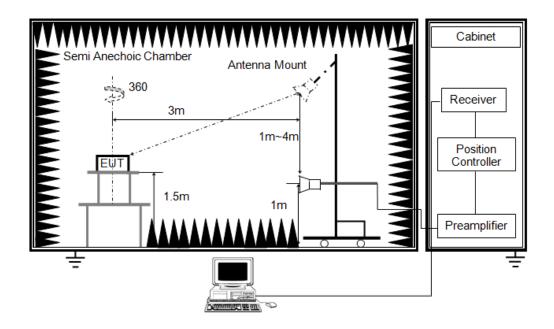

The power line of the EUT is connected to the AC mains through a Artificial Mains Network (A.M.N.).
