

## 一、保修服务方式

### 2. 产品检测与维修服务

若用户遇到的问题无法通过上述描写的技术支持服务方式解决，可以将快递至销售平台提供的售后服务中心，由工程师对其进行检测与维修服务。

- A. 用户请在送修存储设备的资料先自行备份，我们电脑仅负责的检测和维修，对于送修过程中因任何因素造成的造成资料遗失，本公司不予负责，请理解支持！
- B. 对于已经超过免费维修范围的电脑，我们将按照规定收取相关检测及维修费用。
- C. 超过免费保修期的电脑，经过工程师检测后因故不同意维修的，用户需支付检测费用。

注：无论您通过何种方式来寻求技术支持服务，请明确告知使用的产品型号、产品序列号、购买的所在平台、购买时间、详细的故障现象等，以便于厂家、工程师能更加准确快速判断出故障的原因。

## 二、三包凭证说明

1. ‘七日’ 规定：产品自您收到商品的次日起（遇到法定节假日顺延，包括双休日）七天内，发生性能故障，消费者可以选择退货、换货或维修。
2. ‘十五’ 规定：产品自售出之日起15日内，发生性能故障，消费者可以选择换货或维修。
