Description



1. Long press to power on/off/restart/factory reset, short press to return to home screen and main menu function.

2. Swipe up on the control interface and slide down to send notifications. Swipe right/left shortcuts


3. Press and hold the watch face for 3 seconds to switch watch faces.

Download and install the program

1. Scan the QR code or visit the app store to download the "Infowear" app, download it and follow the prompts to install the program. Operating system: for iphone 12.0 and Android 8.0 or later.



2. Bind a linked watch: Open the watch background program "Infowear", click Bind Device on the device interface, and select the relevant model of watch. Click the link and select the confirmation link on the watch. After success, the Wireless docking request will pop up, select Allow access to the address book and call history (after this is turned on, the incoming call will be displayed with a note), and then select Pairing, and the binding is successful




Note: As shown in the picture above, if the connection is not successful. 1. You can restart the watch, or exit Infowear, reopen the background and add the device connection again (you can also uninstall and install Infowear again). 2. If there is no prompt in Figure 4, open the control interface on the watch side, click the phone icon to turn blue and rebind again

GPS Positioning:

 GPS start: after binding, immediately disconnect the Wireless, do not synchronize AGPS, and then enter outdoor running, walking, outdoor cycling and other outdoor sports, the first positioning is cold start (time 1~2 minutes), after success, wait for 3-5 minutes and then exit the sport, and each time you enter the sport after exiting it is a hot start;
AGPS start: bind the watch, enter the APP --- device---- more settings--- update AGPS data, click to update AGPS data, wait for the AGPS update to be completed, enter the outdoor multi-sport, wait for 3-5 minutes to exit the sport, and each time you enter the sport after exiting, it is a hot start;



Automatic Motion Detection: Function overview: When this feature is enabled, you will be reminded to select the corresponding sport mode when you exercise

Exercise Data:

Display the number of steps, distance, and calories recorded on the day, and you can set the target number of steps, distance, and calories in the app

Heart rate:

When entering the heart rate measurement interface, there will be a vibration reminder when the measurement is completed in about 45 seconds, and if it prompts "not wearing the watch", you need to put the watch on again

Sleep:

Display the sleep of the day & the sleep monitoring status of the last seven days (swipe up to see), the data is updated every day, and the data can be saved synchronously when the APP is connected, and the device will recalculate the data information of the new day. Sleep monitoring time: 21:30-12:00



Weather:

You can turn on the weather push in the background program, and the watch can update the weather details of the day after it is turned on.



Motion:

Sports mode options: 8+1 kinds, (yoga as a pushable replacement exercise), click the icon to start exercising, you can support 110+ kinds of sports push on the APP

Make/receive calls, call reminders/reject calls: After binding the audio link normally, you can dial, answer, and reject calls on the watch (only the function of rejecting calls is available when the audio is not bound or the function is turned off)



After the corresponding information reminder is enabled in the background, the watch can display the information notification of the last 14 days. Swipe left to delete the corresponding information

Stopwatch, calculator, alarm clock, timer, female menstrual cycle, find watch, find phone, sedentary reminder, drink water reminder, etc.

Watch Charging & Activation

Align the magnetic charging cable with the metal electrocution of the charging port until the charging indication appears on the watch screen, when the watch prompts low power, please charge it in time, the device belongs to an all-in-one machine, the back case and battery are not removable. Important note: The watch needs to be charged at the USB charging port within 5V--1A



frequently asked questions

- 1. The watch won't turn on
 - 1. Please press and hold the power button for more than 3 seconds
 - 2. The watch will automatically turn on after a long charging time.
- 2. The watch does not charge
 - 1. You can replace the charging head for testing, or plug in the computer USB for testing
 - 2. In the case of damage to the data cable, it will also not be charged or charged slowly

3. When the battery is seriously depleted, you need to charge it for 10-40 minutes and then press the power button to see if it is turned on and charged

- 3. Wireless is not connected or cannot be connected
 - 1. Please try to restart the watch/APP and reconnect it
 - 2. Please try to restart your phone or connect it again after Wireless on your phone
 - 3. Do not connect your phone to other Wireless devices at the same time
- 4. There is no notification information on the watch
 - 1. APP the relevant program information in the message reminder is enabled
 - 2. Message reminders are enabled in the relevant program settings
 - 3. The drop-down notification menu on the mobile phone needs to be turned on

1. The rated input voltage and current of this device is 5V1A, it is strictly forbidden to use chargers above 5V (9V12V, etc.), if you use the charger of the above specifications, the smartwatch will have a charging failure, please note.

3. No vibration is normal when the battery is low, and the vibration returns to normal after recharging more than 20%.
