3. TEST METHODOLOGY

The tests documented in this report were performed in accordance with ANSI C63.4.

(Version :2003) Radiated testing was performed at an antenna to EUT distance 3 meters.

3.1 EUT CONFIGURATION

The EUT configuration for testing is installed on RF field strength measurement to meet the

Commissions requirement and operating in a manner that intends to maximize its emission

characteristics in a continuous normal application.

3.2 EUT EXERCISE

The EUT was operated in the engineering mode to fix the Tx frequency that was for the purpose of

Peak Power (CH High)





7.2 PEAK POWER SPECTRAL DENSITY






Test Plot PPSD (CH Low)



7.3 BAND EDGES MEASUREMENT

Test Plot 20 dB bandwidth





Test Plot Channel Number 2.4 GHz – 2.4835 GHz




Test Plot CH Low






Below 30 MHz

7.8 POWERLINE CONDUCTED EMISSIONS

LIMIT

For an intentional radiator which is designed to be connected to the public utility (AC) power line, the radio frequency voltage that is conducted back onto the AC power line on any frequency or frequencies within the band 150 kHz to 30 MHz shall not exceed 250 microvolts (The limit decreases linearly with the logarithm of the frequency in the range 0.15 MHz to 0.50 MHz). 




