Thank you for purchasing the Click & Go™ Wireless Phone Camera Remote. Use it to remotely activate your smartphone's front or rear camera for still photos or video.

Before using your Click & Go™ Wireless Phone Camera Remote for the first time, please read these instructions carefully.

### Important safety information

This device uses a disposable battery. Improper use of batteries can result in corrosive fluid release, overheating or explosion. Battery fluid is both toxic

and corrosive and can cause burns. To reduce risk of injury, keep batteries out of reach of children. Do not open or puncture batteries. Do not incinerate or heat batteries, and keep them out of hot places. Batteries need to be disposed or recycled in accordance with local laws. To recycle used batteries, contact your local hazardous waste processor, or contact Call2Recycle (website call2recycle.org, phone 877.273.2925) to find the nearest drop-off location for expired batteries. If a battery leaks inside the battery compartment, carefully remove all batteries and clean the battery compartment with a damp paper towel, taking care to not contact skin with the battery fluid. If battery fluid comes into contact with skin. flush with water immediately.

## Other precautions

This product is not a toy. Keep the Click & Go™ Wireless Phone Camera Remote away from children. Do not drop or toss the camera remote or use excessive force when operating it.

This product is not waterproof and should not be used around water or in areas with excessive moisture.

Keep the camera remote away from excessive heat or cold. Avoid operating or storing the camera remote near fire, on stoves, or inside sealed cars in hot weather. Note Operation of the Click & Go™ Wireless Phone Camera Remote does not require an app download. The remote is operational once it is paired with your phone.

## Replacing the battery

The Click & Go™ Wireless Phone Camera Remote requires one "CR2032" battery which is pre-installed and should last approximately one year. To replace the battery, first use a small screwdriver to remove the cover from the battery compartment. Then replace the battery, taking care to maintain the same orientation. Replace the battery compartment cover.

### **Pairing**

Before using, you must first pair the Click & Go™ Wireless Phone Camera Remote to your phone.

To pair the remote to your phone, turn Bluetooth® on your phone or tablet. To activate searching mode, press the button on Click & Go™ shutter for 3 seconds until the indicator light is flashing. Choose "Click&Go" from the list and press "pair." Turn on the camera app on your phone or tablet. If the pairing is lost, repeat this procedure.

iPhone 6 Plus, iPhone 6, iPhone 5S, iPhone 5C, iPhone 5, iPhone 4S, iPhone 4S, iPhone 4I, iPad mini, iPad Air, iPad (4th generation), iPad (3rd generation), iPad 2, iPod touch (5th and 4th generation. Requires iOS 6.0 or later: Click & Go™ works with the following Android devices:

Samsung Galaxy S 5, S 4, and S III, Galaxy Note 3, 2, Tab 2, Note 8.0, and Note 10.1, Google Nexus 4, 5, 6, 7, 9, and 10. Requires Android 4.1 or later. Click & Go™ may not be compatible with any other Samsung or Android devices.

### Operation

To use the Click & Go™ Wireless Phone Camera Remote, position your phone where you want to take pictures from. You may want to use a portable tripod to stabilize your phone to minimize the risk of damage.

Now get into the picture! When you and your fellow camera subjects are ready, press the button on Click & Go™ Wireless Phone Camera Remote. The captured image will be stored on your phone where camera images are normally stored. You can remotely capture as many pictures as your phone's memory allows.

When using movie-capture apps, pressing the remote button will begin video capture. Pressing it again will end capture and save the video segment.

The Click & Go™ Wireless Phone Camera Remote can be used up to 30 feet (10m) from the phone, but radio interference, walls, windows and other obstacles may reduce that distance.

# **Troubleshooting tips**

 The Click & Go<sup>™</sup> Wireless Phone Camera Remote will go to sleep after 90 sec if there is no connection. Once it is paired correctly, the device will sleep after 2 minutes without any action. When it is in sleep mode, press any key to wake up the device.
