

To investigate the maximum EMI emission characteristics generates from EUT, the test system was pre-scanning tested base on the consideration of following EUT operation mode or test configuration mode which possible have effect on EMI emission level. (1) For all test, we have verified the construction and function in typical operation. And all the test modes were carried out with the EUT in transmitting operation in maximum power with all kinds of data rate.

According to ANSI C63.10 standards, the measurements are performed at the highest, middle, lowest available channels, and the worst case data rate as follows:

BLE Mode: GFSK Modulation Transmitting mode.

- (2) During the testing procedure, the continuously transmitting with the maximum power mode was programmed by the customer.
- (3) The EUT is considered a Mobile unit; in normal use it was positioned on X-plane. The worst case was found positioned on X-plane. Therefore only the test data of this X-plane was used for radiated emission measurement test.

1.6 Description of Test Software Setting

During testing channel& Power controlling software provided by the customer was used to control the operating channel as well as the output power level. The RF output power selection is for the setting of RF output power expected by the customer and is going to be fixed on the firmware of the final end product power parameters of RF setting.


Radiated measurement

Below 1000MHz Test Setup




Above 1GHz Test Setup
