



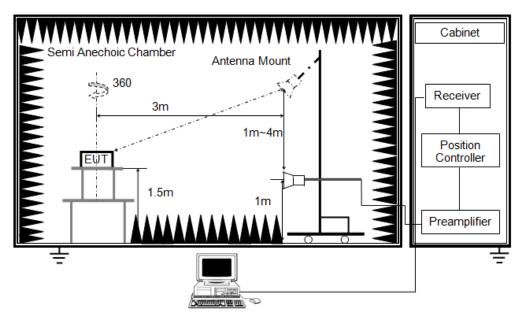
X axis, Y axis, Z axis positions:

Occupied Channel Bandwidth




Maximum Power Spectral Density Level






