The antenna is a FPC antenna which permanently attached, and the best case gain of the antenna is 3.7dBi for module MT6631, 3.13dBi for module RTL8811. It complies with the standard requirement.



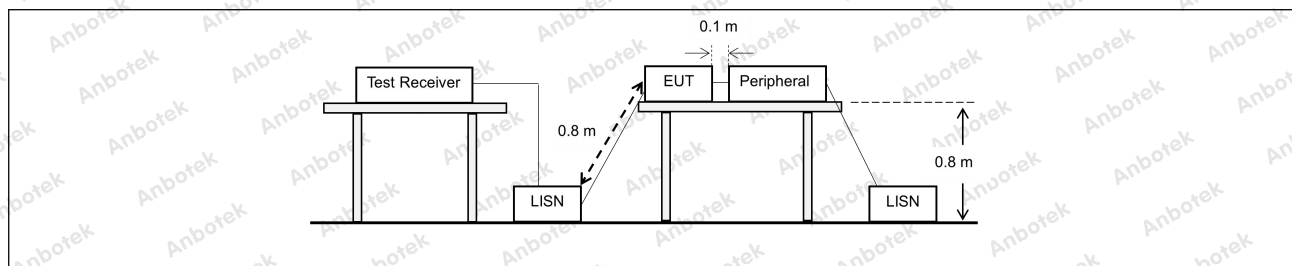
