Installation



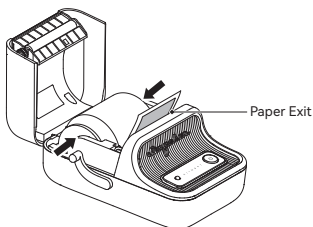
- 1 Press and hold the power button for 2-3 seconds to power on the device. Press down the crank handle on the left side of the device to open the paper compartment.



- 2 Push the paper compartment baffle to both sides and fit the label paper roll down into the compartment.



Danger! Beware of sharp blade when the paper compartment is open.



- 3 Slide the paper compartment baffle inwards to secure the label paper, pull the first paper out, make sure it sticks out of the paper exit, and then close the paper compartment cover to complete the paper loading process.

Switch off	Hold down the Power button for three seconds when the device is on.
Feeding Paper	Press the Power button once when the device is on.
Print a test page	Double-press the Power button when the device is on.
