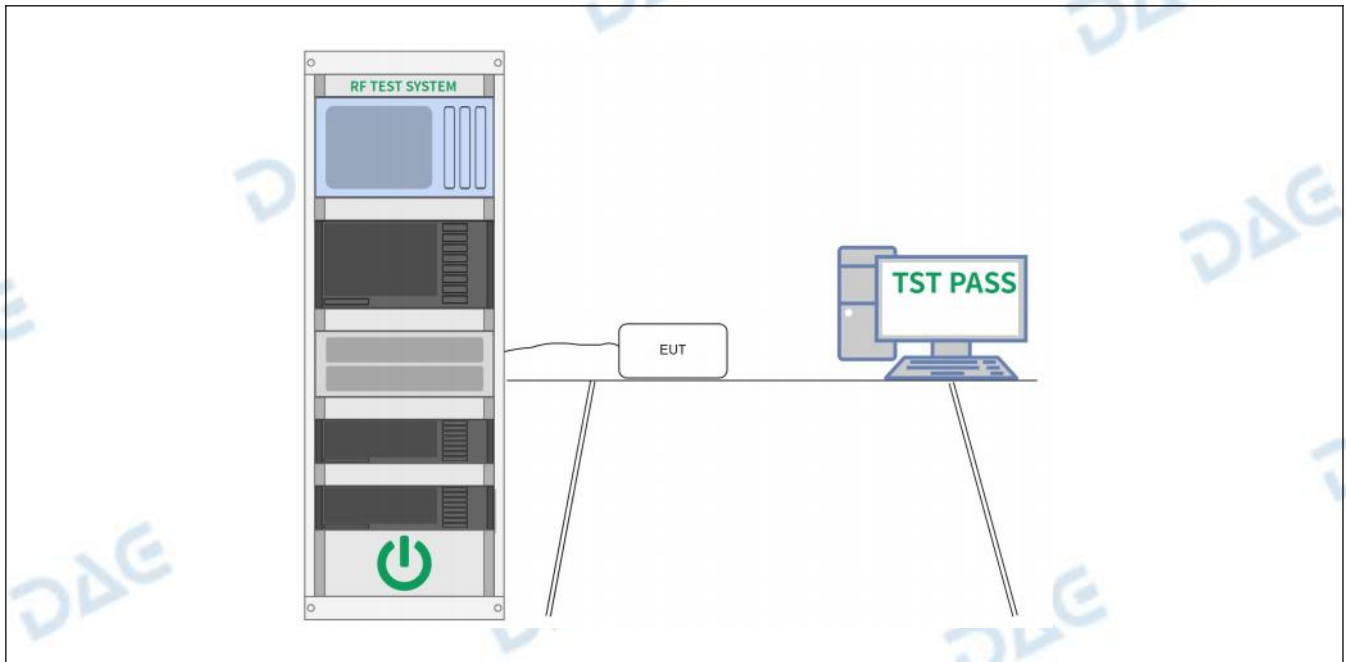

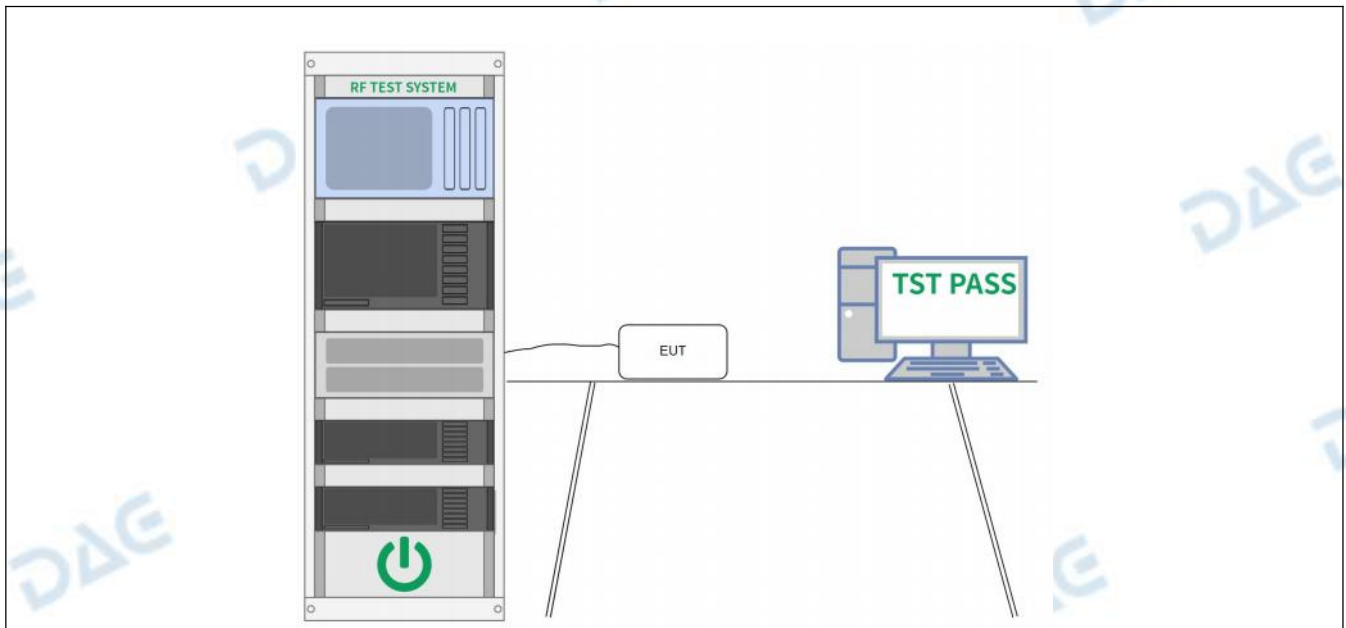

4.8.2 Test Setup Diagram:

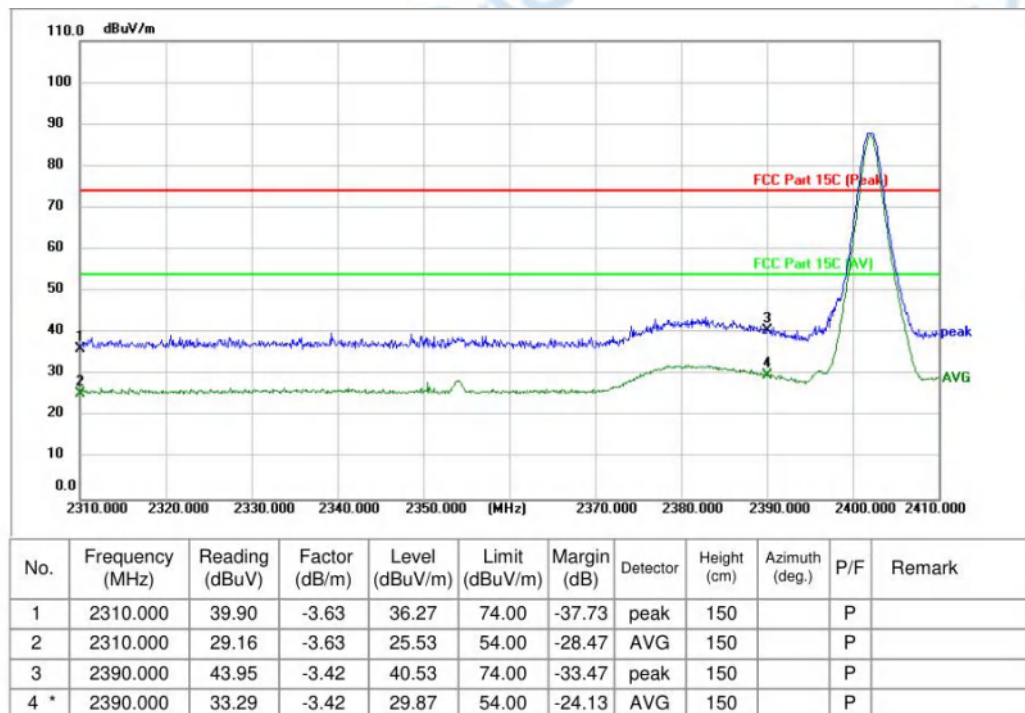

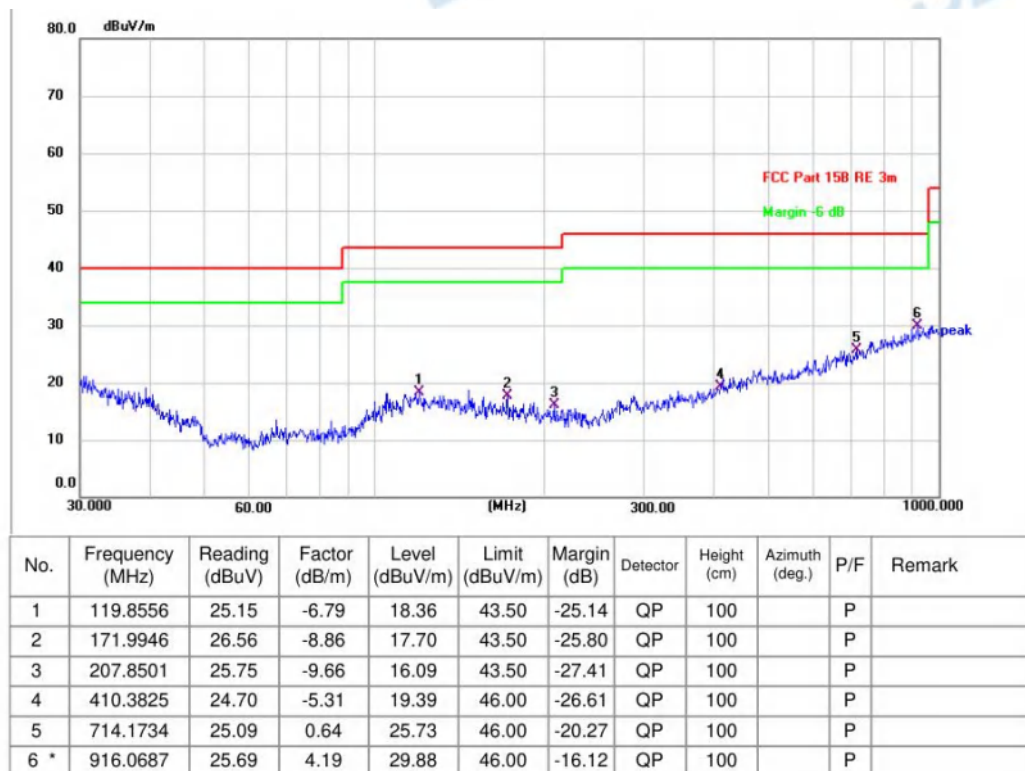
