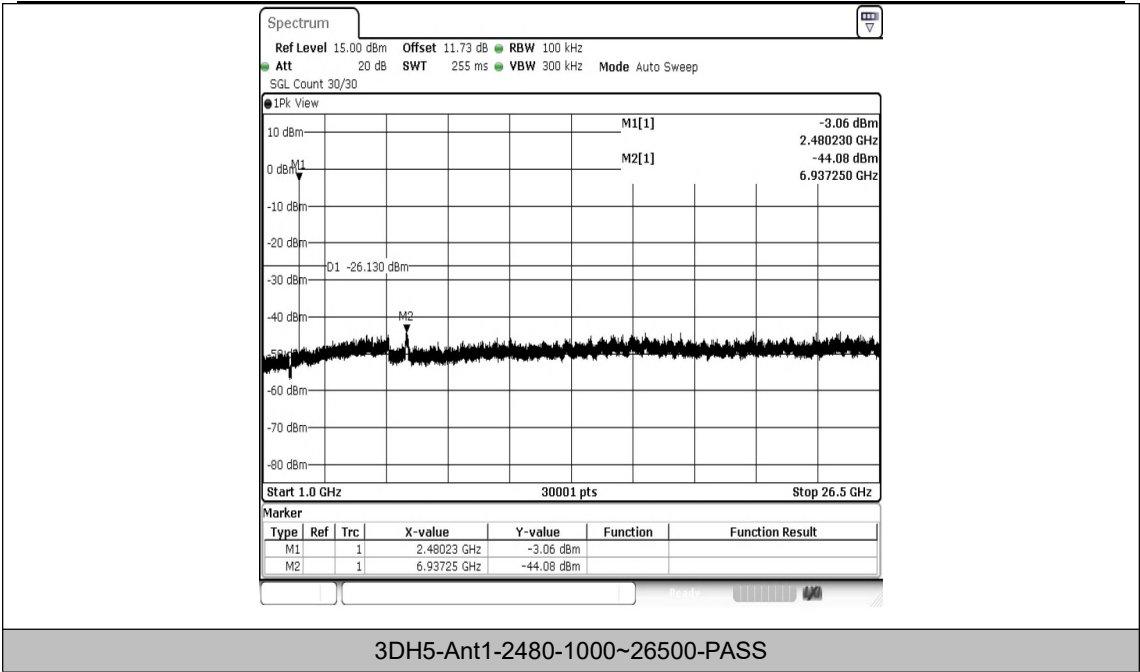


3DH5-Ant1-2480-0~Reference-PASS
