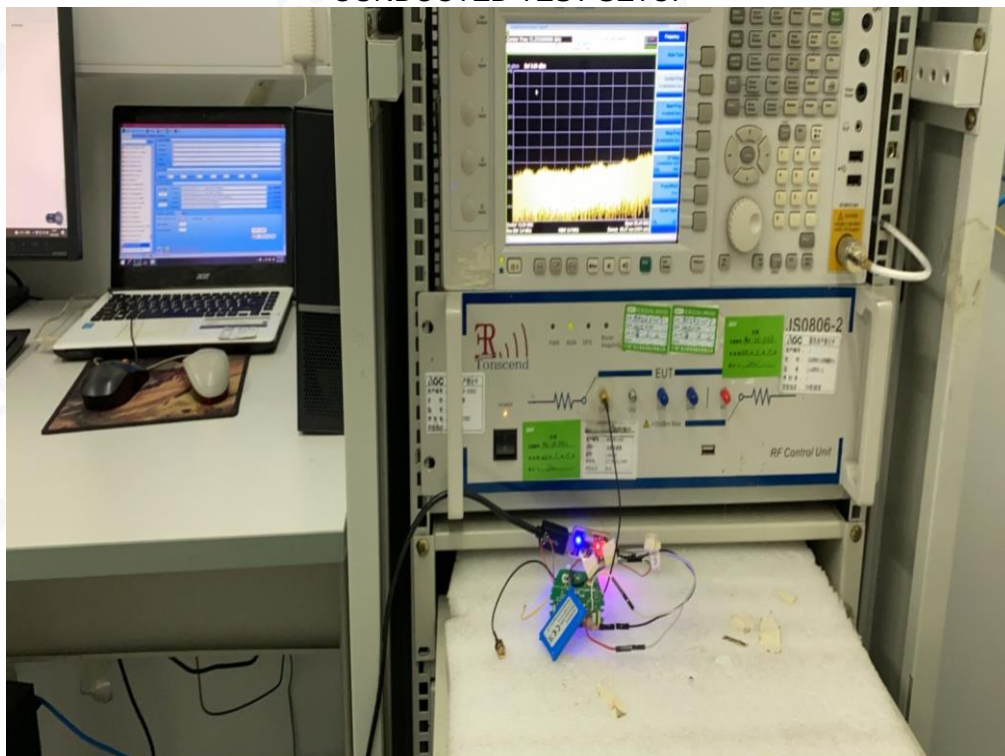

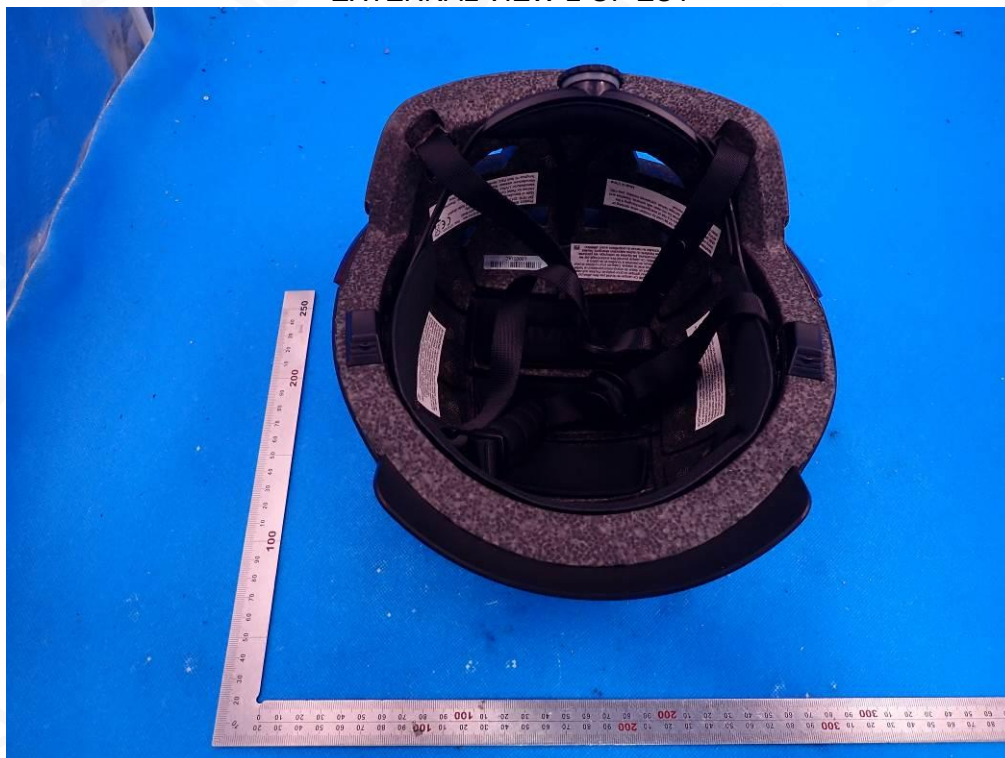

OPEN VIEW OF EUT-1

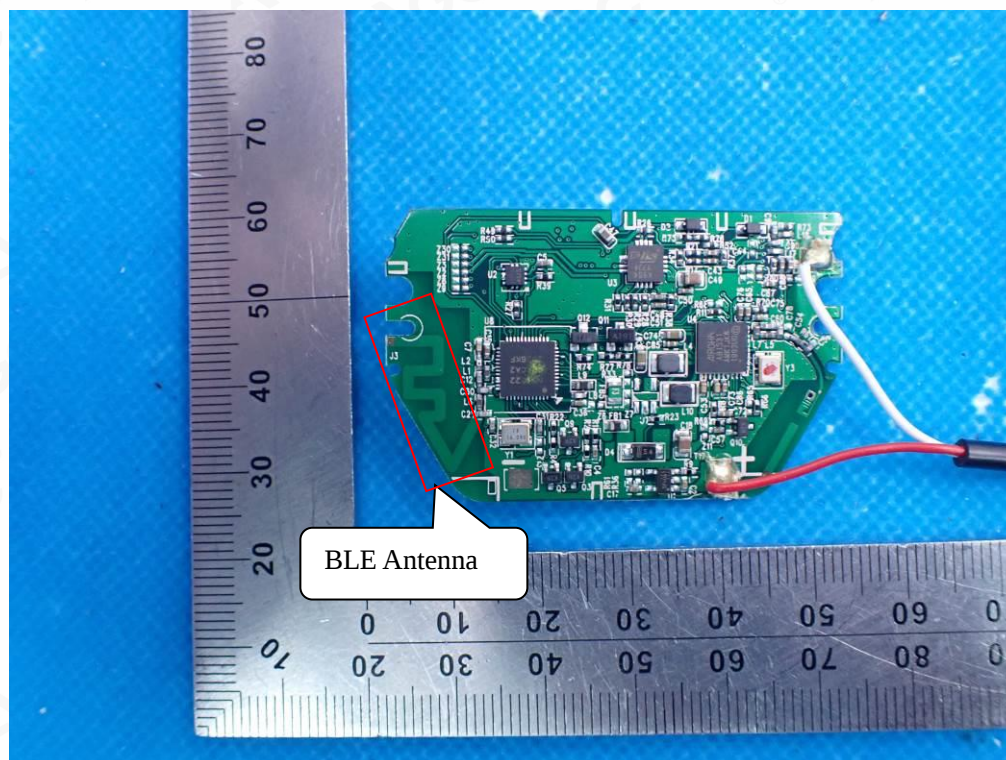


VIEW OF BATTERY

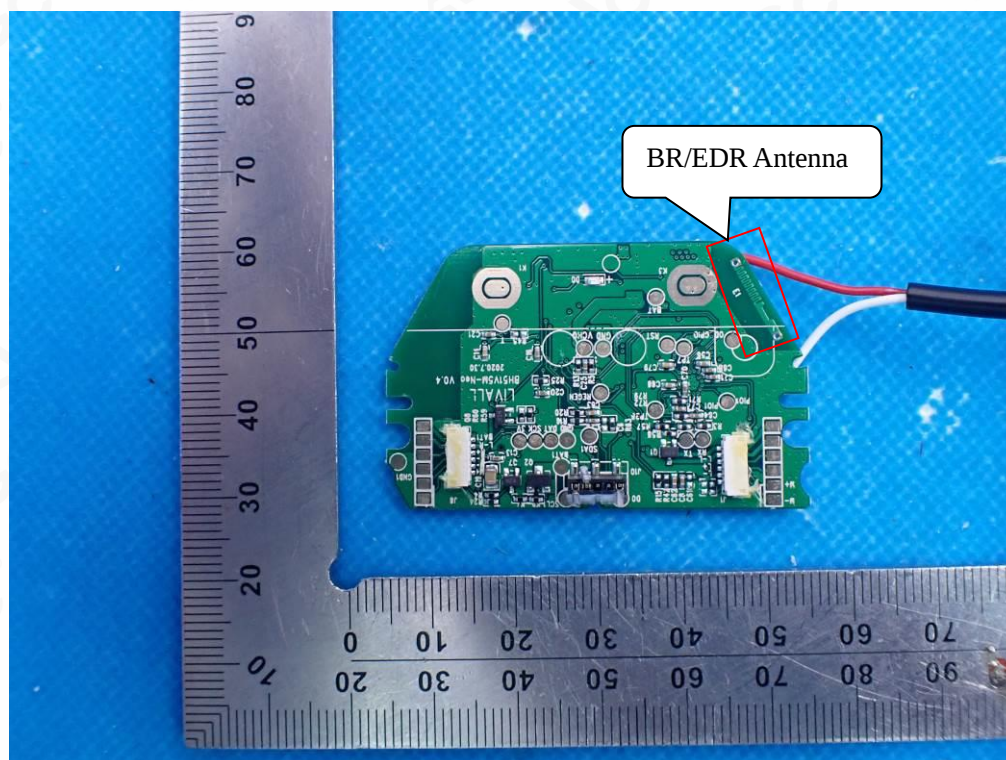

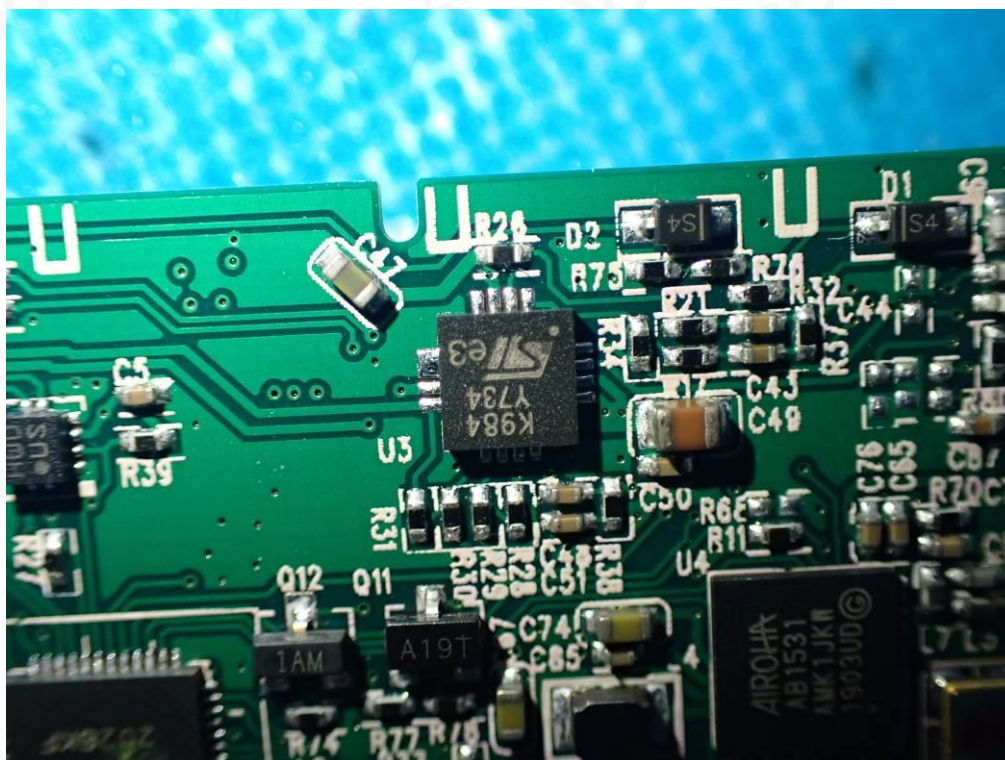

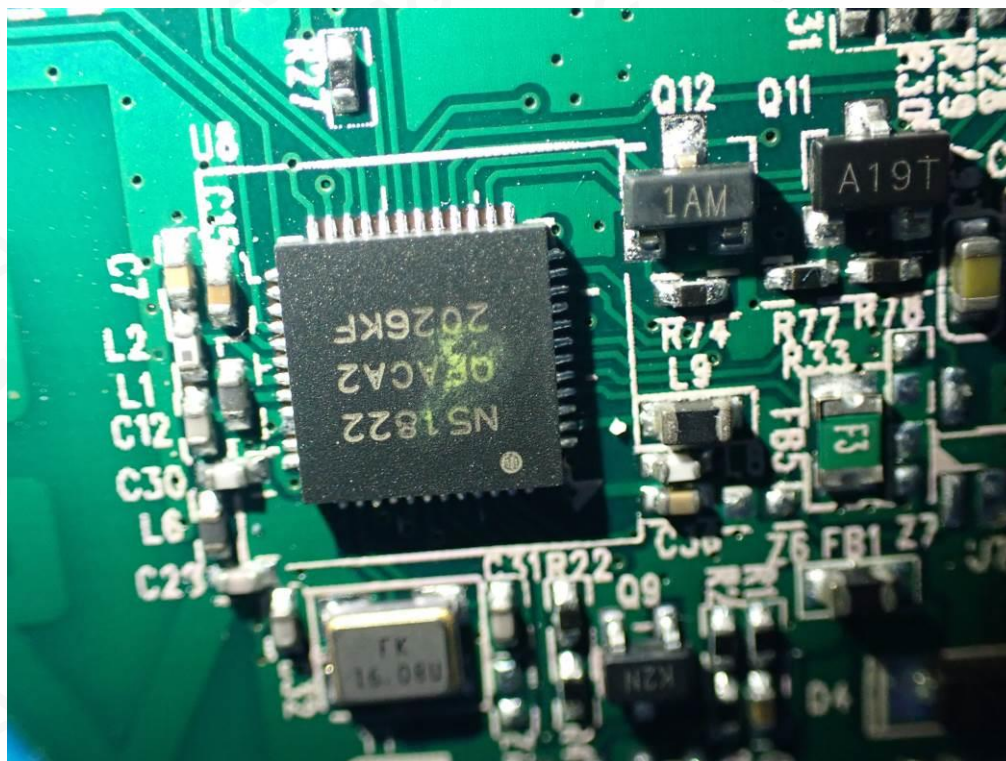

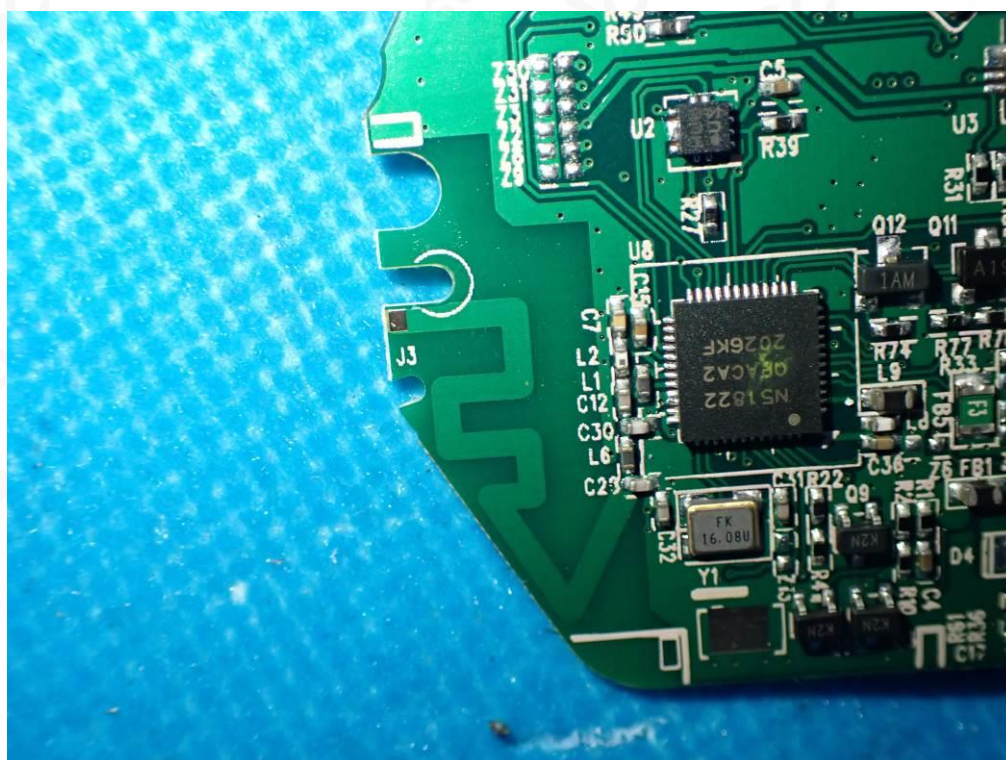
