## Photograph of the tissue simulant fluid liquid depth (Body)







## Body - distance between flat phantom and VM901 is 0 mm






Photograph 1. Body, Front side, 0mm Photograph 2. Body, Front side, 0mm Body - distance between flat phantom and VM901 is 5 mm




Photograph 3. Body, Back side of Ant, 5mm


