

#### On/Off Power



#### Turning On Your microTALK® Radio

1 Press and hold the **Power** button for two (2) seconds. A series of audible tones will indicate the radio is On.

Your microTALK® radio is now in Standby Mode, ready to receive transmissions. The radio is always in Standby Mode except when the Talk or Call buttons are pressed.



#### **Battery Low**

When battery power is low, the Battery Low icon will blink. Your batteries should be replaced or recharged, if using rechargeable batteries.

#### Battery/Power Saver

Your microTALK® radio has a unique circuit designed to extend battery life. If there are no transmissions within ten (10) seconds, the radio will automatically switch to Battery Save Mode. This will not affect the radio's ability to receive incoming transmissions.



#### Talking to Another Person

- 2. With the microphone about two (2) inches (5cm) from your mouth, speak in a normal voice.
  - 3. Release the Talk button when you are finished talking and listen for a response.


