Objective

This test report is in accordance with Part 2-Subpart J and Subpart 90 of the Federal Communication Commission's rules.

The objective is to determine compliance with FCC Rules for output power, modulation characteristic, occupied bandwidth, spurious emissions at antenna terminal, spurious radiated emission, frequency stability and band edge.

Test Methodology

All tests and measurements indicated in this document were performed in accordance with:

the Code of federal Regulations Title 47, Part 2, Part 90.

ANSI C63.26-2015, American National Standard for Compliance Testing of Transmitters Used in Licensed Radio Services

All emissions measurement was performed at Shenzhen Accurate Technology Co., Ltd. The radiated testing was performed at an antenna-to-EUT distance of 3 meters.

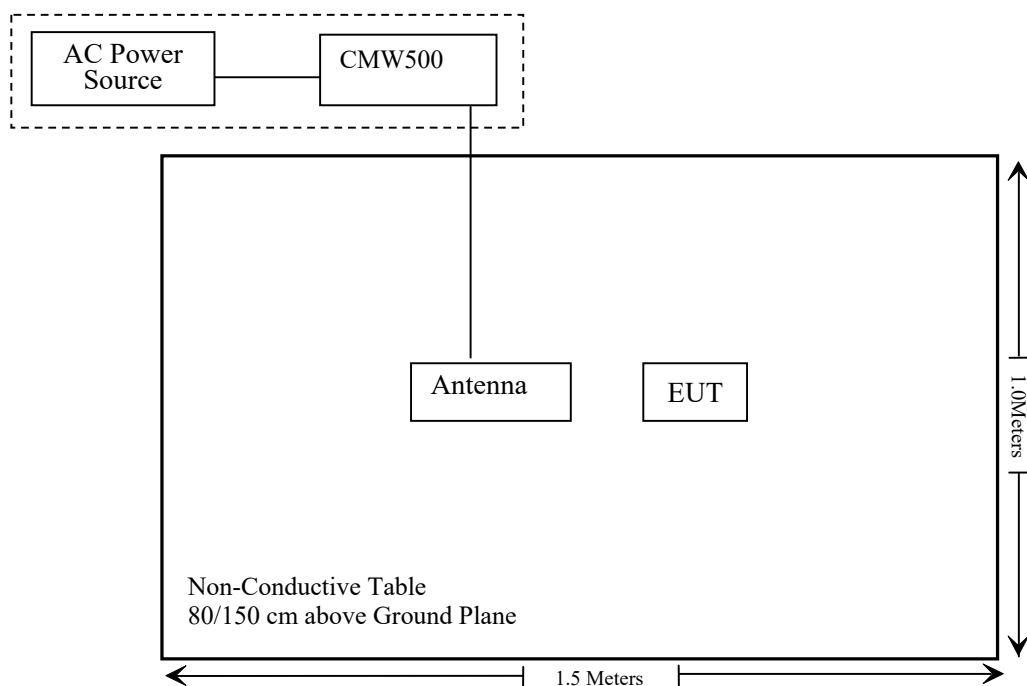

Test Procedure

The transmitter was placed on a wooden turntable, and it was transmitting into a non-radiating load which was also placed on the turntable.

The measurement antenna was placed at a distance of 3 meters from the EUT. During the tests, the antenna height and polarization as well as EUT azimuth were varied in order to identify the maximum level of emissions from the EUT. The test was performed by placing the EUT on 3-orthogonal axis.

The frequency range up to tenth harmonic of the fundamental frequency was investigated.

Remove the EUT and replace it with substitution antenna. A signal generator was connected to the substitution antenna by a non-radiating cable. The absolute levels of the spurious emissions were measured by the substitution.

Spurious emissions in dB = $10 \lg(\text{TXpwr in Watts}/0.001)$ – the absolute level

Spurious attenuation limit in dB = $43 + 10 \log_{10}(\text{power out in Watts})$
