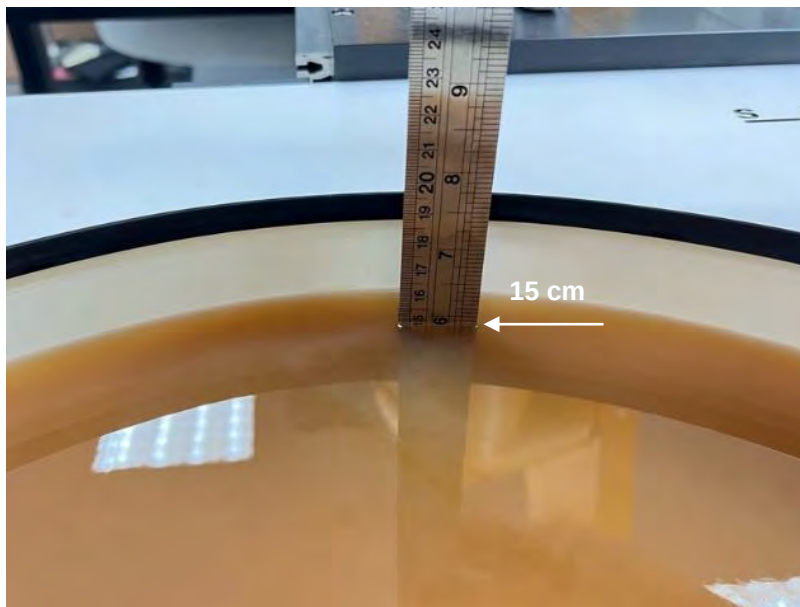

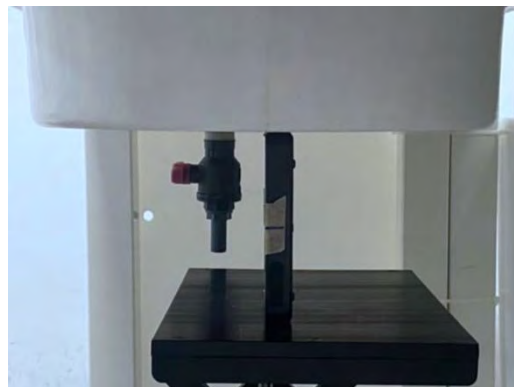

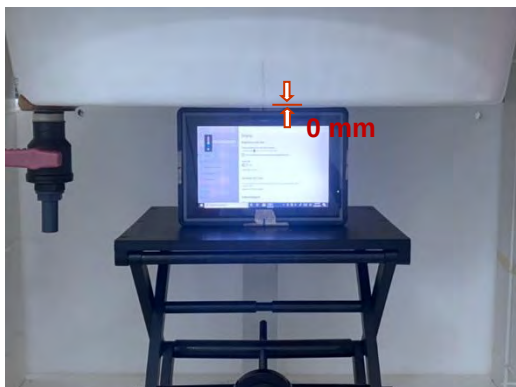

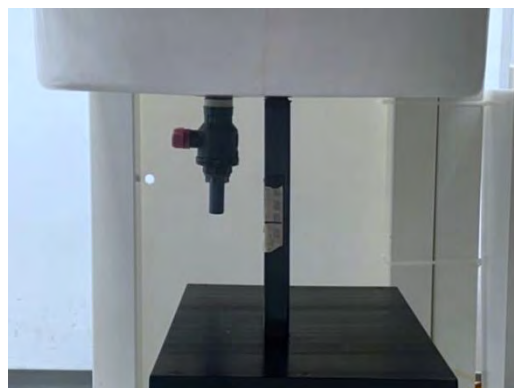

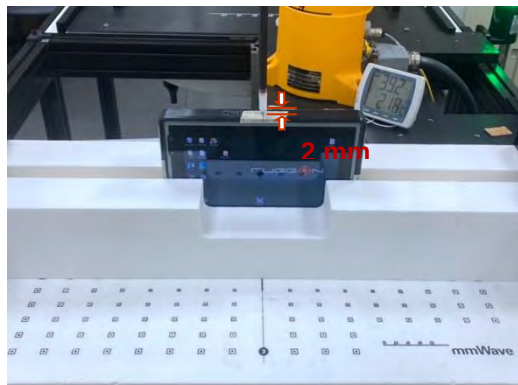

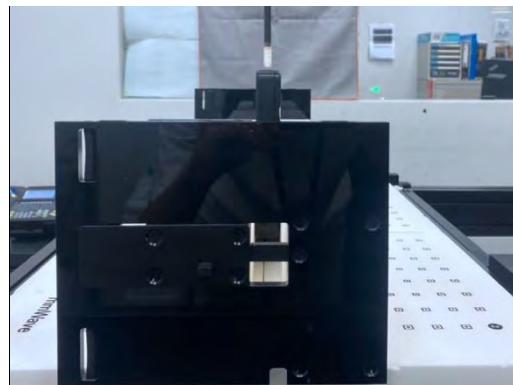

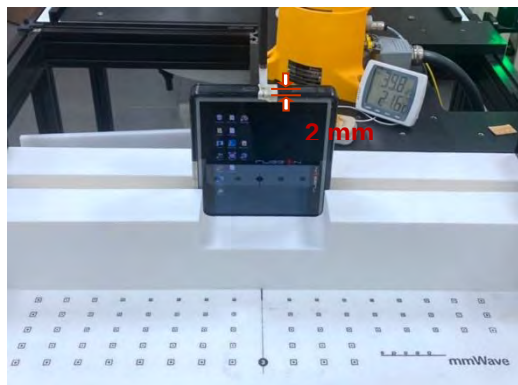
PD - distance between the probe sensor and EUT is 2 mm



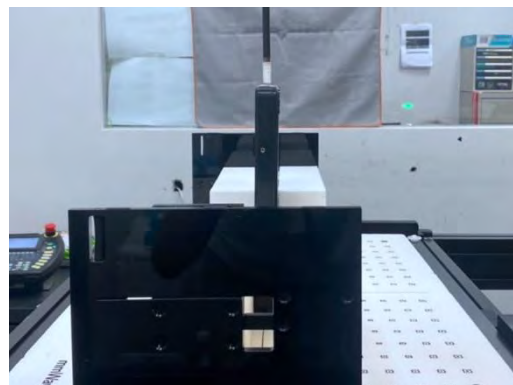
Photograph 11. PD, Top Edge, 2mm

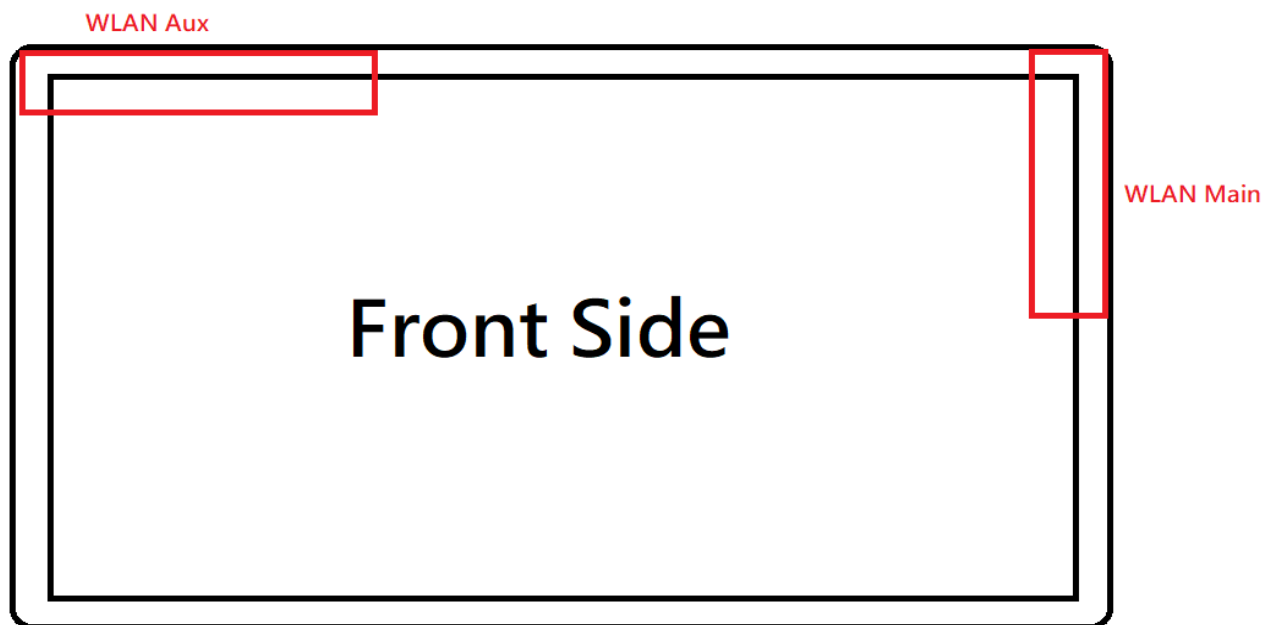
